**Contract Amendment – Advanced Toll Collection and Accounting System (ATCAS II):  
TransCore, LP (\$10,128,252)**

---

**Subject:**

A request for approval of a contract amendment with TransCore, LP (TransCore) in an amount not to exceed \$10,128,252 to provide funds for three additional years of toll system maintenance, subject to the approval of future BATA budgets.

**Background:**

Following a competitive procurement, BATA entered into a contract with TransCore in 2009 to replace the original toll collection system and to provide seven years of maintenance. Installation was completed in late 2013, which set the end of the maintenance period at September 2022. To keep the toll collection system properly maintained, TransCore performs recurring preventative maintenance inspections within each of the 70 lanes currently in service. Additionally, TransCore repairs broken equipment such as cameras, antennas and printers while also proactively replacing equipment prior to failure. In-lane computers receive data from the toll system equipment and TransCore is responsible for compiling, packaging, and transmitting data for each vehicle transaction to the FasTrak<sup>®</sup> Regional Customer Service Center (RCSC). During the entire maintenance period, BATA staff have been satisfied with TransCore's overall performance operating BATA's toll collection system.

**Additional Funds:**

The current annual contract price BATA pays TransCore to maintain the toll collection system is \$3,376,084. Yearly maintenance costs for this proposed contract amendment would remain the same and the key performance indicators would not change. However, as per the contract, TransCore will be entitled to a contract price adjustment on an annual basis during the three-year extension period based on increases and decreases in the Consumer Price Index (CPI) taken from the Urban Wage Earners and Clerical Workers for the San Francisco – Oakland – San Jose area.

**Time Extension:**

This contract amendment would extend TransCore for three additional years until September 30, 2025, which is within the original option years of the contract. Within those three years BATA expects to procure a new toll system contractor to design and build an Open Road Tolling System to support the conversion of the seven state-owned toll bridges to All-Electronic Tolling (AET). The transition from TransCore to a new contractor will likely occur over several years, starting as early as 2024. As the AET program progresses, and the design and construction challenges for the new system are better understood, an additional extension with TransCore for the toll plaza transition will likely be needed.

Attachment A includes a summary of TransCore and its project team's small business and disadvantaged business enterprise status.

**Recommendation:**

Staff recommends that this Committee authorize the Executive Director or designee to negotiate and enter into a contract amendment with TransCore in an amount not to exceed \$10,128,252 to continue providing toll system maintenance for three additional years, subject to the approval of future BATA budgets.
