outlining the current financial crisis of BART could easily be broadened to include the financial crisis of all Greater Bay Area Public Transit.

This financial crisis has been accumulating for decades. But the sudden and major loss in transit ridership in the past few years as a consequence of the COVID epidemic has placed how public transit in the Bay Area is to be financed to the top of the agenda.

When addressing this issue, I urge you to place the future of Bay Area Public Transit in the context of California's efforts to address climate change in the next decades. Even with a transition to electric vehicles, there is structural need to dramatically increase the availability and use of public transit. More than that, the current efforts to restrict automobile parking in dense housing near transit sharply illustrates that public transit cannot be considered in isolation from the constellation of issues surrounding urban development in the Greater Bay Area.

As well, planning for public transportation needs to include addressing the extraordinary congestion on the Highway 101 and Highway 580 and 680 corridors as well as making room for express buses on the Bay Area Bridges.

As the leadership bodies on Bay Area Public Transit, you have the responsibility to address these issues directly:

- 1. Advocate for State government to provide a fiscal bridge for public transit until 2024.
- 2. Support and encourage legislation in 2023 that would enable a ballot measure in 2024 having the purpose of restructuring the funding sources for Bay Area Public Transit.

We are in a crisis moment. Please have the courage and conviction to address that crisis boldly.

#### Dear Committee Members,

As a member of Mountain View YIMBY, a member of Voices for Public Transportation, I ask the Committee to recommend starting work on enabling legislation for the transportation measure early.

We are coming to the end of the hottest week in recent history, with concern that this may be merely the start of a new future. A major factor of climate change is carbon emissions, of which transportation emissions make up a good chunk. While there is great focus on vehicle electrification, we also must ensure that people are driving less and using alternative means more. And for transit, that means having the funding necessary to, at minimum, maintain current service and, hopefully, increase frequency, coverage, and convenience. But transit is currently on a lifeline of federal funds that will not last for long, facing steep deficits in general long-term projections.

It perhaps is true that we are all in the dark over electoral prospects in 2024, given the many other items potentially on the ballot. But it is better to ensure the basic legal groundwork is there in order to better make a go/no-go decision next year, as well as show how serious governmental institutions are at addressing the future of transit.
