Contract – Bay Area Regional Transit Passenger Snapshot Survey: Corey, Canapary & Galanis (\$900,000)

Subject:

Authorization to negotiate and enter into a contract in an amount not to exceed \$900,000, with Corey Canapary & Galanis for the Bay Area Regional Transit Passenger Snapshot Survey ("Project").

Background:

From 2012-2019, MTC implemented an intensive recurring transit passenger data collection program regionally codified by MTC Resolution 3866 ("Ongoing Survey Program"), taking a break for COVID-19 in 2020. This program surveyed approximately 5 to 7.5 percent of boardings across all Bay Area federally funded transit operators. It collected detailed demographic and trip pattern data. This approach to data collection yielded a thorough and robust regional dataset but required 5-6 years to complete a full cycle of Bay Area data collection. Staff will resume the Ongoing Survey Program in 2024 but is also pursuing a simplified one-year survey in parallel to collect high-level summary data for transit operators more quickly than the Ongoing Survey Program's 5–6-year timeframe.

Since 2019 and the advent of the COVID-19 pandemic, Bay Area transit ridership has changed significantly. Not only have the boarding volumes decreased substantially, but riders' demographics, frequency of trip making, trip purposes, and other traveler/trip characteristics have also changed compared to pre-pandemic conditions.

Staff would like to reassess its baseline understanding of post-pandemic regional transit ridership. The Project will update regional demographics (age, gender, income, household size, ethnicity, limited-English proficiency), trip purposes, fare payment information, origin/destination patterns, and other variables for passengers who use the fixed-route transit services within our nine-county region. MTC envisions collecting this "Snapshot Survey" using simpler data collection methods, and with a limited set of questions. It is the explicit goal of this project to complete regional data collection and reporting in approximately a year.

Procurement:

MTC issued a Request for Proposals (RFP) on December 5, 2022, to procure a consultant or consultant team to conduct the Project.

Email notification of the RFP was sent to 3,911 individuals and firms. Staff hosted a non-mandatory pre-proposal conference on December 14, 2022, via Zoom, which provided opportunities for the firms to ask questions about upcoming project opportunities and the procurement process. The pre-proposal conference was attended by 24 individuals. On January 19, 2023, MTC received three proposals.

An evaluation panel comprised of three MTC staff and one staff member each from Bay Area Rapid Transit (BART) and San Mateo County Transit District (SamTrans) reviewed applicants on the following evaluation criteria:

Two of the three firms who submitted proposals – ETC Institute and Corey, Canapary & Galanis – demonstrated strong experience and expertise in transit passenger surveying, an understanding of project goals and research needs, and the ability to complete the work plan within the required timeframe and budget. Each member of the evaluation panel recommended that MTC take the additional step of interviewing ETC Institute and Corey, Canapary & Galanis to determine who of the two shortlisted firms was the better candidate. The table below provides the final ranking after proposal reviews and candidate interviews:

Based on the evaluation panel's proposal review and interviews, they recommend Corey Canapary & Galanis for the Project. Attachment A includes a list of Corey Canapary & Galanis's Small Business Enterprise (SBE) and Disadvantaged Business Enterprise (DBE) status.

Recommendations:

Staff recommends that the Committee authorize the Executive Director or designee to negotiate and enter into a contract in an amount not to exceed \$900,000 with Corey Canapary & Galanis for the Bay Area Regional Transit Passenger Snapshot Survey.
