Funding Agreement - West Oakland Link Project: Alameda County Transportation Commission (\$3,000,000)

Subject:

A request to enter into a funding agreement with the Alameda County Transportation Commission (ACTC) to receive up to \$3,000,000 in funds to allow BATA to complete plans, specifications, and estimates (PS&E) for the West Oakland Link Project.

Background:

The West Oakland Link Project (Project) would construct a new bicycle/pedestrian connection between West Oakland and the bike path leading to the East Span of the San Francisco-Oakland Bay Bridge (Bay Bridge) in Oakland. The Project, which is part of the Bay Trail, would connect West Oakland to existing segments of the regional San Francisco Bay Trail and provide safer access to the Bay Bridge East Span Path and the Class I trail along Maritime Street to the Port of Oakland. The Project is a key component in the Bay Skyway and MTC's Active Transportation Network that will facilitate bicycling and pedestrian trips between San Francisco/Peninsula and the East Bay. This Project will decrease congestion, vehicle miles traveled, greenhouse gas emissions, and air pollution, thus providing great benefits for the Bay Area community.

BATA has long sought funding partners and stakeholders to contribute to the successful implementation of the West Oakland Link as part of the greater Bay Skyway vision. At its May 28, 2020, meeting, ACTC updated its Comprehensive Investment Plan to include \$3,000,000 in programming from Measure B to help fund design (PS&E) for the Project. These funds are matched by \$3,000,000 in BATA Toll Bridge Rehabilitation funds that have already been included in the Toll Bridge Rehabilitation Budget. PS&E for the West Oakland Link Project is expected to start in March 2023, with construction expected to begin in June 2025. Staff has applied for four federal and state grants in 2022 to fund construction.

Approval of the request to authorize the Executive Director or designee to negotiate and enter into the funding agreement with ACTC for the funding of PS&E would be the first discretionary action taken on the Project. As such, pursuant to California Public Resources Code section 21080, subdivision (c) and CEQA Guidelines section 15352, subdivision (a), the Authority must approve this action, subject to BATA adopting the Mitigated Negative Declaration (MND) and the Mitigation Monitoring and Reporting Program (MMRP) for the Project pursuant to BATA Resolution No. 161.
