Aaron Priven, Principal, Regional Mapping and Wayfinding Project Manager and Jay Stagi, Senior Planner, are to attend the Transit Mapping Symposium in Madrid, Spain. The Transit Mapping Symposium is a global forum for sharing information and best practices in transit mapping and wayfinding, with speakers from North America, Europe, and Asia. The topics under discussion involve taking digital mapping data and presenting it in forms suitable for customer viewing, as well as other topics around presentation of information for transit riders. The Regional Mapping and Wayfinding Project cannot succeed without learning from the best examples from around the world. The Transit Mapping Symposium provides a unique opportunity to obtain this information. Travel expenses for this trip are outlined in Attachment A.

Laura Krull, Associate Planner, Bikeshare Project Manager is to attend the North American Bikeshare & Scootershare Association (NABSA) annual conference in Guadalajara, Mexico. The NABSA Conference encourages collaboration across sectors to grow bikeshare and its benefits to communities, creating a more equitable and sustainable transportation ecosystem. NABSA is the bikeshare industry's membership organization with representation from system owners, operators, host cities, equipment providers, and technology providers. Session topics include ebikes, connectivity to transit, effective community engagement, pricing, and privacy. MTC's ability to support bikeshare programs in the Bay Area will benefit from learning from the best examples from around the world. Travel expenses for this trip are outlined in Attachment B.
