Contract Amendment – San Francisco-Oakland Bay Bridge West Spans Load Rating:
Arup North America, Ltd. (\$50,000)

#### **Subject:**

This item would authorize the Executive Director or designee to negotiate and enter into a contract amendment with Arup North America, Ltd. (Arup) to provide design services to complete the load rating study of the San Francisco-Oakland Bay Bridge (SFOBB) West Spans in an amount not to exceed \$50,000 through September 30, 2023.

### **Background:**

In compliance with Federal Highway Administration (FHWA) requirements, Caltrans is in the process of load rating all state bridges. In 2014, along with efforts to further the SFOBB West Span Bicycle, Pedestrian, and Maintenance Path Project and with the support of Caltrans, BATA contracted with Arup to prepare a load rating study of the West Spans of the San Francisco-Oakland Bay Bridge. The study identified localized areas for further study and possible retrofit. Caltrans has designed structural retrofits, primarily limited replacement of rivets with high-strength bolts and additional bracing, to bring the bridge into compliance with the load rating criteria. Caltrans has requested Arup review the designs and update the load rating study accordingly to the retrofitted conditions when construction is complete.

In June 2020, the BATA Oversight Committee initially approved a contract for Arup from the 2017 BATA Design Services and Construction Management Bench for this work. Attachment A includes a summary of Arup and its project team's small business and disadvantaged business enterprise status.

Due to coordination and supply chain issues, the design, fabrication and construction of the retrofit work has taken longer than originally anticipated. Construction is expected to be completed by September 30, 2023.

# **Next Steps:**

To account for the delay and additional possible further design support during construction, staff recommends a contract amendment with Arup to provide design support to complete the Load Rating Study of the SFOBB West Spans in an amount not to exceed \$50,000. Funding for the amendment is budgeted in the Toll Bridge Rehabilitation Program.

#### **Issues:**

None identified.

#### **Recommendations:**

Staff requests that this Committee authorize the Executive Director or designee to negotiate and enter into a contract amendment with Arup in an amount not to exceed \$50,000 to provide design support to complete the Load Rating Study of the San Francisco-Oakland Bay Bridge West Spans.
