Contract - Microsoft Volume Enterprise Licensing Agreement: SoftwareONE, Inc. (\$1,250,000)

Subject:

Approval of a contract in an amount not to exceed \$1,250,000, for the term of May 1, 2023 through April 30, 2026 with SoftwareONE, Inc., for the renewal of MTC's Enterprise Software Licensing Agreement for desktop, data center, and cloud subscription software, including multiple Microsoft software products used across the agency, with the option to renew for an additional three-year term.

Background:

MTC has standardized on Microsoft desktop and data center software since the early 1990's. In 2013, Microsoft's cloud services were added as well. Since 2006, this Committee has authorized the Executive Director to enter into a series of multi-year enterprise agreements for Microsoft products, taking advantage of a volume licensing discount made possible by a cooperative purchasing agreement established through Riverside County. Use of such cooperative agreements is permitted under the Agency's purchasing policies. contained in the Executive Director's Management Memorandum (EDMM) No. 352 The Riverside County agreement explicitly allows for any public agency in the state to leverage that agreement, obtaining large volume discounts that would otherwise be unavailable to smaller agencies conducting their own competitive procurements. This arrangement has been used by hundreds of agencies across the state, including several in the Bay Area, as well as by the State's Department of General Services.

The enterprise volume license includes standard desktop software (such as Windows and Microsoft Office), specialized software (such as Project, Visio. PowerApps), server-based software (such as Windows Server for Data Centers and SQL Server for databases), and cloud-based services (such as Office 365, SharePoint Online and Exchange Online). The main benefits of the enterprise agreement include:

- guaranteed product pricing during the three-year term (if we have to add licenses)
- access to all product version updates as soon as they become available

• access to additional products and services as technology and our needs change

The current enterprise agreement (ending April 30, 2023) that was authorized by this Committee on March 1, 2017, allowed the Executive Director to issue a purchase order to SoftwareONE, Inc., with the ability to extend for three additional years, subject to annual operating budget approvals. Due to the multi-year nature of this enterprise agreement, it was determined that a contract is more appropriate than a purchase order.

SoftwareONE, Inc., is neither a small business nor a disadvantaged business enterprise, and has no subcontractors.

Issues:

Recommendations:

Staff recommends that the Committee authorize the Executive Director or designee to enter into a contract with SoftwareONE, Inc., in an amount not to exceed \$1,250,000 for the term of May 1, 2023 through April 30, 2026, for the renewal of MTC's Enterprise Software Licensing Agreement for desktop, data center, and cloud subscription software, including multiple Microsoft software products used across the agency, with the option to renew for an additional three-year term; subject to annual approval of the MTC operating budget, with the option to extend for three additional years, subject to subsequent annual operating budgets approvals.
