RE: Outreach Update for the Regional Housing Needs Assessment (RHNA) Process

This memo identifies the completed and planned outreach to elected officials regarding the sixth cycle of the Regional Housing Needs Allocation (RHNA) process.

Local Government Outreach – Meetings with Elected Officials and Staff

In addition to the updates provided to the ABAG Regional Planning Committee (RPC) and reporting to the Executive Board, ABAG staff has conducted supplemental outreach to local elected officials. Between January and March 2020, the following outreach activities have occurred:

General Assembly

A special ABAG General Assembly on RHNA occurred on February 7th with 90 local elected officials, jurisdiction staff, and other stakeholders hearing from Senator Wiener, Senator Beall, Assemblymember Chiu and staff from the California Department of Housing and Community Development (HCD) about recent changes to RHNA and what local governments need to do in order to update their housing elements. Attendees also participated in a session about additional assistance from HCD and ABAG for local governments updating housing elements.

Presentations to Elected Officials

Presentations will be scheduled via existing meetings, such as Mayors and Councilmembers Conferences and League of California Cities meetings. The status of presentations is as follows:

Staff will continue to reach out to additional Conferences or League meetings in the region, including those in Napa, Sonoma and Solano counties. As Napa and Solano counties are both RHNA sub-regions, the outreach will need to be a bit different, as the process itself is different. All of these presentations will occur prior to the release of the proposed RHNA methodology.

Additional Outreach

Additional outreach to elected officials is also supported by a template RHNA PowerPoint that will be available in May 2020 for local staff to use to present to their councils and boards. In addition, staff facilitate deployment of the template presentation during RHNA webinar, which will be designed as a "train the trainer" event for local city and county staff. The idea is to prepare local staff to present information about RHNA and the recent legislative changes to council or other interested parties.

ABAG-MTC staff have begun outreach to local staff via the League of Cities City Manager conference on February 6 and at the Alameda County City Managers meeting on February 19. Additional outreach to discuss funding available from the state to assist local jurisdictions with RHNA implementation through their Housing Element updates will also occur.

Local planning directors will receive additional information on RHNA implementation and technical assistance available through ABAG-MTC's Regional Early Action Planning (REAP) grants program via county-wide planning directors meetings during March – May 2020. Additional information about RHNA and REAP will be presented to elected officials. Based on this outreach plan, staff expects that each jurisdiction in the nine counties will receive updates and have opportunity to provide feedback on multiple occasions during the first half of 2020.
