 agencies' Transit Oriented Communities Policy is planned to be released this spring. Expected
 products include model ordinances for 10 affordable housing policy options as well as detailed
 policy profiles for the 26 affordable housing policy options with program design considerations,
 resources and examples.

To be as accurate as possible, we are asking jurisdictions to encourage or require the survey for property owners who apply for an ADU building permit.
