Subject:

Request for Committee authorization of contract amendments with CHP for:

- i. \$3,625,000 for enforcement services on the I-880 Express Lanes; and
- ii. \$1,802,000 for enforcement services on the I-680 Contra Costa Express Lanes.

Background:

BAIFA currently employs two primary methods to enforce express lane regulations:

- Automated toll enforcement Cameras and license plate recognition technology identify vehicles without FasTrak ® accounts, enabling violation notices to be issued.
- Manual enforcement CHP, supported by toll system data, conducts visual observations to verify vehicle occupancy and enforces violations such as illegal crossing of double-white lines and missing license plates.

BAIFA reimburses CHP for the cost of providing dedicated manual enforcement services, which remain a critical component to addressing occupancy violations and other infractions. Per California Vehicle Code Section 23251, the CHP is the designated agency responsible for enforcing traffic laws on toll highways, including occupancy requirements in express lanes. BAIFA pays overtime hourly rates for the dedicated shift work, typically scheduled during peak period travel when express lanes occupancy violations are more likely. The dedicated shifts to express lane enforcement allows regular CHP shifts to carry out their primary safety-focused mission on freeways.

To advance BAIFA's efforts in improving and the effectiveness of enforcement across its Express Lanes, staff initiated a pilot program to evaluate technology-based solutions for verifying carpool eligibility. In September 2023, staff launched the MTC Express Carpool Check Pilot to test app-based technology for verifying carpools on the I-680 Express Lanes. Staff presented the results of the pilot to the Committee in December 2024. Staff are developing a roadmap for future efforts to evaluate technology that assists with enforcement.

i. Contract Amendment - I-880 Express Lanes Enforcement: CHP (\$3,625,000

BAIFA has approved \$6,890,000 for CHP enforcement services on the I-880 Express Lanes from October 2020 through June 2026. Staff proposes adding a not-to-exceed amount of \$3,625,000 in new contract authority to provide enforcement services from July 2026 through June 2028. This budget is based on BAIFA's requested enforcement levels, which assume four CHP officers in the morning and four in the evening, Monday through Friday. The total contract value including the recommended amendment would be \$10,515,000, as shown below, subject to future BAIFA operating budget approvals.

ii. Contract Amendment – I-680 Express Lanes Enforcement: CHP (\$1,802,000)

CHP has provided enforcement services for BAIFA since the I-680 Express Lanes opened in October 2017. In 2021, CHP changed the responsibility of BAIFA's contract from its Dublin Area Office to its Contra Costa Area Office and requested a new contract for a clean administrative record. BAIFA approved a new enforcement contract in December 2021 for \$1,600,000, covering the period from July 2022 through June 2024. This was followed by a contract amendment approved in November 2023 for \$1,190,000, extending enforcement services from July 2024 through June 2026. Staff proposes adding a not-to-exceed amount of \$1,802,000 in new contract authority to provide enforcement services from July 2026 through June 2028. This budget is based on BAIFA's requested enforcement levels, which assume two CHP officers in the morning and two in the evening, Monday through Friday. As a shorter corridor, I-680 requires proportionally less coverage—an adjustment reflected in the proposed CHP staffing levels. The total contract value would be \$4,592,000, as shown below, subject to future BAIFA operating budget approvals.
