**Subject:**

Authorization to negotiate and enter into a contract amendment in an amount not to exceed \$300,000, with KBM Office Equipment Inc. (KBM-Hogue) for the procurement and installation of office, conference room, shared space, and other ancillary furniture to accommodate hybrid work at the Bay Area Metro Center (BAMC).

**Background:**

Following a competitive procurement, the Authority executed a 10-year contract with two optional five-year extensions with KBM-Hogue on June 25, 2014, for an amount not to exceed \$500,000 for Phase I professional services related to the design of new office furniture for the base building build-out. The contract was subsequently amended on:

- May 15, 2015
- September 1, 2015
- June 5, 2017
- September 1, 2019
- June 28, 2023
- August 14, 2023
- February 1, 2024
- June 1, 2024
- September 8, 2025

These amendments expanded the scope to include acquisition, delivery, and installation of furniture for offices, un-programmed spaces, conference rooms, and public spaces at 375 Beale Street, bringing the total contract authorization to \$7,250,000.

This amendment authorizes an additional \$300,000 for continued design, procurement, and installation of office, conference room, shared space, and ancillary furniture. Work includes updates to the Claremont Conference Room, adjacent to the Board Room, to support hybrid-meeting needs and improve overall space functionality.



Funds for this amendment are included in the FY 2025/26 BAHA Capital Budget.

With this amendment, the new total contract amount would be \$7,550,000.

Furniture needs for BAHA Capital Projects and MTC occupied spaces are coordinated through this contract as it serves as the procurement vehicle for orders and installation. MTC will provide funding for several upcoming furniture requests for MTC occupied spaces. Furniture and improvements associated with BAHA Capital Projects, including the Claremont Conference Room Project, will continue to be funded through BAHA Capital Projects budgets.

KBM-Hogue is not a Small Business Enterprise (SBE) or a Disadvantaged Business Enterprise (DBE).

**Issues:**

None identified.

**Recommendations:**

Staff recommends that the Authority authorize the Executive Director to negotiate and enter into a contract amendment with KBM-Hogue in an amount not to exceed \$300,000 for the procurement and installation of office, conference room, shared space, and other ancillary furniture to accommodate hybrid work at BAMC located at 375 Beale Street, San Francisco, for a new total contract amount not to exceed 7,550,000.
