### Purchase Order - Bay Area Metro Center Conference Room Hybrid Technology Modernization: AVI-SPL (\$275,000)

### Subject:

Authorization to issue a Purchase Order (PO) with AVI-SPL in an amount not to exceed \$275,000 for the modernization of hybrid video conferencing in conference rooms and work areas at the Bay Area Metro Center (BAMC).

### **Background:**

To foster effective collaboration with partner agencies and productive meetings with distributed staff teams and consultants, staff have installed several Logitech hybrid video conferencing systems throughout agency floors at BAMC. Positive reception among technical staff and end users have since garnered requests for hybrid systems to be added to additional conference rooms and work areas.

This PO will allow staff to install 17 new Logitech video conferencing systems on agency floors at BAMC while simultaneously replacing aging audio visual equipment past its useful life. The proposed project budget of \$275,000 provides contingency for unforeseen needs in modernization of the conference rooms and workspaces, including emerging requests not previously planned. This project will occur in two phases, with a projected completion by October 2024. This project is essential for ensuring an effective and consistent hybrid collaboration workplace and seamless communications among staff and stakeholders.

#### **Procurement Process:**

In June 2024, staff solicited and received project proposals from Integrated Communication Systems (ICS), W. Bradley Electric (WBE) and AVI-SPL.

Based on their quoted costs and thorough approach, staff recommends AVI-SPL as the integrator for this project. AVL-SPI has an active agreement with Omnia Partners Group Purchasing Organization (GPO), a collaborative intergovernmental procurement vehicle, which fulfills competitive procurement requirements.
