| 7  | BY THREE ACTIONS TO DATE BOTH BY THE MTC AND ABAG BOARDS. SO   |
| 8  | WITH THE SHIFT TO THE COMMUNICATIONS IMPLEMENTATIONS, AND AS   |
| 9  | WELL AS ADDRESSING OUR CEQA REQUIREMENTS, WE'RE HEADING INTO   |
| 10 | THE FOURTH AND FINAL ROUND OF ENGAGEMENT ON THE PLAN AS WELL   |
| 11 | AS THE FOURTH AND FINAL ACTION BY MTC AND ABAG. NEXT SLIDE.    |
| 12 | SO, EVERY THIS IS THE FOURTH ITERATION OF AN INTEGRATE THE     |
| 13 | LONG RANGE REGIONAL PLAN THAT MTC AND ABAG HAVE DEVELOPED. AND |
| 14 | EVERY PLAN HAS HAD A STORY, GENERALLY AT THE INTERSECTION OF   |
| 15 | FEDERAL AND STATE PLANNING REQUIREMENTS, AS WELL AS EVOLVING   |
| 16 | NEEDS AND POLICY PRIORITIES IN THE REGION. THE FIRST PLANNED   |
| 17 | BAY AREA REALLY ESTABLISHED THAT SHARED REGIONAL EMPHASIS ON   |
| 18 | SUSTAINABILITY AS WELL AS FOCUSING FUTURE GROWTH ALONG OUR     |
| 19 | TRANSPORTATION CORRIDORS, PLANNED BAY AREA 2040 IN 2017 REALLY |
| 20 | FOCUSED ON THE REGIONAL HOUSING CRISIS AND HOW IT CONNECTED TO |
| 21 | SOME OF OUR TRANSPORTATION CHALLENGES IN FURTHER CATALYZING A  |
| 22 | LOT OF OUR ONGOING WORK IN THAT AREA. AND PLANNED BAY AREA     |
| 23 | 2050 EXPANDED IN SCOPE TO INCLUDE FOUR EXPANSIVE ELEMENTS      |
| 24 | REALLY LEANING IN ON THAT STRATEGIES, AS OPPOSED TO PROJECTS,  |
| 25 | AND INCLUDING DETAILED QUANTIFICATION OF COST, COUPLED WITH A  |



- 1 STRONG EMPHASIS ON RESILIENCE AND EOUITY. NEXT SLIDE. SO, THIS
- 2 PLAN UPDATE HAS BEEN VERY MUCH INFORMED BY CERTAIN KEY
- 3 CHALLENGES, AS WELL AS OPPORTUNITIES. FIRST AND FOREMOST, JUST
- 4 THE VARIETY OF POST-PANDEMIC CHALLENGES FACING THE REGION,
- 5 INCLUDING REMOTE WORK, TRANSIT RIDERSHIP DECLINES, AS WELL AS
- 6 RISING OFFICE VACANCIES, AND REDUCED -- REDUCED FUTURE
- 7 REVENUES. BUT THAT, IN TURN, INFORMED IMPORTANT WORK TO
- 8 IDENTIFY COST REDUCTION STRATEGIES FOR AFFORDABLE HOUSING, AS
- 9 WELL AS INFORMING AN INNOVATIVE PARTNERSHIP WITH THE REGION'S
- 10 TRANSIT OPERATORS TO IDENTIFY OPPORTUNITIES TO ADVANCE A MORE
- 11 UNIFIED REGIONAL TRANSIT NETWORK. WE ALSO COLLABORATED CLOSELY
- 12 WITH BCDC IN THE DEVELOPMENT OF A FIRST EVER SEA LEVEL RISE
- 13 RESILIENCE PROJECT LIST AND IMPLEMENTED COST EFFECTIVE
- 14 SOLUTIONS TO ENSURE THAT THE PLAN CAN ACHIEVE ITS AGGRESSIVE
- 15 AND STATUTORILY REQUIRED CLIMATE TARGET. NEXT SLIDE. SO ON
- 16 OCTOBER 20TH, THE DRAFT PLANNED BAY AREA 2050+ WILL BE
- 17 RELEASED FOR PUBLIC REVIEW AND COMMENT, AND THAT WILL INCLUDE
- 18 THE THREE KEY TRACKS OF WORK. I'LL PROVIDE A BRIEF PREVIEW OF
- 19 THE PLAN DOCUMENT, AS WELL AS THE EIR, BUT TODAY OUR FOCUS IS
- 20 REALLY ON THAT THIRD AND FINAL TRACK OF THE WORK WHICH IS THE
- 21 DRAFT IMPLEMENTATION PLAN WHICH IDENTIFIES NEAR-TERM ACTIONS
- 22 THAT MTC AND ABAG CAN TAKE TO ADVANCE THE LONG RANGE
- 23 STRATEGIES IN THE PLAN IN PARTNERSHIP WITH A WHOLE HOST OF
- 24 ENTITY ACROSS THE REGION. NEXT SLIDE. SO, THE PLAN DOCUMENT IS
- 25 REALLY THE PRIMARY STORY TELLING DEVICE OF THE PLAN. IT RECAPS



- 1 THE PLANNING CONTEXT, WHAT THE PLAN IS, ITS DEVELOPMENT AND
- 2 ENGAGEMENT PROCESS, THE STRATEGIES AND THE OUTCOMES. REALLY
- 3 ALL OF THE THINGS THAT WE HAVE BEEN COMING TO THIS COMMITTEE
- 4 SINCE THE SUMMER OF 2023. AND THAT PLAN DOCUMENT IS
- 5 ACCOMPANIED BY AN ADDITIONAL TEN TECHNICAL SUPPLEMENTAL
- 6 REPORTS. NEXT SLIDE. SO, WE'RE REQUIRED, UNDER CEOA, TO
- 7 DEVELOP A PROGRAMMATIC ENVIRONMENTAL IMPACT REPORT FOR THE
- 8 PLAN, AND THAT LOOKS AT THE 14 REQUIRED IMPACT AREAS UNDER
- 9 CEQA. IT IDENTIFIES POTENTIAL IMPACTS, AS WELL AS MITIGATION
- 10 STRATEGIES, IT COMPARES THE DRAFT PLAN TO THREE ALTERNATIVES,
- 11 AND, ALSO, ANALYZING CUMULATIVE GROWTH INDUCING AND
- 12 IRREVERSIBLE IMPACTS ASSOCIATED WITH THE DRAFT PLAN. NEXT
- 13 SLIDE. SO, THE DRAFT IMPLEMENTATION PLAN, IT'S IMPORTANT TO
- 14 NOTE, IS REALLY THE MOST DYNAMIC PART OF THIS PLAN'S FINAL
- 15 PHASE. AND THERE WILL BE SIGNIFICANT OPPORTUNITY TO REVISE THE
- 16 DRAFT ACTIONS THAT ARE INCLUDED IN THE DRAFT IP, BASED UPON
- 17 INPUT FROM THIS BODY, AS WELL AS A WHOLE HOST OF PARTNERS
- 18 ACROSS THE REGION. SO, THIS PLAN IDENTIFIES 65 ACTIONS ACROSS
- 19 THESE DIFFERENT VEHICLES OF PLANNING, FUNDING, COORDINATION,
- 20 ADVOCACY, DELIVERY AND ASSISTANCE. AND THE REALLY SOME OF THE
- 21 KEY PRIORITIES THAT WE HEARD WAS THE IDEA OF DELIVERING ON
- 22 EXISTING COMMITMENTS RATHER THAN SIGNIFICANTLY EXPANDING THE
- 23 SCOPE OF THE IMPLEMENTATION PLAN TO INCLUDE, LIKE, YOU KNOW,
- 24 NEW INITIATIVES AREAS. TRANSITIONING SOME OF THE SUCCESSFUL
- 25 PILOTS THAT THE AGENCIES HAVE BEEN ADVANCING OVER THE LAST



- 1 SEVERAL YEARS INTO ONGOING INITIATIVES, AND ENSURING THERE ARE
- 2 SUFFICIENT RESOURCES TO SUSTAIN SOME OF THE PROGRESS THAT WE
- 3 HAVE BEEN ABLE TO ACHIEVE. AND THERE IS SIGNIFICANTLY MORE
- 4 DETAIL IN THE ATTACHMENT B THAT WAS INCLUDED IN YOUR PACKET.
- 5 NEXT SLIDE. IN THE TRANSPORTATION REALM, OBVIOUSLY FUNDING IS
- 6 A MAJOR CONSIDERATION, AND WITH THE ADVANCEMENT OF SB63, WE
- 7 WILL BE TRANSITIONING INTO, YOU KNOW, MORE OF OUR ROLE AS AN
- 8 IMPARTIAL PROVIDER OF INFORMATION AS THAT ADVANCES IN
- 9 PARTNERSHIP WITH OTHERS. THE FEDERAL SURFACE TRANSPORTATION
- 10 REAUTHORIZATION IS DUE TO EXPIRE AT THE END OF NEXT YEAR, AND
- 11 THAT WILL BE SOMETHING WE'LL BE CLOSELY WORKING WITH PARTNERS
- 12 ON TO ENSURE THAT THE REGION'S PRIORITIES ARE REFLECTED.
- 13 CLIPPER BAY PASS, REGIONAL MAPPING AND WAYFINDING, REGIONAL
- 14 TRANSIT PRIORITY INITIATIVES, THIS IS AN AREA THROUGH THE
- 15 REGIONAL NETWORK MANAGEMENT COMMITTEE AS WELL AS COMING OUT OF
- 16 THE TRANSIT TRANSFORMATION TASK THERE HAVE BEEN SOME PROMISING
- 17 RESULTS FROM THESE INITIATIVES AND WE'RE HOPING TO CONTINUE
- 18 THEM. IN A BROADER PERSPECTIVE THERE IS A LOT OF INTEREST IN
- 19 LOOKING AT COST EFFICIENCY AND COST EFFECTIVENESS FOR
- 20 TRANSPORTATION PROJECT DELIVERY, WHILE ALSO COUPLINGS THAT
- 21 WITH EFFORTS TO EXPAND IN THE LINE AFFORDABILITY AND EQUITY
- 22 PROGRAMS. WE HAVE HEARD A LOT OF INTEREST FROM PARTNERS IN
- 23 TERMS OF JUST LOOKING AT THE TOPIC OF CONGESTION, INCLUDING
- 24 THE DEVELOPMENT OF A POTENTIAL WHITE PAPER, LOOKING AT HOW
- 25 CONGESTION MANAGEMENT CAN EVOLVE IN THE REGION, AND ALSO A



- 1 REVIEW OF OUR EXPRESS LANES, A REVISITING OUR EXPRESS LANES
- 2 STRATEGIC PLAN IN LIGHT OF EVOLVING STATE PRIORITIES. WE
