23	JULIE SNYDER: GOOD MORNING, CHAIR CANEPA AND MEMBERS. JULIE
24	SNYDER MTC STAFF. EVERY YEAR WE COME TO YOU IN OCTOBER WITH
25	THE LEGISLATIVE SCORECARD BASED ON ADVOCACY YOU ADOPTED



- 1 EARLIER IN THE YEAR. THE SCORECARD IS IN YOUR PACKET AND
- 2 HIGHLIGHTS THE ROBUST SET OF 2024 POLICY GOALS. ON TOP OF
- 3 BUDGET FUNDING FOR REAP AND TRANSIT, AS WELL AS THE
- 4 TRANSPORTATION REVENUE MEASURE, YOU AND YOUR STAFF ENGAGED ON
- 5 A NUMBER OF OTHER ITEMS. I'M GOING TO HIT THE HIGHLIGHTS AND
- 6 WOULD BE HAPPY TO TAKE QUESTIONS ON ANY OTHER ITEMS. SO, WE'LL
- 7 GO THROUGH IN PAGE ORDER. THE FIRST COUPLE OF PAGES IN THE
- 8 SCORECARD ARE ITEMS THAT GEORGIA GAVE LAST MONTH INCLUDE
- 9 TRANSPORTATION REVENUE MEASURE, ACA10 VOTE THRESHOLD MEASURE
- 10 AND SB 960 AND BUDGET THE ONLY SUBSTANTIVE CHANGE SINCE THEN
- 11 IS GOVERNOR NEWSOME ON SIGNED SB 960 BY SENATOR WIENER THIS
- 12 BODY HAS BEEN ENCOURAGING LEGISLATURE TO TAKE ACTION ON
- 13 TRANSIT PRIORITY FOR A NUMBER OF YEARS THIS PIECE OF
- 14 LEGISLATION WAS PART OF YOUR TRANSIT ACTION PLAN. SO WE'RE
- 15 VERY PLEASED TO SEE IT SIGNED. MOVING DOWN TO PAGE THREE, WE
- 16 DIVE INTO THE HOUSING THREE P'S. THERE WEREN'T MANY HOUSING
- 17 BILLS THIS YEAR THAT GENERATE THE WIDESPREAD PUBLIC ATTENTION
- 18 OF THE TYPE WE HAVE SEEN IN THE PAST BUT WE CONTINUE TO SEE
- 19 SIGNIFICANT BIPARTISAN INTEREST IN TACKLING HOUSING
- 20 AFFORDABILITY AND HOMELESSNESS. LEGISLATORS LITERALLY
- 21 INTRODUCED HUNDREDS OF BILLS ON THOSE TOPICS. DON'T WORRY I'M
- 22 NOT GOING TO TALK ABOUT MORE THAN FIVE [LAUGHTER] . WEEKEND GO
- 23 ON FOR DAYS. MOVING DOWN TO PAGE -- SORRY -- THREE A ON THE
- 24 BAY AREA HOUSING FINANCE AUTHORITY. I'M PLEASED TO SHARE THAT
- 25 GOVERNOR NEWSOME SIGNED OUR AB 598 AUTHORED BYE R BY BUFFY



- 1 WICKS WHO CONTINUES TO BE A PRIMARY LEGISLATIVE CHAMPION FOR
- 2 THE BAHFA REGIONAL HOUSING WORK. THE BILL CLARIFIES THAT BAHFA
- 3 DOES NOT HAVE THE AUTHORITY ON FUNDING LOCAL LAND USE OR
- 4 HOUSING POLICIES THIS FULFILLS COMMITMENT MADE BY OUR AGENCY
- 5 LEADERSHIP TO THE BUSINESS COMMUNITY IN INTEREST OF
- 6 STRENGTHENING OUR ONGOING RELATIONSHIP WITH THEM. LOOKING AT
- 7 3B STATE FUNDING ON PAGE FIVE AS PREVIOUSLY REPORTED OUR MAJOR
- 8 EFFORTS IN THIS SPACE WAS PRESERVING ALMOST ALL OF THE REAP
- 9 2.0 FUNDING THAT THE GOVERNOR HAD PROPOSED CUTTING. AS A
- 10 RESULT MTC HAS \$96 MILLION FOR A RANGE OF PROGRAMS TO MAKE
- 11 TRANSIT MORE RIDER FRIENDLY AS WELL AS TO PRODUCE AND BUILD
- 12 AFFORDABLE HOUSING. MOVING DOWN TO ITEM 3C, THE GOVERNOR
- 13 SIGNED TWO BILLS THAT WE SUPPORTED TO HELP OUR LOCALITY MEET
- 14 THEIR HOUSING GOALS BY REDUCING DEVELOPMENT COSTS. APROPOS THE
- 15 CONVERSATION THAT THE PRIOR COMMITTEE JUST HAD ON THE
- 16 DEVELOPMENT COSTS. THE FIRST WAS AB2353 BY ASSEMBLY HOUSING
- 17 CHAIR CHRIS WARD, WHICH PROVIDES UP FRONT SAVINGS TO NON-
- 18 PROFIT DEVELOPERS BY MODIFYING THE WAY THAT THE WELFARE TAX
- 19 EXEMPTION IS ADMINISTERED. THE SECOND BILL IS AB1053 BY
- 20 ASSEMBLY BUDGET CHAIR JESSE GABRIEL. IT WILL SAVE BORROWERS
- 21 FROM THE STATE'S MULTI-FAMILY HOUSING LOAN PROGRAM
- 22 APPROXIMATELY \$1 MILLION PER TYPICAL \$11 MILLION LOAN BY
- 23 ALLOWING THEM TO ACCESS FUNDS DURING THE CONSTRUCTION PHASE,
- 24 AS OPPOSED TO WAITING UNTIL THEY HAVE CONSTRUCTED USING
- 25 PRIVATE DOLLARS AND THEN HAVE STATE DOLLARS COME IN AND BUY



- 1 THAT OUT. SIGNIFICANT SAVINGS. AND I ANTICIPATE THAT COST
- 2 REDUCTION WILL CONTINUE TO BE A BIG FOCUS OF POLICY MAKERS
- 3 NEXT YEAR, ESPECIALLY IF THE STATE BUDGET DEFICIT CONTINUES TO
- 4 LOOK BAD. SO, LET'S JUMP DOWN TO PAGE SIX IN THE AREA OF LAND
- 5 USE PLANNING REFORM IN THE CONTEXT OF SB 375 IN THE RHNA. LAST
- 6 YEAR THE STATE DEPARTMENT OF HOUSING AND COMMUNITY DEVELOPMENT
- 7 HELD A LONG STAKEHOLDER PROCESS TO INFORM RECOMMENDATIONS TO
- 8 THE LEGISLATURE ON THE REGIONAL HOUSING NEEDS ASSESSMENT
- 9 PROCESS AS WELL AS HOUSING ELEMENTS. AND AS A RESULT, WE
- 10 EXPECTED A WAVE OF BILLS TO FOLLOW THIS YEAR. HOWEVER, THE
- 11 FINAL REPORT WAS RELEASED LATE, AFTER THE BILL INTRODUCTION
- 12 DEADLINE, RESULTING IN FEWER BILLS THAN ANTICIPATED. THAT
- 13 SAID, GOVERNOR NEWSOM DID SOMETHING WHICH IS FAIRLY -- WHICH
- 14 IS QUITE UNUSUAL FOR A GOVERNOR, HE SPONSORED A MAJOR RHNA
- 15 BILL, AGAIN, BY ASSEMBLYMEMBER HOUSING -- ASSEMBLY -- SORRY --
- 16 ASSEMBLYMEMBER HOUSING COMMITTEE CHAIR, CHRIS WARD, AND THAT
- 17 WAS AB3093. THIS MEASURE FOCUSES ON MORE DEEPLY INCORPORATING
- 18 THE NEEDS OF PEOPLE EXPERIENCING HOMELESSNESS INTO THE HOUSING
- 19 ALLOCATION METHODOLOGY, AND THE HOUSING ELEMENT ZONING
- 20 REQUIREMENTS AND PROGRAMS. HCD HAS COMMITTED TO WORKING WITH
- 21 STAKEHOLDERS IN THE COMING YEAR TO DEVELOP A CLEAR SET OF
- 22 GUIDELINES, BECAUSE THE BILL DOES NOT CONTAIN MUCH DETAIL
- 23 ABOUT HOW THE STATE EXPECTS CITIES AND COUNTIES TO MEET THESE
- 24 NEW REQUIREMENTS. ADDITIONALLY MTC ABAG REGIONAL HOUSING
- 25 TECHNICAL ASSISTANCE PROGRAM IN ITS RHTA WILL OFFER RESOURCES



- 1 TO OUR LOCAL PARTNERS STARTING WITH OUR NEW HOUSING LAWS
- 2 WEBINAR IN DECEMBER AND GOING FROM THERE. SECOND HOUSING
- 3 PLANNING BILL THAT WE WANTED TO HIGHLIGHT WOULD HAVE HAD A
- 4 SIGNIFICANT IMPACT ON OUR SUSTAINABLE COMMUNITY STRATEGY. THIS
- 5 WAS ONE THAT THE COMMITTEE HAS DISCUSSED BEFORE AB1335 BY
- 6 SOUTHERN CALIFORNIA ASSEMBLYMEMBER RICK ZIEBER. THE BILL WAS
- 7 DRIVEN BY HOUSING ADVOCATES WHO WERE CONCERNED ABOUT THE
- 8 GROWTH FORECAST THAT APPEARED IN SCAG SUSTAINABLE COMMUNITY
- 9 STRATEGY. THE SPONSOR HAD GOOD INTENTIONS, WHICH WAS TO BETTER
- 10 ALIGN THE EIGHT YEAR RHNA TARGETS INTO THE SUSTAINABLE
- 11 COMMUNITY STRATEGY. BUT THEIR CHOSEN APPROACH WOULD HAVE BEEN
- 12 VIRTUALLY IMPOSSIBLE FOR MTC TO IMPLEMENT AND ALSO MEET OUR
- 13 FEDERAL AIR QUALITY CONFORMITY AND OTHER REQUIREMENTS. SO, WE
- 14 TOOK AN OPPOSED UNLESS AMENDED POSITION. BUT THE BILL HAD
- 15 STALLED LAST YEAR BUT WAS REVIVED NEAR THE END OF THE SESSION
- 16 WITH THE INTEND TO ADD SOME ADDITIONAL PROVISIONS FROM THE HCD
- 17 REPORT. HOWEVER, THE POLICY COMMITTEES DECIDED THAT THE
- 18 PROPOSED CHANGE WARRANTED MORE CONVERSATION, SO THEY HELD THE
- 19 BILL. WE DO ANTICIPATE DISCUSSION ON THIS WILL CONTINUE INTO
- 20 NEXT YEAR. AND THEN A REMINDER THAT THIS AGENCY WOULD LIKE TO
- 21 SEE HOLISTIC REVIEW OF THE SB 375 FRAMEWORK. AND ALONG WITH
- 22 THE OTHER BIG THREE MPOS, SENT A LETTER TO THE HEAD OF THE
- 23 RESOURCES BOARD TO ASK TO CONVENE A GOVERNMENT TO GOVERMENT
- 24 COLLABORATION AROUND THAT. THAT WORK HAS BEGUN, THE FIRST ALL
- 25 DAY IN-PERSON MEETING IS IN SACRAMENTO NEXT WEEK OR THE



- 1 FOLLOWING WEEK, IN THE FUTURE MEETINGS WE'LL HAVE ADDITIONAL
- 2 INFORMATION FOR YOU ON THAT. THEN I WOULD LIKE TO MOVE DOWN TO
- 3 PAGE EIGHT, ITEM FIVE, AND TALK A LITTLE BIT ABOUT THE
- 4 TRANSPORTATION SYSTEM SAFETY AND EFFECTIVENESS. AB2645 BY
- 5 ASSEMBLYMEMBER LACKEY IS A BILL THAT WE TOOK AN OPPOSE UNLESS
- 6 AMENDED POSITION ON, WHICH IS A RELATIVELY UNUSUAL STANCE FOR
- 7 OUR AGENCY. HOWEVER, IN THIS CASE, THE BILL WOULD HAVE HAD A
- 8 SERIOUS IMPACT ON OUR ABILITY TO OPERATE OUR TOLL PROGRAMS.
- 9 AND WE WERE PART OF A COALITION THAT UP TO THAT POINT HADN'T
- 10 GAINED TRACTION. THIS BILL WOULD HAVE REQUIRED THE BAY AREA
- 11 TOLL AUTHORITY TO PROVIDE TRAVEL INFORMATION ABOUT VEHICLES
- 12 THAT ARE SUBJECT TO A PUBLIC SAFETY ALERT. TAKING THE OPPOSE
- 13 UNLESS AMENDED POSITION HELPED US REALLY TO ENGAGE
- 14 PRODUCTIVELY WITH THE AUTHOR TO OFFER AMENDMENTS, REMOVING OUR
- 15 OPPOSITION IF THEY MADE THE BILL PERMISSIVE RATHER THAN
- 16 MANDATORY ON OUR TOLL AUTHORITY. THEY ACCEPTED THE AMENDMENTS
- 17 AND WE WERE ABLE TO MOVE TO NEUTRAL. SO, LASTLY, I'M GOING TO
- 18 TOUCH ON OUR FEDERAL ADVOCACY WORK. SKIPPING DOWN TO PAGE 11
- 19 OF THE DOCUMENT. ITEM 1A IS OUR DC TRANSPORTATION ADVOCACY,
- 20 WHICH FOCUSED, LARGELY, ON IMPLEMENTING THE COMMISSION'S BAY
- 21 AREA INFRASTRUCTURE GRANT STRATEGY. A REMINDER THAT THE
- 22 COMMISSION SPEARHEADED THIS STRATEGY IN 2022 TO POSITION THE
- 23 BAY AREA TO MAXIMIZE RESOURCES FROM THE INFLUX OF FUNDING FROM
- 24 THE 2021 INFRASTRUCTURE BILL. YOU PRIORITIZED A SHORT LIST OF
- 25 REGIONAL PRIORITY PROJECTS FOR THE MOST NATIONALLY COMPETITIVE



- 1 PROGRAMS AND ELEVATED THESE DURING YOUR ANNUAL DC ADVOCACY
- 2 TRIPS. THIS APPROACH CONTINUED TO SEE BIG SUCCESS THIS YEAR.
- 3 AS OF LAST MONTH, OUR REGIONAL PRIORITY PROJECTS HAVE SECURED
- 4 AWARDS IN TEN OF THE APPROXIMATELY 12 TARGETED GRANTS,
- 5 INCLUDING MOST RECENTLY, \$166 MILLION MEGA AWARD TO THE
- 6 INNOVATE 680 PROJECTS IN CONTRA COSTA COUNTY. SO, MOVING TO
- 7 ITEM C ON PAGE 12 IN THE HOUSING SPACE, MTC WAS PLEASED TO
- 8 SECURE A \$5 MILLION GRANT FROM HUD'S NEW HOUSING GRANT PROGRAM
- 9 TO IMPLEMENT OUR PRIORITY SITES DEVELOPMENT PROGRAM. YOU ALL
- 10 WERE INSTRUMENTAL IN CREATING THIS PROGRAM IN PRIOR YEARS DC'S
- 11 ADVOCACY TRIP BY HIGHLIGHTING THE VALUE OF BAHFA'S REGIONAL
- 12 APPROACH TO THE SENATE APPROPRIATIONS COMMITTEE. THEN AFTER WE
- 13 APPLIED FOR THE GRANT COMMISSIONERS ALSO OUTREACHED TO HUD TO
- 14 HELP SUPPORT OUR APPLICATION. PERHAPS MORE IMPACTFUL THAN OUR
- 15 INITIAL AWARD IS THAT CONGRESS HAS CONTINUED TO FUND THIS
- 16 PROGRAM WITH A SECOND ROUND EVER 100 MILLION MORE THAN THE
- 17 FIRST \$85 MILLION ROUND. THAT IS WITH APPLICATIONS ACTUALLY
- 18 DUE LATER THIS WEEK. SO THAT WILL HOPEFULLY CONTINUE TO BE
- 19 PART OF HUD'S PORTFOLIO THAT ELEVATES THE VALUE THAT REGIONAL
- 20 AGENCIES BRING TO THE SPACE. THE FINAL ITEM I WANT TO MENTION
- 21 IS PEPRA, THAT WILL BE ONGOING VERY IMPORTANT ISSUE NEXT YEAR
- 22 IT'S VITALLY IMPORTANT THAT OUR TRANSIT PARTNERS WITH ACCESS
- 23 AND MAINTAIN ACCESS TO THEIR FEDERAL TRANSIT FUND. MTC STAFF
- 24 IS CHAIRING THIS WORK AT THE STATEWIDE ASSOCIATION LEVEL AND
- 25 WORKING CLOSELY WITH THE GOVERNOR'S OFFICE HIS STAFF IS



- 1 FOCUSING THIS MONTH ON DEVELOPING A STRATEGY TO HAMMER OUT,
- 2 AND HELP ENSURE THAT THESE FUNDS KEEP FLOWING SO WE WILL
- 3 CONTINUE TO STAY ENGAGED IN THAT SPACE OVER THE COMING YEAR.
- 4 THAT'S A WRAP ON A VERY BUSY 2024. NEXT MONTH WE'LL BRING YOU
- 5 A DRAFT FORM FOR YOUR DISCUSSION THEN FINAL MONTH OR FOLLOWING
- 6 MONTH FOR YOUR APPROVAL. MR. CHAIR I'LL STOP THERE AND HAPPY
- 7 TO ANSWER ANY QUESTIONS ON ANY OF THE OTHER ITEMS.
