Subject: Contract Authorizations related to ABAG's Integrated Regional

Water Management (IRWM) Disadvantaged Community and

Tribal Involvement Program (DACTIP) Grant

Background:

On May 16, 2019, the ABAG Executive Board authorized the MTC Executive Director, or her designee, to use her authority to enter into contracts up to \$200,000 each with 8-13 community partners, to conduct outreach, needs assessments, and project development activities. Specific information about those partners and their discrete budgets were included in an item approved by the Board on July 18, 2019. This item seeks approval to increase the budgets of our outreach partners, as detailed in tables 1 and 2 below, to continue developing projects to proposal ready status and to conduct tap water quality testing efforts.

In 2019, ABAG was awarded \$3,020,000 in grant funding from the California Department of Water Resources' IRWM Disadvantaged Community Involvement Program (funded by California Proposition 1). The work under this grant was begun under a previous grantee that was not able to complete the workplan as required by the state. This grant has funded local community outreach partners to work with disadvantaged, underrepresented, and tribal communities throughout the Bay Area to conduct needs assessments to identify water-related needs and solutions. The goal of this work is to identify projects in these communities that could be proposed in future rounds of funding and to integrate these communities into the IRWM funding and oversight processes. This grant was recently increased to \$4,807,000 to support continued project development work and to conduct tap water quality testing efforts.

The original suit of community outreach partners has finished their needs assessments and have continued onto project development. To develop projects into proposal ready status, additional funding is required to support community outreach partner staff and to secure consultant expertise. These community outreach partners and their proposed budgets are included in *Table 1: Revisions to Original Authorizations* below.

These project partners will also build off their findings in their needs assessments that found an alarming degree of mistrust in tap water. The state has provided additional funding in part to support this regional tap water quality testing effort. This request

also includes Dr. Greg Pierce, a subject matter expert in tap water quality and water quality testing efforts. Dr. Pierce's services were originally procured using informal bidding process. Dr. Pierce's role has expanded as the tap water quality testing program continues to develop and is included in *Table 2: New Outreach Partners and Consultants* for approval of up to \$50,000 to support the effort.

Since entering into agreement with the state and continuing the work started under the previous grantee, Estuary Partnership staff have assessed the work program and determined that it must be expanded to include those experiencing homelessness and south bay communities. This authorization includes additional community outreach partners to help conduct the needs assessments with unsheltered and south bay communities. These new partners are included in *Table 2: New Outreach Partners and Consultants*, along with All Positives Possible. All Positives Possible is a new DACTIP community outreach partner that will work to develop project ideas to meet the needs of Richmond and Vallejo and will work with a number of other community-based organizations to conduct tap water quality testing.

Table 2 also includes a \$180,000, contingency on the total authorization to be used in the event that outreach partners listed in tables 1 or 2 need to increase their budgets to achieve program goals. This amount was previously authorized by the Executive Board to procure programmatic support from the San Francisco Public Utilities Commission, but the SFPUC was not able to contract with MTC for this project within the project's required time frame. This contingency will allow program staff the flexibility to make small adjustments to contract budgets if necessary to support project completion.
