WHICH IS THE EXPRESS LANES 4 5 START PILOT EXTENSION APPROVAL OF THE 18 MONTH EXTENSION OF EXPRESS LANES START PILOT THIS ITEM EXTEND THE EXPRESS START 6 PILOT WHICH PROVIDES LOW-INCOME USERS DISCOUNT THE TOLL ON 7 8 INTERSTATE 880 EXPRESS LANES BY 18 MONTHS THIS ACTION ALLOWS CUSTOMERS RECEIVING PROGRAM BENEFITS WHILE STAFF COMPLETES 9 EVALUATION AND RECOMMENDATIONS THIS FALL THEY WILL HAVE THE 10 ABILITY TO FINE TUNE THE PROGRAM AT ANY TIME FOLLOWING 11 RECOMMENDATIONS AND CONCURRENT VIEW OF OPPORTUNITIES TO EXPAND 12 ENROLLMENT AND ELIGIBILITY ACROSS MTC'S LOW-INCOME PROGRAMS. 13 STAFF ENSURED THEY'RE EXPLORING NEW PARTNER OPPORTUNITIES AS 14 15 WELL AS ADDITIONAL PARTNERSHIPS WITH COMMUNITY BASED 16 ORGANIZATIONS INCLUDING THOSE SUGGESTED BY THE COMMITTEE.
