

Napa County SHARE Rental Assistance Pilot Program: 2025 Update BAHFA Advisory Committee| January 23, 2025





Pilot Goals

- Reduce the risk of homelessness for ELI and severely rentburdened participants
- Connect participants with other safety net benefit programs and stabilizing supports to achieve long-term stability
- Center equity and community voice
- Prioritize efficient program administration and low-burden access

Program Model

- \$5M in MTC Funds
- Napa County Housing Department additional \$1.6M
- Expect to serve ~150 people over 4 years
- Participants receive:
 - Up to \$800 / month in rent
 - Case management

Launch Period Achievements

- Strong partnerships with providers to provide outreach and case management
- Public application portal launched
- Evaluation plan underway with Napa County Department of Public Health
- 33 active and enrolled clients; 12 applications in progress January 1

"My heart is full. I am so grateful because of this program. Because of this miracle, I am able to go out and get a sandwich with friends and family without feeling I won't be able to pay my rent or bills. I am able to buy other necessities like undergarments. I am just super blessed - I was scared I was going to be homeless again."

"I only earn \$1,627 a month and the rent is \$1,409, I wouldn't have enough money for food or utilities, so I'm so thrilled and grateful. My appreciation to Napa County for providing this so necessary program to keep seniors housed. Thank you."



Launch Period Eligibility Criteria

- ✓ 65 years or older
- $\checkmark\,$ Have lived in Napa County for at least 1 year
- ✓ Earn less than \$30,850 if you live alone; \$35,250 if with another person
- $\checkmark\,$ Spend 70% or more of income toward rent
- ✓ No other rental assistance (e.g., housing voucher)
- ✓ No more than \$7,500 in assets or savings (except ownership of mobile home)


Additional prioritization:

- □ Homeless in previous 3 years
- Recent eviction notice due to lack of money
- Eviction in previous 3 years
- □ Loss of a person who paid for housing costs

- Not eligible for federal assistance due to immigration status
- □ Felony conviction on background check
- □ Financial fraud victim in past 3 years




Participants are Highly Rent-Burdened



Increasing Racial and Ethnic Diversity Requires Ongoing Outreach



Income Levels Make Meeting Basic Needs Extremely Challenging

Typical Senior on Social Security



Average SSI in CA: \$1,670 per month Annual Income: \$20,400



Average rent for Napa 1BR: \$1,928 Rent burden: 115%



Funds Left: -\$258 per month Senior must rely entirely on family and community assistance; cannot sustain housing costs



Threshold Client Eligibility



Income: \$2,500 per month (30,000 per year)



Average rent for Napa 1BR: \$1,928 Rent burden: 77%



Funds Left: \$572 per month **Funds Left After Taxes:** \$317 per month

Early Learnings and Next Steps

- Continue to provide support and problem-solve for landlord and documentation-related challenges
- Increased outreach efforts in Latine communities
- Racial Equity Training Series in 2025
- Continue to enroll applicants; reevaluate eligibility criteria in 2025
- Department of public health evaluation continuation
