Approval of a proposed amendment to Plan Bay Area 2050 ("Plan") to include the Sonoma-Marin Area Rail Transit District's (SMART) passenger rail service extension to Healdsburg, and the approval of two companion technical documents: the Transportation-Air Quality Conformity Analysis (Conformity Analysis) and the Environmental Impact Report (EIR) Addendum.
