**Public Comment: for the June 10 Bay Area Toll Authority Oversight Committee Meeting – FasTrak Toll Violation OCR Failures**

Dear Bay Area Toll Authority Oversight Committee members,

I am submitting this written public comment to urge you to address a serious failure in the system used to identify Bay Area FasTrak toll violations.

I have received 28 false Notices of Toll Evasion from Bay Area FasTrak. In every instance, the pictured car is either a Lexus SUV with license plate 9RTA204 or the image is unreadable.

This is not my car:

- My license plate is 9WTA204, not 9RTA204 — “W,” not “R.”
- My car is a Rivian, not a Lexus.
- My car has never been in the Bay Area.

Examples are in the attached figures.

I have disputed every instance by mail, phone, and/or email, yet I continue to receive false Notices of Toll Violation. The failure to correct this obvious error after repeated notice reflects a serious lack of responsiveness.

This is not an isolated mistake. It appears to reflect a systemic failure in the OCR software or another process used to read license plates and match them to registered owners.

When the system gets it wrong, the burden shifts to the public to dispute charges and defend against penalties they do not owe. That creates financial risk, unnecessary stress, and a significant due-process concern, especially because these notices threaten serious consequences if they are not addressed.

If this has happened to me 28 times, it may be happening to many other drivers as well. A system that repeatedly issues violation notices to the wrong vehicle owner subjects innocent drivers to wrongful enforcement while failing to identify and hold the actual violator accountable.

I respectfully ask the Committee to direct an independent review of the OCR and plate-matching process, require disclosure of the error rate and quality-control procedures, suspend enforcement where

image-to-vehicle mismatches are identified, and establish a straightforward process for dismissing clearly erroneous notices.

Please treat this as evidence of a serious enforcement failure, not a one-off customer service issue. I urge the Committee to act promptly to stop the wrongful issuance of violations to innocent drivers and ensure that actual violators are accurately identified and held accountable.

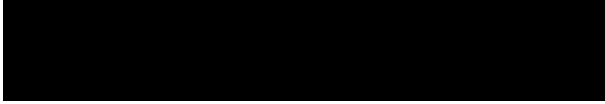
