4 SKIPPING AGENDA ITEM 7 POSTPONING TO THE NEXT MEETING AND NOW
5 WE'RE AT AGENDA ITEM 8A, PRIORITY CONSERVATION AREA GRANT
6 PROGRAM IN AN AMOUNT NOT TO EXCEED \$8 MILLION. THIS IS AN MTC
7 ACTION ITEM, AND WE HAVE BEN BOTKIN TO PROVIDE THE
8 PRESENTATION SUPERVISOR GOOD MORNING, I'M SO PLEASED TO BE
9 HERE. MY NAME IS BEN BOTKIN, THE CONSERVATION AREA GRANT
10 PROGRAM MANAGER. TODAY WE'RE HERE TO SHOW YOU THE FOURTH ROUND
11 OF THE CONSERVATION GRANT CYCLE, BY FAR THE MOST POPULAR.
12 TODAY I'LL BE PROVIDING A BRIEF OVERVIEW OF THE PROCESS
13 DESCRIBE HOW THE PROGRAM ADVANCES PLAN BAY AREA STRATEGIES AND
14 HOW PROPOSALS WERE EVALUATED, PROJECT TYPE ELIGIBILITY AND TO
15 SHARE OUR RECOMMENDATIONS, LASTLY TO IDENTIFY NEXT STEPS. I
16 KNOW IT'S A PACKED COMMITTEE AGENDA TODAY, SO WE'LL JUMP RIGHT
17 IN. INCOMES SLIDE, PLEASE PLEASE. SO IN SEPTEMBER THIS
18 COMMITTEE APPROVED THE STAFF'S REQUEST TO RELEASE AN \$8
19 MILLION CALL FOR PROPOSALS. AS FOLKS MAY REMEMBER, THE PCA
20 GRANT FUNDS WERE SPLIT INTO TWO ROUNDS WITH THE GOAL OF
21 GETTING FUNDS OUT FOR PROJECTS IN NEED WHILE ALSO RESERVING
22 SOME FUNDS FOR COMPLETION OF THE PCA REFRESH PROCESS, WHICH
23 WAS AN UPDATE TO THE PCA PLANNING FRAMEWORK, WHICH COMPLETED
24 IN 2025. THE CALL FOR PROPOSALS WAS RELEASED JUST BEFORE
25 THANKSGIVING, AND IN OUR FIRST ROUND SETTING OFF A TWO-STEP

1 PROCESS WITH THE FIRST LETTER OF INTEREST PHASE RECEIVING 53
2 LETTERS OF INTERESTS, REQUESTING NEARLY \$36 MILLION IN FUNDS.
3 AFTER A FULL EVALUATION, 28 PROPOSALS WERE ADVANCED TO PREPARE
4 A FULL APPLICATION, AND THAT WAS ABOUT \$19 MILLION IN REQUESTS
5 AND ULTIMATELY WERE PRESENTING 16 PROJECTS FOR AWARDS TODAY.
6 NEXT SLIDE, PLEASE. TAKING A SLIGHT STEP BACK, WHILE MANY OF
7 THE PROCESS AND GOALS OF THE PCA PROGRAM HAVE REMAINED
8 CONSISTENT OVER PREVIOUS ROUNDS, IN THIS ROUND WE WERE ABLE TO
9 INCORPORATE THE FINDINGS OF THE PCA REFRESH AND THE UPDATES TO
10 THE PLAN FRAMEWORK INTO OUR GRANT GUIDELINES. THE PCA PROGRAM
11 IS REALLY INSTRUMENTAL IN IMPLEMENTING SEVERAL BAY AREA PLAN
12 STRATEGIES, PARTICULARLY EN5 AND EN6, AND THE PCA REFRESH
13 PROVIDED A MUCH MORE STRUCTURED APPROACH IN ORDER TO PROTECT
14 AND RESTORE KEY HABITATS IN OPEN SPACE, SUPPORT THE
15 AGRICULTURAL ECONOMY, ENHANCE BIKE INFRASTRUCTURE AND REGIONAL
16 TRAILS AND PROVIDE URBAN GREEN AND CLIMATE RESILIENCE IN URBAN
17 AREAS. FOR THE NATURAL BE LANDS PCA TYPE, ONE OF THE
18 OBJECTIVES IS TO MAINTAIN A WILDLIFE CORRIDOR AND
19 CONNECTIVITY. FOR URBAN GLEAMING IT'S TO PRIORITIZE URBAN
20 GREENING AND EQUITY PRIORITY COMMUNITIES AND FOR RECREATION TO
21 COMPLETE AND ENHANCE ACCESS TO THE REGIONAL TRAILS NETWORK. BY
22 ESTABLISHING DATA INDICATORS AND INCORPORATING THESE
23 OBJECTIVES INTO THE PCA EVALUATIONS AND CRITERIA WE WERE
24 BETTER ABLE TO EVALUATE THE OBJECTIVES THAT ALIGN WITH THE
25 PLAN FOR THE BAY AREA, NEXT SLIDE, PLEASE. FOR THE EVALUATION

1 PROCESS WE HAD FOUR KEY CRITERIA THAT WERE ESTABLISHED IN OUR
2 GUIDELINES. ONE WAS ALIGNMENT WITH THOSE PCA OBJECTIVES AND
3 GOALS. THE SECOND WAS HOW A PROJECT WAS ENGAGING WITH
4 PARTNERS, THE COMMUNITY, COMMUNITY-BASED ORGANIZATIONS, IN
5 PARTICULARLY EQUITY PRIORITY COMMUNITIES, LOOKING FOR PROJECTS
6 THAT HAVE A HIGH-SCORING PRIORITIZATION AS WELL AS THOSE WITH
7 SUCCESS, CAN THE APPLICANT DELIVER ON THE PROPOSED COACH WORK
8 THAT THEY WERE PROVIDING. WE HAD FUNDING TARGETS THAT WERE SET
9 BY THE COMMISSION. THIS INCLUDED PROVIDING FUNDING TO AT LEAST
10 ONE PROJECT PER COUNTY. FUNDING A DIVERSITY OF PROJECT TYPES
11 AND ACTIVITIES AND RECOMMENDING THAT AT LEAST 50% OF AWARDS BE
12 FOR PROJECTS IN THE FOUR NORTH BAY COUNTIES. THIS 50% NORTH
13 BAY TARGET DATES BACK TO THE INITIATION OF THE PCA GRANT
14 PROGRAM AS A WAY OF BALANCING ABAG FUNDING AND RECOGNIZE THAT
15 56% OF THE CONSERVATION PRIORITY LANDS AND 81% OF THE REGION'S
16 REMAINING PRIME FARMLANDS IN THOSE FOUR NORTH BAY COUNTIES.
17 NEXT SLIDE, PLEASE. BEFORE WE GET TO THE PROJECT
18 RECOMMENDATIONS, I DID WANT TO QUICKLY NOTE THE TYPES OF
19 PROJECTS THAT WERE ELIGIBLE FOR FUNDING. THIS HAS REMAINED
20 CONSISTENT OVER ALL OF THE PREVIOUS PCA GRANT CYCLES AND
21 REALLY HELPS TO SUPPORT THOSE PLAN BAY AREA STRATEGIES. SO
22 OVER THE PRIOR CYCLES, WE'VE AWARDED 38 MILLION TO OVER 70
23 PROJECTS ACROSS THE REGION TO ADVANCE THESE TYPES OF PROJECTS,
24 AND REALLY WHAT'S YOU A PEEK THAT ABOUT THIS PROGRAM IS IT CAN
25 FUND ALL PHASES, AND SO WE'RE ABLE TO MEET GRANTEEES WHERE

1 THEY, SUPPORT THINGS LIKE COMMUNITY ENGAGEMENT, INITIAL
2 PLANNING AND DESIGN, PERMITTING AND ENVIRONMENTAL REVIEW.
3 SOMETIMES THOSE HARDER TO FUND -- PARTS OF THE PROJECT CYCLE
4 THAT ARE REALLY CRITICAL TO DELIVERING ON THESE PROJECTS.
5 NEXT, PLEASE. SO THAT GETS US TO OUR FUNDING RECOMMENDATIONS,
6 AND WE'RE REALLY PLEASED TO SHARE THIS EXCELLENCE SUITE OF
7 PROJECTS. SPANNING ALL 9 BAY AREA COUNTIES, THESE PROJECTS
8 ADVANCE REGIONAL PRIORITIES THROUGH REGIONAL TRAIL CLOSURES,
9 WILDLIFE CROSSINGS, CREEK CORRIDORS AND SHORELINE ACCESS WHILE
10 SUPPORTING COMMUNITY STEWARDSHIP, PARK DEVELOPMENT AND
11 AGRICULTURAL VIABILITY. MANY PROJECTS FOCUSED ON FOUNDATIONAL
12 WORK SUCH AS FEASIBILITY STUDIES, ENVIRONMENTAL REVIEW AND
13 HABITAT RESTORATION PLANNING, THIS COULD MEAN LARGER CAPITAL
14 EFFORTS WHILE OTHERS ARE LOOKING AT PARK PRIORITY AREAS NEXT
15 SLIDE, PLEASE. AS I NOTED IN THE BEGINNING IT WAS INCREDIBLY
16 CHALLENGING TO WINDOW DOWN FROM THE 23 INITIAL PROPOSALS THAT
17 WE RECEIVED. A LOT OF EXCELLENT PROJECTS THAT REALLY DESERVE
18 FUNDING BUT WE FELT THAT THESE ONES BEST ALIGNED WITH THE
19 VEAFLTION OUR CRITERIA AND FUNDING TARGETS. OVERALL THIS \$8
20 MILLION INVESTMENT SUPPORTS MULTIBENEFIT SOLUTIONS THAT LINK
21 ECOLOGICAL HEALTH WITH PUBLIC ACCESS, CLIMATE RESILIENCE AND
22 COMMUNITY ENGAGEMENT INCLUDING EQUITY-COMMUNITIES TO MAKE IT A
23 MORE HEALTHY PLACE TO LIVE AND VIBRANT. IN CONCLUSION, STAFF
24 IS SEEKING APPROVAL OF \$8 MILLION OF PCA GRANT FUNDS. UPON
25 APPROVAL, STAFF WOULD WORK WITH GRANTEES TO ESTABLISH THE

1 SCOPE OF WORK, BUDGETS AND TIMELINES AND ENTER INTO CONTRACT
2 THIS SUMMER. AND THEN LOOKING FORWARD, WE'RE LOOKING FORWARD
3 TO A FUTURE ROUND OF ABAG FOR PCA GRANTS IN THE 27/28 PERIOD
4 WHILE IN THE MEANTIME WORKING WITH PARTNERS TO ADVANCE BAY
5 AREA CONSERVATION STRATEGIES. NEXT SLIDE, THAT CONCLUDES MY
6 PRESENTATION TODAY, AND WITH THAT, I AM HAPPY TO ANSWER ANY
7 QUESTIONS YOU MAY HAVE. THANK YOU.

11 **PAT ECKLUND:** THANK YOU VERY MUCH. AND GREAT PRESENTATION. MY
12 QUESTION IS, THE APPLICANTS THAT WERE NOT SELECTED, DO YOU
13 HAVE A WRITTEN DOCUMENT THAT CAN SHARE WHY THESE APPLICATIONS
14 WERE NOT SELECTED? SUPERVISOR CERTAINLY, AND WE HAVE WORKED
15 WITH MANY OF THE APPLICANTS THAT HAVE FOLLOWED UP THAT WERE
16 NOT SUCCESSFUL IN SHARING WITH THEM OPPORTUNITIES FOR WAYS TO
17 IMPROVE THEIR PROPOSAL PERHAPS IN FUTURE ROUNDS. WE DO NOT
18 HAVE A WRITTEN-OUT FOR EVERY SINGLE PROJECT THAT WAS NOT
19 ADVANCED BUT CERTAINLY THAT'S SOMETHING THAT COULD BE
20 DEVELOPED IF DESIRED BY AN APPLICANT.

15 AND EFFORT, ALL THE WORK YOU PUT INTO THIS. AND THAT'S ALL I
16 REALLY WANTED TO SAY. I RECEIVED THE EMAIL YESTERDAY, SO I'M
17 LOOKING FORWARD TO OUR VOTE. THANK YOU.

23 EXPRESS MY APPRECIATION ON BEHALF OF THE CITY OF ALMEDA FOR
24 FEASIBILITY STUDY FOR THE WOODEN BRIDGE, AND JUST TO EXPLAIN A
25 LITTLE BIT ABOUT WHAT IT IS. WE HAVE ' RESIDENTIAL AREA AND

1 PUBLIC ELEMENTARY SCHOOLS BUT ALL OF THE CHILDREN WHO GO TO
2 MIDDLE SCHOOL OR HIGH SCHOOL GO ON TO THE MAIN ISLAND. SO THIS
3 WOODEN BRIDGE IS A CONNECTOR TO GET THEM TO THE BICYCLE
4 PEDESTRIAN BRIDGE THATS CROS THE ESTUARY AND IT'S GOTTEN VERY
5 OLD AND RICKETY AND WE'RE ASKED NOT TO RIDE OUR BIKES BUT TO
6 WALK THEM OVER TO THIS BRIDGE. SO IT'S WONDERFUL THAT WE HAVE
7 THE FEASIBILITY STUDY TO GET -- TO MOVE US CLOSER TO THE
8 REPLACEMENT. AND I'M PROUD TO REPORT THAT IN THE CITY OF
9 ALMEDA, 40% OF OUR SCHOOL CHILDREN GET THEMSELVES TO SCHOOL ON
10 THEIR BIKES OR WALKING OR SCOOTERS OR ON THE BUS. SO THIS IS
11 JUST A VERY IMPORTANT PIECE OF INFRASTRUCTURE THAT WILL HELP
12 ALL THE KIDS WHO LIVE ON THE HARBOR BAY PART OUR ISLAND TRAVEL
13 MORE SAFELY, BUT WITHOUT NEEDING A RIDE TO SCHOOL. SO THANK
14 YOU. HE

2 THAT PART OF THE PROCESS AS WELL SUPERVISOR YEAH, GREAT
3 QUESTION. IT CERTAINLY IS AND WE'VE MADE MINOR CHANGES OVER
4 THE PREVIOUS CYCLES WITH THIS LAST ROUND A BIT MORE OF A
5 SUBSTANTIVE UPDATE FOLLOWING THE PCA REFRESH, SO THIS WAS THE
6 FIRST TIME POST PCA REFRESH OF HAVING THIS THRONES LOOK AT
7 PROJECTS. HONESTLY A LOT OF THE PROJECTS DID SCORE VERY WELL.
8 IT WASN'T SUCH A MATTER OF A LOT OF THESE PROJECTS NOT
9 ALIGNING WITH OUR CRITERIA. IT'S JUST AVAILABLE FUNDING. WE
10 HAD TO MAKE SOME REALLY HARD DECISIONS. SODA CITY LIVE SAY ONE
11 OTHER BENEFIT OF THIS PROGRAM IS WE DO WORK VERY CLOSELY WITH
12 THE STATE COASTAL CONSERVANCY, AND SO HAVING THEM AS PARTNERS
13 ALLOWS THEM TO GET FAMILIAR WITH THESE PROJECTS AS WELL AND
14 THEY SOMETIMES HAVE OTHER AVAILABLE FUNDS. SO IN WORKING WITH
15 THEIR STAFF, WE HAVE BEEN ABLE TO IDENTIFY SOME PROJECTS THAT
16 ARE MAYBE ABLE TO MOVE FORWARD FOR SOME OF THEIR FUNDING AS
17 WELL.

13 WE'VE ALREADY HAD TWO INSTANCES AND THERE'S A MAJOR PROJECT
14 RIGHT NOW THAT IS ACTUALLY BEING DRIVEN BY FORMER MAYOR CHUCK
15 REID, AND ONCE AGAIN, WE HAVE SEEN EFFORTS -- HAVEN'T SEEN
16 EFFORTS TO MOVE THE PLANS TO NEIGHBORHOODS. I'M ACTUALLY GOING
17 TO GIVE YOU THE ADDRESSES, AND THEN YOU CAN SEE WHAT'S GOING
18 ON. THE FIRST ONE IS 6321 SAN IGNACIO AVENUE. I KNOW THE
19 BUILDING VERY WELL. I WORKED IN THAT BUILDING FOR THREE YEARS.
20 I WAS ACTUALLY INSIDE THE BUILDING WHEN THE ' 89 EARTHQUAKE
21 HIT. YOU WOULD HAVE NEVER GUESSED THERE WAS A 700 WATT
22 MEGAWATT BATTERY INSIDE THAT 70,000 SQUARE-FOOT BUILDING. THE
23 OTHER ONE IS 6150 SAN IGNACIO AVENUE. IF YOU GOOGLE IT, YOU'RE
24 GOING TO SAY THIS IS A NON-HISTORIC FACILITY. WELL, IT WAS
25 LAST MONTH. BUT NOW ALL THE RVS HAVE BEEN MOVED OUT. AND WHILE

21 SUPERVISOR GOOD MORNING CHAIR AHN, VICE-CHAIR BURT, COMMITTEE
22 MEMBERS. MY NAME IS MICHAEL MEEHAN AND PROJECT DIRECT FOR
23 LOOKING AHEAD TO PLAN BAY AREA 2060, WHICH IS WHAT WE'LL BE
24 INTRODUCING TO YOU TODAY. NEXT SLIDE, PLEASE. TODAY'S
25 PRESENTATION IS SPLIT INTO TWO PARTS, FIRST WITH A BIT OF

1 BACKGROUND ON PLAN BAY AREA AND THEN COVERING OUR INITIAL WORK
2 ON 2060 THUS FAR. I'LL TRY TO BE BRIEF ON THE FIRST HALF SO
3 THAT WE CAN FOCUS ON 2060 AND ANY EARLY FEEDBACK YOU MAY HAVE
4 FOR OUR TEAM. NEXT SLIDE, PLEASE. SO I'LL BE AT VARYING
5 DEGREES. I IMAGINE ALL OF THE COMMITTEE MEMBERS ARE QUITE
6 FAMILIAR WITH THE PURPOSE OF PLAN BAY AREA, IT'S THE REGION'S
7 LONG-RANGE PLAN INTEGRATING TRANSPORTATION, LAND USE AND THE
8 ENVIRONMENT. AND IT'S A FRAMEWORK OF PRIORITIES RATHER THAN A
9 SET OF REGULATORY MANDATES. THE LAST BULLET HERE IS MAYBE THE
10 MOST SALIABILITY FOR TODAY'S PRESENTATION NOTING THAT THE
11 PLAN EVOLVES WITH THE EMERGING NEEDS AND CHALLENGES OVER TIME
12 AND ACROSS ITERATIONS DELIVERING RESULTS THROUGH STRONG
13 PARTNERSHIPS AND LOCAL LEADERSHIP. NEXT SLIDE, PLEASE. AS FOR
14 THE CORE REGULATORY REQUIREMENTS, THE PLAN NEEDS TO DO MANY
15 THINGS. IT NEEDS TO FIRST MEET THE VARIOUS STATE AND FEDERAL
16 STATUTES THAT OUTLINE TIMING, COORDINATION AND COMMUNITY
17 ENGAGEMENT, AND IT NEEDS TO PRODUCE A FISCALLY SOUND PROJECT
18 LIST THAT SERVES OUR REGIONAL NEEDS AND ACCOMMODATE FUTURE
19 GROWTH AND APPROPRIATE LEVELS OF HOUSING ACROSS ALL ECONOMIC
20 SEGMENTS. OF COURSE, LASTLY, IT ALSO NEEDS TO ACHIEVE THE

22 NEXT SLIDE, PLEASE. SO SINCE 2013 WHEN THE FIRST PLAN BAY AREA
23 WAS ADOPTED, IT HAS EVOLVED FROM INTEGRATED PLANNING TO A MORE
24 COMPREHENSIVE APPROACH. HERE WE'RE TRYING TO CHARACTERIZE THE
25 PROGRESSION FROM THE EARLY 2013 AND 2017 ITERATIONS, WHICH

1 WERE MORE NARROWLY TAILORED IN THEIR POLICIES AND REPRESENTS

4 2050, THE FIRST MAJOR UPDATE TO THE PLAN, AND THEN OF COURSE
5 THE RECENTLY ADOPTED 2050 PLUS, THESE PLANS TOGETHER REPRESENT
6 A SHIFT EVOLVING INTO A MORE COMPREHENSIVE APPROACH TO ACCOUNT
7 FOR EXPANDED PRIORITIES, TAKING A MORE VISIONARY AND
8 ASPIRATIONAL STANCE ORIENTING MANY CORE COMPONENTS AROUND THE
9 QUESTION OF WHAT WOULD IT TAKE TO ACCOMPLISH OUR GOALS FOR THE
10 REGION. NEXT SLIDE, PLEASE. NOW, AS A BRIEF REFRESHER ON 2050
11 PLUS BEFORE GETTING MORE INTO 2060, THE RECENTLY ADOPTED
12 UPDATE WAS NOILY MINOR BUT NONETHELESS COVERED SIGNIFICANT
13 GROUND OVER FOUR ELEMENTS, 11 THEMES AND 35 STRATEGIES,
14 TOGETHER DIRECT OVER 1.4 TRILLION DOLLARS IN INVESTMENTS AND
15 MEETING OUR GREENHOUSE GAS TARGETS. NOTABLE IS THAT THIS WEEK
16 WE RECEIVED FEDERAL APPROVAL FOR PLAN BAY AREA 2050, AND THE
17 REGION IS NOW OUT OF ITS CONFORMITY LAPSE GRACE PERIOD. ALL
18 RIGHT. SO TRANSITIONING TO 2060, FIRST WITH SOME KEY CONTEXT
19 FOR THIS EFFORT. THIS UPDATE IS CONSIDERED MAJOR, AND
20 THEREFORE WILL INCLUDE A MORE FOUNDATIONAL EVALUATION OF
21 PLANNING ASSUMPTIONS AND OTHER COMPONENTS OF THE PLAN. WE'RE
22 EXPECTING DURING THIS UPDATE THAT THERE WILL BE SHIFTS IN
23 STATE PLANNING REQUIREMENTS THROUGH SB375 MODERNIZATION,
24 SB1087 AS WELL AS READVISED GHD TARGETS AND CARB GUIDELINES.
25 IMPORTANTLY THIS UPDATE WILL ALIGN WITH RHNA CYCLE 7 WHICH

1 WILL BE CONFIRMED BY THE REGIONAL PLAN AND RUN PARTICLE TO
2 PLAN BAY AREA 2060 WITH THE STATE'S REGIONAL HOUSING NEEDS

4 2060 UPDATE, WE'VE BEEN REFLECTING ON PAST PLANS TO GLEAN SOME
5 IMPORTANT LESSONS AND HELP FRAME THE OPPORTUNITIES WE HAVE TO
6 IMPROVE AND BETTER ADDRESS SOME ONGOING CHALLENGES. SO THIS
7 INCLUDES THE EXTENT TO WHICH AN ASPIRATIONAL VISION CAN FEEL

9 PRIORITIZATION, SPEAKING HERE MOST CLEARLY TO THE MOST RECENT
10 TWO ITERATIONS OF THE PLAN. HOW INHERENTLY COMPLEX CONTENT CAN
11 BE UNCLEAR AND HARD TO NAVIGATE. AND THAT THE SCALE OF LONG-
12 RANGE, REGION-WIDE PLANNING CAN BE DIFFICULT TO TRANSLATE INTO
13 NEAR-TERM AND LOCAL-LEVEL IMPLEMENTATION. NEXT SLIDE, PLEASE.
14 ALL RIGHT, SO THERE'S A LOT OF TEXT ON THIS SLIDE, BUT WE
15 THINK IT'S IMPORTANT MATERIAL TO COVER AS WE BEGIN THE
16 DEVELOPMENT OF OUR SCOPE. SO WE'VE OFFED THREE THEMES TO
17 HIGHLIGHT HERE, AND WE'LL SHARE EACH THEM IN A BIT MORE
18 DETAIL. SO FIRST WE HIGHLIGHT PLAN UTILITY AND A DESIRE TO
19 ENHANCE HOW THE PLAN CONNECTS LONG-RANGE PLANNING TO EVERY DAY
20 CONCERNS, USING A CLEAR NARRATIVE. WE AIM TO IMPROVE THE
21 USABILITY AND PUBLIC ENGAGEMENT AROUND THE PLAN BY MAKING

4 TOPIC AS WELL. NEXT SLIDE, PLEASE. SO MOVING ON TO THE

6 WE'RE CURRENTLY CHARACTERIZING THE PROCESS AS COMPROMISED OF

5 IN PLANNING. OKAY, I HAVE A QUESTION ON NUMBER 10. HAVE YOU
6 ADVANCE FOCUS ON EQUITABILITY, IMPROVING AFFORDABILITY AND
7 REDUCING HOMELESSNESS. REDUCING HOMELESSNESS, WE'RE ALL
8 WORKING ON, THAT BUT IT REALLY DEPENDS ON FUNDING FOR LOCAL
9 GOVERNMENTS TO DO IT. SO I DON'T KNOW MUCH MORE THAT WE CAN DO
10 UNLESS WE GET FUNDING AND THAT SHOULD PROBABLY BE A DISCUSSION
11 THAT WE HAVE OUTRIGHT BECAUSE IF WE DON'T HAVE THE MONEY I
12 DON'T SEE SEE -- HELP ME UNDERSTAND HOW WE CAN DO THAT BECAUSE
13 BECAUSE IT SEEMS LIKE THE MORE HOUSES WE BUILD. WE DON'T BUILD
14 THEM, BUT THE MORE HOUSES THAT WE AUTHORIZE -- HOW CAN WE
15 AFFORD -- INCREASE AFFORD THISBILITY? HOW ARE WE GOING TO DO
16 THAT OTHER THAN WHAT WE'RE ALREADY DOING?

17

18 **SPEAKER:** WE'RE REALLY TRYING TO LOOK MORE DEEPLY AT OUR
19 STRATEGIES AND THE LITERATURE AND EVIDENCE THAT IS OUT THERE
20 TO SUPPORT THE EFFICACY. THERE IS A LOT THAT HAS BEEN LEARNED
21 OUT THERE AT THE LOCAL LEVEL, AT STATE LEVEL IN TERMS OF
22 RESEARCH AND EFFECTS OF DIFFERENT TYPES OF POLICIES AND WE
23 REALLY WANT TO SEE WHAT WE CAN LEARN FROM PROGRESS THAT MAY
24 HAVE BEEN MADE IN PLACES BEYOND THE BAY AREA AND POTENTIALLY
25 BEYOND CALIFORNIA, SPECIFICALLY WITH RESPECT TO COST

1 REDUCTION, THIS IS SOMETHING THAT WE INVESTIGATED IN PLAN BAY
2 AREA 2050 PLUS, WHICH ARE WHAT ARE SOME PROMISING APPROACHES
3 TO ACTUALLY REDUCE COSTS IN TERMS OF DEVELOPING AFFORDABLE
4 HOUSING IN PARTICULAR? AND THAT IS WORK THAT WE ARE LOOKING TO
5 FURTHER EXPAND UPON IN THIS NEXT UPDATE OF THE PLAN AS WELL.
6 BUT, YOU KNOW, TO ACKNOWLEDGE YOUR POINT, IT'S A VERY HARD
7 PROBLEM. IT'S A DIFFICULT PROBLEM THAT, YOU KNOW, WE STRUGGLE
8 WITH AS A REGION, AS A STATE, AND, YOU KNOW, AS A NATION, IN
9 FACT. AND REALLY JUST TRYING TO FIND THE MOST PROMISING
10 APPROACHES SO THAT WE CAN IDENTIFY PRIORITIES AND APPROACHES
11 THAT COULD BE PROMISING TO IMPLEMENT AT THE LOCAL LEVEL

13 **PAT EKLUND:** YOU KNOW, WHEN I LOOK AT COST OF HOUSING NOW, I
14 WOULDN'T BE ABLE TO AFFORD IT. AND I THINK EACH ONE OF US CAN
15 PROBABLY SAY THAT AS WELL. AND SO WITHOUT CHANGING THE QUALITY
16 OF THE LIFE, WHICH IS A SMALLER UNIT OR WHATEVER. BUT I THINK
17 WE NEED TO MAYBE EVEN TALK WITH SOME OTHER ORGANIZATIONS OR
18 STATES OR WHATEVER WHAT IS POSSIBLE AND ARE WE JUST TRYING TO
19 DO IT AROUND THE EDGES WHICH MIGHT HELP AT BIT? BUT I'M A
20 LITTLE CONCERN CHANGED ABOUT AND THE FUTURE, BECAUSE, YOU
21 KNOW, IF I HAD KIDS, THEY PROBABLY WOULDN'T BE ABLE TO AFFORD
22 TO EVEN BUY A CONDO, FOR THAT MATTER. SO THE OTHER QUESTION I
23 HAD IS ALSO ON PAGE 10, AND THAT'S THE REVISED LAND USE
24 FRAMEWORK TO STRENGTHEN RESILIENCE. TO -- ARE YOU INTENDING TO
25 -- I ALSO SERVE ON THE CONSERVATION DEVELOPMENT COMMISSION.

21 **MARILYN EZZY ASHCRAFT:** THANK YOU. THANK YOU FOR THIS REPORT.
22 IT IS VERY INTERESTING AND INSIGHTFUL AND I'LL LOOK TO THE
23 FUTURE. MY SUGGESTION OR ASK IS THAT WE FIND A WAY TO ELEVATE

12 NEAR-TERM PRIORITIZATION. CAN YOU CLARIFY TO WHAT EXTENT THIS
13 PLAN WILL CONTINUE TO BE ASPIRATIONAL OR MOVE TOWARDS

20 COMMISSION AND BOARD TO, YOU KNOW, DIRECT US WHERE TO GO. I
21 THINK WE'VE IDENTIFIED A VARIETY OF DIFFERENT ASPECTS OF THE
22 PLAN WHERE WE COULD ADJUST COURSE, YOU KNOW, WHETHER THAT'S
23 THINKING ABOUT THE FINANCIAL, FISCAL ENVELOPES OR

12 AGGRESSIVE STRETCH GOALS. SO, YOU KNOW, YOU HAVE A SPECTRUM
13 FROM CONSERVATIVE PLANS TO REALISTIC TO STRETCH TO
14 ASPIRATIONAL, WHICH I'D CALL UNREALISTIC. AND SO I'M LOOKING
15 FOR AGGRESSIVE REALISTIC GOALS, IS WHAT I'M -- I'LL BE

13 OUT, YOU KNOW, WHETHER THERE'S STRETCH GOALS OR WHETHER

15 **SPEAKER:** IMMIGRATION IS DEFINITELY ONE OF THE FACTORS THAT WE
16 HAVE TO LOOK AT BECAUSE I THINK, AS YOU'RE AWARE, WE DO A
17 REGIONAL GROWTH FORECAST FOR THE REGION THAT COMES UP WITH A
18 POPULATION AND JOBS FORECAST FOR THE REGION. SO IMMIGRATION IS
19 DEFINITELY A COMPONENT OF THAT. I THINK AS WE GO THROUGH THE

16 RENTAL CAP, WHICH IS GOING TO EXPIRE, SO BEFORE WE JUMP AHEAD
17 HERE I HOPE WE ARE LOOKING CLOSELY AT THE DATA TO SEE WHAT IS

11 THE IMPLEMENTATION IS THE BIG PIECE, HOW WE FINANCE AND GET
12 LEGISLATION AND CONSISTENCY WITH STATE AND FEDERAL MOLS
13 POLICIES. AND I WANT TO OBSERVE . IF WE'RE LUCKY DURING THIS
14 PLANNING PROCESS WE WILL COME OUT OF A FEDERAL POLICY POSITION

19 THINK THAT HAS TO BE BAKED INTO OUR PLANNING AS WELL. AND I
20 SERVED WITH COMMISSIONER EKLUND AND ASHCRAFT AND A NUMBER OF
21 OTHERS ALSO ON BCDC. AND SO I'M JUST CURIOUS TO HEAR A LITTLE
22 MORE ABOUT WHO OUR MTC STAFF IS WORKING ON THAT AND HOW THAT
23 EXOAN LENT WORK BECAUSE THAT WILL COME ON AS A BIG WAY SO IF
24 YOU COULD JUST SAY A LITTLE BIT MORE ABOUT WHAT'S INTENDED
25 THERE IF YOU KNOW SUPERVISOR JUST TO ZOOM OUT FOR A MOMENT, WE

4 2050 WHERE WE FIRST INTRODUCED SEA LEVEL RISE, A SEA-LEVEL

23 EVALUATION. AND NOW I'M OFFICIAL. NEXT SLIDE. SO JUST A LITTLE
24 BIT OF LEVEL-SETTING FOR THOSE WHO MAY NOT KNOW BUT I'M SURE
25 ALL OF YOU ALREADY DO. WHAT ARE EQUITY PRIORITY-BASED

1 COMMUNITIES? THEY'RE PLACE-BASED DESIGNATIONS DEFINED AT THE
2 CENSUS TRACT LEVEL AND WE DEVELOP THEM TO OFF SOCIALLY AND
3 ECONOMICALLY DISADVANTAGED POPULATIONS. THEY WERE PREVIOUSLY
4 KNOWN AS COMMUNITIES OF CONCERN UP UNTIL 2021. WE UPDATE THEM
5 EVERY FOUR YEARS USING THE LATEST AMERICAN COMMUNITY SURVEY
6 DATA AND THE METHODOLOGY THAT IDENTIFIES EPCS WAS LAST REVISED
7 OVER A DECADE AGO IN 2016. TO THE RIGHT WE HAVE AN IMAGE FROM
8 BAY AREA 2050 PLUS OF THE LATEST EQUITY-PRIORITY COMMUNITIES
9 ACROSS THE REGION. NEXT SLIDE. SO I'M SURE IT'S OF NO SURPRISE
10 TO THIS COMMISSION, BUT UNFORTUNATELY EQUITY-PRIORITY
11 COMMUNITIES CONTINUE TO EXPERIENCE DISPARITIES ACROSS ALL OF
12 MTC AND ABAG'S CORE WORK AREAS WHETHER THIS IS THE
13 ENVIRONMENT, TRANSPORTATION, HOUSING AFFORDABILITY, THE
14 ECONOMY. THIS IS A TOOL TO HELP RECTIFY THOSE. NEXT SLIDE. SO
15 A LITTLE BIT MORE ABOUT THE METHODOLOGY AND EXACTLY HOW EPCS
16 ARE DEFINED. THEY, AGAIN, ARE CENSUS TRACTS THAT HAVE A
17 SIGNIFICANT CONCENTRATION OF SPECIFIC DISADVANTAGED FACTORS.
18 THOSE FACTORS ARE ON THE RIGHT. WE LOOK AT POPULATIONS OF LOW
19 INCOME, PEOPLE OF COLOR, PEOPLE WITH DISABILITIES, LIMITED
20 ENGLISH PROFICIENCY, ZERO-VEHICLE HOUSEHOLDS, SENIORS 75 YEARS
21 AND OVER, SINGLE-PARENT FAMILIES AND SEVERELY RENT-BURDENED
22 HOUSEHOLDS. WE THEN FOR EACH OF THESE FACTORS SET A THRESHOLD
23 TO DETERMINE STATISTICAL SIGNIFICANCE FOR EACH FACTOR BASED ON
24 A REGIONAL AVERAGE. AFTER THAT, WE ATTRACT AND QUALIFY IN TWO
25 WAYS. ONE IT MEETS THE THRESHOLD FOR BOTH LOW INCOME AND

1 PEOPLE OF COLOR OR IT MEETS THE THRESHOLD FOR LOW INCOME AND
2 THREE OF ANY OF THE REMAINING FACTORS. NEXT SLIDE. SO MTC AND
3 ABAG USE EPCS FOR A LOT OF DIFFERENT THINGS IN PLANNING,
4 FUNDING, IMPLEMENTATION. ON THE PLANNING SIDE OF THE HOUSE, WE
5 USE THEM AS A BIG PART OF PLAN BAY AREA WHETHER THAT'S
6 ENGAGEMENT OR REFINING OUR STRATEGY FOCUS. THEY'RE USED IN
7 VARIOUS EQUITY STRENGTHS ACROSS THE AGENCY LIKE THE BAY TRAIL
8 EQUITY STRATEGY AND OUR COMMUNITY-BASE TRANSPORTATION PLANS.
9 THEY PLAY A BIG ROLE IN A MAJORITY OF OUR FUNDING PROGRAMS,
10 WHETHER IT'S A FUNDING CRITERIA OR THERE'S SOME SORT OF
11 NARRATIVE DESCRIPTION OF HOW THE PROJECT WILL AFFECT EQUITY
12 ACROSS ALL OF OUR FUNDING PROGRAMS. THEN AS FAR AS
13 IMPLEMENTATION, IT'S PRETTY INTERESTING, I'M LEARNING ABOUT
14 NEW WAYS WE USE THEM IN THIS SIDE OF THE HOUSE, BUT THEY HELP
15 DETERMINE BAY WHEELS DOCK LOCATIONS WHERE WE HAVE CLIPPER
16 RETAIL LOCATIONS AND WHERE WE HAVE OUR CHARGING PROGRAMS, ET
17 CETERA. IT'S QUITE INTERESTING AND FAST. NEXT SLIDE. AND A LOT
18 OF PEOPLE THINK EQUITY PRIORITY COMMUNITIES ARE NEW. WE'VE
19 ACTUALLY BEEN USING SOME VERSION OF THEM FOR QUITE A WHILE. SO
20 HERE I HAVE THE EVOLUTION OF EPCS. SINCE 1999, WE'VE BEEN
21 USING THEM IN OUR RTP, YOU KNOW, LOOKING AT EQUITY ANALYSIS
22 FOR LOW INCOME POPULATIONS AND POPULATIONS OF COLOR. SO FOR A
23 WHILE. AND THEN IN 2007, THE AGENCY ACTUALLY ADOPTED ITS OWN
24 SET OF ENVIRONMENTAL JUSTICE PRINCIPLES DIRECTING STAFF TO
25 ANALYZE IMPACTS ON LOW INCOME COMMUNITIES OF COLOR THROUGHOUT

1 ALL OF ITS PROJECTS. IN 2009 WE HAD THE OFFICIAL COMMUNITIES
2 OF CONCERNED FRAMEWORK BEING INTRODUCED. IN 2013, THAT
3 EXPANDED TO LOOK NOT ONLY AT LOW INCOME AND MINORITY
4 POPULATIONS BUT THOSE EIGHT FACTORS I MENTIONED EARLIER. WE
5 THEN FORMALLY ADOPTED THIS PROCESS AS PART OF PLAN BAY AREA
6 2040. AS PART OF PLAN BAY AREA 2050, THE REGIONAL WORKING
7 EQUITY GROUP INVOLVED IN THAT PROCESS DIRECTED US TO RENAME
8 THE COMMUNITIES OF CONCERN TO EQUITY PRIORITY COMMUNITIES AND
9 THAT HAS BEEN DONE, BUT THEY ALSO RECOMMENDED AS TO REVISIT
10 THE EQUITY PRIORITY COMMUNITY FRAMEWORK, AND THAT'S WHAT WE'RE
11 DOING NOW IN 2026. NEXT SLIDE. SO WHY UPDATE THE EPC FRAMEWORK
12 NOW? OVER TIME, THE EPC FRAMEWORK HAS BEEN SHAPED BY EVOLVING
13 FEDERAL, STATE, AND AGENCY-LEVEL POLICIES, AND AT THE SAME
14 TIME, THE BAY AREA'S DEMOGRAPHICS HAVE SHIFTED VASTLY. WE HAVE
15 NOT LOOKED AT THIS POST PANDEMIC. THAT'S A VERY IMPORTANT
16 CONSIDERATION. AND THERE'S JUST BEEN NEW CHALLENGES. SO WE ARE
17 NOT STARTING FROM SCRATCH. WE HAVE HAD FEEDBACK ON THE EPCS AS
18 LONG AS THEY HAVE EXISTED. SO SOME KEY QUESTIONS THAT WE'RE
19 GOING INTO THIS WITH ARE, HOW CAN THE EPC TOOL PROVIDE CLEAR
20 DEFINITIONS AROUND DISPLACEMENT AND GENTRIFICATION IMPACTS?
21 AND WHAT WAYS CAN THE EPC TOOL BETTER REPRESENT PEOPLE WITH
22 DISABILITIES? WE KNOW THAT FOLKS WITH DISABILITIES AND SENIORS
23 ARE NOT GEOGRAPHICALLY CONCENTRATED. THEY ARE LOCATED ALL OVER
24 OUR REGION. HOW ACCOUNT EPC TOOL UPDATE OUR LOW INCOME THEY
25 ARE HOLDS? RIGHT NOW WE LOOK AT 200% OF THE FEDERAL POVERTY

1 LEVEL. WE KNOW THAT IS VERY LOW. SO HOW CAN WE MORE ACCURATELY

13 ANALYSES SO WE KNOW A LOT IS RIDING ON THIS UPDATE AND WANT TO
14 SUPPORT MORE PLAN-BASED DECISION-MAKING. SO THE EPC REFRESH
15 CONSISTS OF TWO PHASES. PHASE I IS ABOUT LISTENING AND
16 LEARNING AND STARTING TO ANALYZE WHAT WE HAVE TO WORK WITH. IN
17 PHASE 1A, WE HAVE OUR LISTENING SESSIONS. WE'VE STARTED WITH
18 INTERNAL LISTENING SESSIONS GOING ACROSS THE AGENCY JUST TO
19 FIGURE OUT EXACTLY HOW FOLKS ARE USING THEM, WHAT'S WORK,
20 WHAT'S NOT WORKING, WHERE OUR OPPORTUNITY -- ARE OPPORTUNITIES
21 TO GROW? WE'RE WRAPPING THAT UP RIGHT NOW. WE'VE LEARNED SO
22 MUCH. IT'S GOTTEN ME SO EXCITED TO DO THIS WORK. AND I'M EVEN
23 MORE EXCITED TO GO EXTRA IN OUR NEXT PHASE. YOU'VE BEEN
24 PROVIDED WITH A STAKEHOLDER LIST OF OVER 100 DIFFERENT
25 STAKEHOLDERS. THAT LIST CAN GROW AND EXPAND AS WE LEARN. WE'LL

1 BE TALKING TO THEM. AND THEN THE LAST PHASE, PHASE 1B WILL BE

21 SINCE THE EPC HAS BEEN INVENTED. THERE'S A LOT TO LEARN.
22 PEOPLE HAVE DONE A LOT OF EVALUATIONS AND WE WANT TO HEAR FROM
23 THEM. TACHT B HAS A MORE EXPANSIVE LIST OF THOSE STAKEHOLDERS.
24 NEXT STEPS WE ARE PREPARING AN RFP TO PROCURE CONSULTANT
25 SUPPORT TO DO THAT INITIALIZATION AND WHERE WE CAN GO WITH
