**Background:** In January 2021, MTC and ABAG approved the Plan Bay Area 2050 Final

Blueprint as the Preferred Environmental Impact Report (EIR) Alternative. Since then, MTC/ABAG staff have been developing the Draft Plan Document, the Draft Implementation Plan, and corresponding supplemental reports. Furthermore, environmental analysis has been ongoing from fall 2020 through spring 2021, with scoping comments used to inform the Draft EIR and to craft a "reasonable"

range" of alternatives.

**Draft Plan Release:** Staff envisions releasing the Draft Plan Document, Draft Implementation Plan,

Draft EIR, and supplemental reports in the coming weeks, with briefings provided

to all relevant MTC/ABAG committees, the Commission, and the ABAG

Executive Board in June. Currently, the Draft Plan Document, Draft

Implementation Plan, and supplemental reports are slated for release on or around

the week of May 24th. The Draft EIR will be released soon thereafter, on or

around the week of May 31st.

Next Steps: MTC/ABAG staff will kick off the final phase of Plan Bay Area 2050 public

engagement in mid-June with public workshops and public hearings, which will continue to occur virtually given the evolving public health situation. Staff will also present the Draft Plan Document, including the Bay Area's sustainable communities strategy, to elected officials at County Transportation Agency board meetings in May and June, fulfilling an SB 375 engagement requirement. The

public comment period, as established by state law and MTC's Public

Participation Plan, will stretch through mid-July. After the conclusion of the public comment period, staff will report back to the Joint MTC Planning/ABAG Administrative Committee in August and make revisions as appropriate based on feedback received. Plan Bay Area 2050 remains on track for the Commission and

ABAG Executive Board to jointly consider for adoption this fall.

**Communities of Concern: Reconsidering Our Language** 

**Subject:**

**Background:** 

The "Communities of Concern" framework has been in use by MTC and ABAG since 2001 to identify communities with significant concentrations of historically underserved populations, primarily people of color and people with low incomes. Staff has made continual updates to the definition, the demographic factors considered and the methodology over the last two decades. For Plan Bay Area 2050, staff employed the same framework adopted by MTC and ABAG during Plan Bay Area 2040, with updates to the underlying demographic data using best available information from the U.S. Census Bureau. This adopted framework is shown in **Table 1**.

Table 1. Communities of Concern Framework for Plan Bay Area 2050

Demographic Factor	% Regional Population	Concentration Threshold
1. People of Color	60%	70%
2. Low Income (<200% Federal Poverty Level)	21%	28%
3. Limited English Proficiency	8%	12%
4. Zero-Vehicle Household	9%	15%
5. Seniors 75 Years and Over	6%	8%
6. People with Disability	10%	12%
7. Single-Parent Family	13%	18%
8. Severely Rent-Burdened Household	10%	14%

Definition – census tracts that have a concentration of BOTH people of color AND low-income households, OR that have a concentration of 4 or more factors, above the listed thresholds

The Communities of Concern designations are used widely at MTC and ABAG, as well as by county and city agencies within the Bay Area. They are used in planning efforts and equity analyses, prioritization criteria in programming of funds (e.g. Community-Based Transportation Plan Planning Grants, Active Transportation Program), and alignment of resources for public engagement.

Nomenclature **Update:** 

The year 2020 was an opportunity for reckoning in our region and beyond. Acknowledging the power of language and that words can shape people, actions and culture, staff began reconsidering the nomenclature "Communities of Concern" in mid-2020. Staff embarked on an inclusive process to identify new nomenclature by engaging with underserved communities, the Policy Advisory Council's Equity & Access Subcommittee and the Regional Equity Working Group.

Despite this being an abstract topic to discuss, the small group discussions with underserved communities were rich and offered diverse feedback. The discussions began with an open-ended question: "what does the term *Communities of Concern* mean to you?" Staff then provided more context on the definition and use of these designation by MTC/ABAG and our partners, and highlighted why these designations are important given historical context. Staff then sought opinions on the overall framework itself and the nomenclature by providing a variety of new options, including:

- Equity Priority Communities, Equity Focus Communities, Equity Priority Neighborhoods, and Equity Action Areas
- Underserved Communities, Equity Prioritized Investment Communities, Opportunity Zones, and Historically Marginalized Communities
- Economically Distressed Areas, Disadvantaged Communities and Environmental Justice Communities

Staff will share synthesized feedback and a recommendation for new terminology, included in **Attachment A**. In summary, reactions to the existing terminology were almost unanimously adverse. To many, the term "Communities of Concern" is problematic, triggering, demeaning, negative, vague and passive. Recurring feedback themes for a new term were that the term needs to be positive, empowering and uplifting, be forward-looking and action-oriented, communicate "priority" and intentionality and be short and easily understood. Based on the feedback received, staff is recommending the term "Equity Priority Communities" to describe these places going forward.

This small but meaningful change can communicate to the region at large that MTC and ABAG intend to prioritize these historically underserved and under-represented communities to advance toward equitable outcomes. Staff acknowledges that there is much work to be done beyond simply changing the nomenclature in the years ahead, and that there must be concerted ongoing effort toward truly achieving the equitable outcomes.

**Next Steps:** 

Staff envisions updating the Community of Concern nomenclature with the new term "Equity Priority Communities" across work products, including the upcoming Plan Bay Area 2050. Furthermore, if approved, staff will share this update with other agencies across the region that frequently use this framework. Beyond the nomenclature, defining and measuring equity-focused populations is a continuous ongoing effort as part of the MTC-ABAG Equity Platform. While a broad reexamination of the existing framework was not possible during the Plan Bay Area 2050 timeline due to resource constraints, staff is looking to refresh the framework and methodology, starting next year in advance of the next long-range planning cycle.

**Recommendation:** 

Staff recommends the MTC Planning Committee and ABAG Administrative Committee approve the renaming of "Communities of Concern" as "Equity Priority Communities" for use across all MTC and ABAG work products and projects.



Communities of Concern are designated geographies (census tracts) that have high concentrations of underserved populations. Designations are based on calculated thresholds for 8 demographic factors, including race and income.


Communities of Concern are updated every plan cycle with most recent census demographic data, in this case in 2020.

- "Communities are continuously changing, so term should not feel stagnant"
- Term should "not be too long", but should be "clear and understood across audiences"

### Clipper® Launches on iPhone and Apple Watch, Debuts New Mobile App

On April 15, MTC launched the Clipper regional transit-fare payment card on iPhone and Apple Watch, and released a mobile app for easier management of Clipper cards.

Clipper on iPhone and Apple Watch gives riders on 24 Bay Area transit systems a new, contactless way to pay fares on buses, trains and ferries. Adding a Clipper card to iPhone or Apple Watch is easy. Customers can add the card directly through Apple Wallet and load cash value with Apple Pay anytime, anywhere. Riders also can transfer the value from a plastic Clipper card to their iPhone. Clipper will be coming to Google Pay in May.

The launch makes paying for and riding public transit easier and safer because Clipper on iPhone and Apple Watch works with Express Mode, which allows riders to quickly tag and pay for rides without having to use Face ID, Touch ID, wake or unlock their device, or open an app. Riders can simply hold their iPhone or their Apple Watch near the Clipper reader and then board the bus, train or ferry. They no longer need to touch a ticket vending machine or reload a Clipper card at a retailer.

The new Clipper mobile app, available on iPhone, allows riders to easily manage their Clipper cards and their Clipper account, and to plan transit trips around the Bay Area. Riders must use the Clipper app to buy transit agency passes for use on iPhone or Apple Watch.

"This new fare payment method works on all 24 Bay Area transit services that accept Clipper," said MTC Executive Director Therese McMillan. "Riders can easily add cash value from Apple Pay and just tag and ride. It couldn't be more user-friendly, not to mention timely. We're looking forward to offering the same convenience soon with Google Pay."

Transit riders who are enrolled in the Clipper START program and those who use cash to load their Clipper cards also can use the Clipper app, but cash payers will need to use a BART, Golden Gate Ferry, or SMART ticket machine or select Caltrain ticket machines to add value to iPhone or Apple Watch. MTC has been working with Apple and Cubic Transportation Systems, the Bay Area's fare payment solutions partner, to introduce these convenient new payment and account management features. ### Bay Area Bike to Wherever Days Are Coming in May

Bicycling has never been more popular across the region and May brings the return of Bike Month and the Bay Area's "Bike to Wherever Days" (BTWD) as an alternative to the annual Bay Area Bike to Work Day event.

During the pandemic, bicycling for personal wellness, exercise and recreation has seen a pronounced rise in popularity. Social distancing protocols and safer streets have resulted in many people riding for the first time and veteran riders getting back on their bicycles. This year's Bay Area BTWDs will reflect the renewed enthusiasm for bicycling around the region.

In an effort to further encourage people to pedal, the entire month of May has been designated as Bay Area "Bike to Wherever Days" with May 21 being National Bike to Wherever Day.

Each of the nine Bay Area county bike coalitions will offer classes, activities, education and more to help cyclists pedal safely, while building communities, finding new routes and using bicycles as a means of transportation. The counties' traditional Bay Area Bike Commuter of the Year (BCOY) Award has been retooled to recognize each county's Bike Champion of the Year. Bay Area counties have creatively pivoted their programming to accommodate the surge in interest in riding with many of these programs being accessible online. Bay Area Bike to Wherever Days is presented by MTC and 511, the region's traveler information system. BTWD 2021 also receives regional support from the Bay Area Air Quality Management District and Bay Area Rapid Transit, as well as from many sponsors at the local level. Prizes for the Bike Champion of the Year winners were donated by the Association of Bay Area Governments (ABAG), Bay Area Air Quality Management District, Better World Club and Mike's Bikes.

### MTC Mourns Loss of Dr. Martin Wachs, Transportation Giant

Dr. Martin Wachs — a giant in the field of transportation, who authored several books, wrote hundreds of articles and taught thousands on the subject — died April 11, 2021. He was 79.

Dr. Wachs was a Distinguished Professor Emeritus of Civil & Environmental Engineering and of City & Regional Planning at the University of California, Berkeley, where he directed the Institute of Transportation Studies. Earlier, he spent 25 years at the University of California, Los Angeles, where he was Chairman of the Department of Urban Planning for 11 of those years. After leaving the university in 1996, Dr. Wachs became the Director of the Transportation, Space, and Technology Program at the RAND Corporation in Santa Monica. In semi-retirement, Dr. Wachs taught courses and conducted research at UCLA in transportation policy, worked on transportation policy projects at RAND and served as a policy expert.

MTC Executive Director Therese McMillan was a longtime friend and called Dr. Wachs a mentor.

"With the passing of Dr. Martin Wachs, the transportation community — and the human community — lost both a giant, and a kind and caring heart," McMillan said. "I got to know 'Marty' as a young professional, during his time at UC Berkeley heading up the Institute of Transportation Studies, and teaching at the College of Environmental Design, my alma mater. And while I didn't have the privilege of sitting in his classroom, I had the joy of being his student nonetheless — with his commitment to advancing young talent, and especially women at a time we were still trying to shoulder our way to equitable standing in the field."

McMillan said Dr. Wachs' legacy is immense.

"Marty's accomplishments are too numerous to articulate, but his greatest was his ability to communicate, listen and share — even in difficult moments," she said. "His stamp on countless individuals as mentor and friend will stand equally strong — I like to think more so — alongside his prodigious research contributions. He will be missed, but forever remembered with deepest gratitude."

Before landing at UCLA in 1971, Dr. Wachs received a Ph.D. in Civil Engineering (Urban and Regional Planning) from Northwestern University in 1967, an M.S. in Civil Engineering (Urban and Regional Planning) from Northwestern University in 1965 and a B.C.E. in Civil Engineering from City University of New York in 1963. Dr. Wachs also wrote four books and 180 articles on subjects related to relationships between transportation, land use, and air quality; transportation systems; and the use of performance measurement in transportation planning. His research addressed issues of equity in transportation policy, problems of crime in public transit systems, and the response of transportation systems to natural disasters, including earthquakes. His other areas of interest included professional ethics, transportation and aging, transportation and land use, transportation and the environment, transportation finance, and urban transportation planning.

Dr. Wachs was a recipient of a Guggenheim Fellowship, two Rockefeller Foundation Humanities Fellowships, a UCLA Alumni Association Distinguished Teaching Award, the Pyke Johnson Award for the best paper presented at an annual meeting of the Transportation Research Board (TRB), and the Carey Award for service to the TRB. Recently, he was a member of the Advisory Committee on Research and Development for the California Department of Transportation and completed his term as the first Chair of the Advisory Panel for the Travel Model Improvement Program of the U.S. Department of Transportation.

#### **Items of Note:**

CTF Awards: The California Transportation Foundation this month named BATA as its Organization of the Year for 2020. The award will be presented at a virtual CTF Transportation Awards ceremony on Thursday, May 27 from 12 to 1:30 p.m. The CTF chose BATA for this prestigious award because of its effective partnership with Caltrans and with FasTrak contractor Conduent Inc. to transition the region's seven state-owned toll bridges to all-electronic tolling in March 2020. What originally was planned to be a gradual, years-long transition was forced by COVID-19 to take place on just about 48 hours' notice. BATA first adapted its existing toll violation system to begin issuing no-penalty toll notices to customers who did not already have FasTrak accounts, while also beginning an all-out sprint to design, install, test and implement a genuine all-electronic tolling system.

Equity Panel: San Diego Association of Governments (SANDAG) Board of Directors Meeting On Friday, April 23, 2021, I was invited to participate with other equity leaders in a discussion before the Board of SANDAG. While I have often been invited to speak on this topic and the work that we are doing here in the San Francisco Bay Area, this opportunity is worthy of note as it was timed with SANDAG's efforts to finalize their long range plan, with a focus on equity. The conversation was insightful in many respects, including questions from the Board. In short, our collective regional commitments to equity are needed and challenging.
