Subject:	Contract – Motorist Aid System Support: TeleTran Tek Services, Inc. (TeleTran Tek).
Background:	Since 1992, MTC SAFE has employed a Motorist Aid System Support Consultant to provide motorist aid system support in the form of data collection and analysis for the Call Box Program and the Freeway Service Patrol (FSP). For the Call Box Program, the operational data collected includes monthly call box answering statistics, maintenance repairs and service occurrences, and cellular service activities. For FSP, this consultant collects data on number and type of assists and tow truck drivers' performance. The data is used to determine the quality of service being provided by the various partners and contractors in both programs and address deficiencies.
	MTC SAFE's contract with the current consultant, TeleTran Tek, is due to expire on June 30, 2021. Thus, a request for proposal (RFP) was released in March to retain a consultant to continue providing such data for both the Call Box Program and FSP. The resulting contract would be for a five-year term.
	MTC SAFE received one responsive proposal from TeleTran Tek and this firm was rated based on the following three evaluation criteria: qualifications and experience of firm/personnel (40%), work plan (35%), and cost effectiveness (25%). Due to the technical nature of this data and the intensive data processing required, it is important that these services be contracted to a qualified technical consultant.
	Based on the proposal evaluation of the proposer, the evaluation panel comprised of MTC SAFE staff found that TeleTran Tek's proposed cost of \$100,000 per FY is an acceptable contract price, and their familiarity with the program provides reliability and expertise in data extraction. They have extensive experience with intensive data processing and reporting for Call Box and FSP Programs in the state and have pre-existing relationships with our programs' data sources including Caltrans and California Highway Patrol (CHP). TeleTran Tek is neither a small business nor a disadvantaged business enterprise and has no subcontractors.
Issues:	None identified.
Recommendation:	Staff recommends that the Operations Committee authorize the Executive Director or designee to negotiate and enter into a contract with TeleTran Tek Services, Inc. for the period of July 1, 2021 through June 30, 2026 in the amount not to exceed \$500,000, subject to the annual agency budget approval.

Background:	Since 2002, MTC SAFE has provided funding to the Santa Cruz County Regional Transportation Commission (SCCRTC) for additional California Highway Patrol (CHP) enforcement along Highway 17 in order to reduce traffic incidents, injuries and fatalities. The funding provided by MTC SAFE is used for CHP enforcement on the Santa Clara County side of Highway 17. SCCRTC pays for enforcement on the Santa Cruz County side of SR-17 and oversees the program. Since its inception, the "Safe on 17" Program has produced an almost 50 percent reduction in annual fatality and injury collisions. The current agreement with SCCRTC for "Safe on 17" service was entered into on July 1, 2018 and expires on June 30, 2021. Due to the proven benefits of this program, staff is requesting that the Committee authorize continued funding for the "Safe on 17" program for an additional three-year period (through June 30, 2024) in the amount of \$50,000 per fiscal year beginning July 1, 2021, for a total of \$150,000.

Recommendation:	Staff recommends that the Operations Committee authorize the Executive Director or designee to negotiate and enter into a funding agreement amendment with Santa Cruz County Regional Transportation Commission in an amount not to exceed \$150,000 to provide additional CHP enforcement hours on Highway 17 through June30, 2024.

Subject:	MTC SAFE financial statements for the third quarter ending March 31, 2021.
	MTC SAFE continues to operate well within budget expectations for FY 2020- 21. With 75% of the budget year passed, total revenue for MTC SAFE and Freeway Service Patrol (FSP) combined is approximately \$12.1 million, 57% of the \$21.1 million approved budget. Total expenses are approximately \$11.1million, excluding encumbered contracts, or 49% of the \$22.8 million approved budget. The operating surplus is approximately \$1.0 million as of March 2021 and shows as an operating reserve transfer in Attachment A: Third Quarter SAFE Financial Statements. Salary and benefit expense is at 73% of the adopted budget, which is slightly below the 75% budget target for three quarters of the fiscal year.
	General highlights include:
	<b>Freeway Assist Program</b> Total revenue is \$5.0 million or 78% of the approved budget. The additional revenue is the result of slightly higher vehicle registration fees. This revenue increased by 9% over the last quarter as shown in the Total DMV Revenue graph. DMV registration fees make up 99% of the total revenue for the program.
	Year-to-date Freeway Assist Program total operating expenses are approximately \$1.2 million or 43% of the adopted budget. Maintenance, inspection and telecommunication activities continue to be slow due to the pandemic. Activities are expected to rise until year end but not enough to fully incur all budgeted contract expenses.
	<b>(FSP Program</b> Total revenue is \$7.0 million or 48% of the approved budget while total expenses are \$9.5 million or 50% of the approved budget. The operating shortfall of \$2.5 million is covered by a budgeted transfer from the Callbox Program. Through March 2021, FSP has utilized \$2.4 million, or 57% of the budgeted transfer in of \$4.3 million.
	The majority of the FSP Program expenses are towing contracts. Actual year-to- date expense is \$8.8 million with a related encumbered balance of \$5.8 million. Combining actual expenditures and the remaining contract encumbrance will push year-end expenses to \$14.6 million, or 86% of the adopted budget. We should not fully incur all budgeted contract expenses as activities are not yet back to pre- pandemic level.
	Capital Programs

The total life-to-date budget for the Capital Program is \$13 million. As of the end of the third quarter of FY 2020-21, life-to-date expenses for those programs plus encumbrances total \$10.5 million.

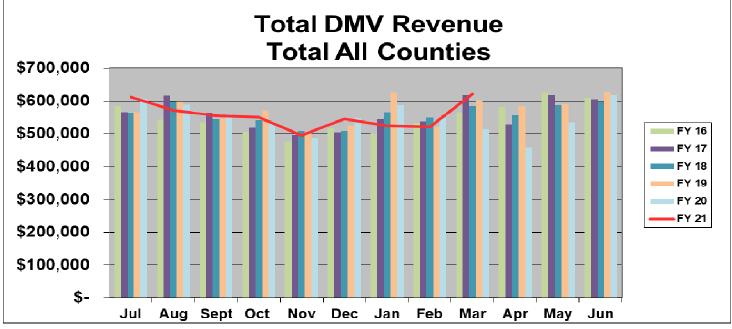

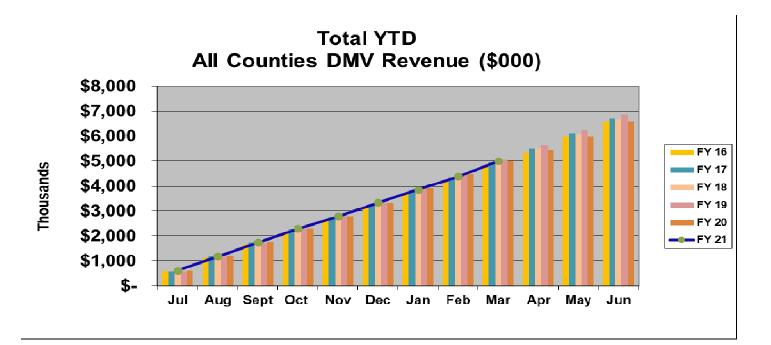

Subject:	Request for approval of a contract amendment to extend the IBI contract term to June 2023 and to add \$1,500,000 over FYs 2021-22 and 2022-23 to provide technical advice to MTC and the transit operators, support management of the next generation Clipper system integrator contract, oversee design and testing of the next generation Clipper system, support related Clipper system procurements, and provide additional consulting services as needed to support delivery of the next generation Clipper system.
Background:	<ul> <li>In 2015, MTC and the operators worked to develop a scope of work for a consultant to advise and help manage the procurement and implementation of the next generation Clipper system and, after a competitive procurement, awarded a contract for this work to IBI. The IBI contract scope includes support for: <ul> <li>System design;</li> <li>System development;</li> <li>Testing; and</li> <li>Transition to a new fare payment system and operations.</li> </ul> </li> </ul>
	The contract originally provided for a contract period through June 2020 with options to extend up to an additional 10 years and included support of one or more procurements for the new system. An amendment to the contract approved by this Committee in April 2019 extended the contract period to June 30, 2021, and added \$4M to the contract for IBI's support through that period. Given MTC's strategy of awarding task-based scopes of work priced on a not-to-exceed basis, MTC has been able to manage IBI's contract such that these allocated funds will last beyond June 30, 2021. As a result, MTC recently executed another amendment that extended the term of the contract with IBI to June 30, 2022, without adding additional funds.
	The initial IBI contract term was set to allow MTC and the transit operators the opportunity to re-evaluate Clipper next-generation technical advisor needs at key points (at completion of the system integrator procurement, and after system implementation) so that we could develop another technical advisor support strategy if the work of IBI was deemed unsatisfactory. MTC and transit operator staff have been satisfied with IBI's work to date, as exemplified by IBI's quality work on the Clipper Customer Service Center procurement over the past year.
	The proposed contract amendment would add another year to IBI's contract period, extending it to June 30, 2023, and would add \$1.5 million for IBI's support through that date. These funds are expected to be needed for work

support through that date. These funds are expected to be needed for work subsequent to October 2021, as current funds in the contract are sufficient to fund IBI's work until then.

Specific tasks supported by the addition of the \$1.5 million would include but are not limited to overall program management support through the contract term, advisory services related to the next generation Clipper system implementation, system installation, transition, operations and maintenance oversight and management, and account-based equipment installation support. Attachment A includes a summary of IBI and its project team's small business and disadvantaged business enterprise status. This contract amendment is contemplated and included in the Two-Year Clipper Budget and Work Plan. The Clipper Executive Board approved this proposed contract action at its May 17, 2021 meeting. For 28 years, MTC has been administering the PASS or similar service to provide technical assistance to Bay Area agencies, cities and counties to re-time traffic signals to improve traffic operations.			
	i. PASS FY 2021-22 Cycle of Projects On March 3, 2021, MTC issued a PASS Call for Projects and subsequently received six (6) applications from local agencies that nominated one or more arterial corridors for signal timing technical assistance. Applications were received from jurisdictions in Alameda, Contra Costa, San Mateo, and Marin Counties. Staff evaluated each application against the following project evaluation criteria: 1) ability to meet PASS goals – improve travel time and travel time reliability, improve air quality, and improve safety for motorists, transit riders, pedestrians, and bicyclists; 2) project readiness; and 3) project management capacity.			
	Based on the evaluation, staff recommends approval of six (6) applications covering eleven (11) qualifying arterial corridors for the FY 2021-22 cycle, as identified in Attachment A.			
	ii. Contracts – PASS Technical Consultant Services: In March 2021, staff reviewed Statements of Qualifications (SOQs) submitted for the 2016 On-Call Transportation Planning and Engineering Services bench, Service Category E: Arterial Operations. Of the 10 pre-qualified firms, four (4) have consistently been selected on the basis of superior qualifications and experience with signal timing projects. These firms are: DKS Associates, Iteris, Inc., Kimley-Horn and Associates, Inc., and TJKM Transportation Consultants. However, due to the low number of PASS projects for this FY2021-22 cycle, staff recommends assigning the six projects to Kimley-Horn and Associates, Inc. and DKS Associates through a direct selection process. These two firms were selected based on prior experience working with the recommended grantee agencies and other factors, including project size.

Together, this partnership developed Resilient SR 37 to identify corridor-wide Improvements.
	In April 2020, after a competitive procurement, this Committee approved the selection of T.Y. Lin International because it demonstrated a stronger understanding of the needs of the project and identified comprehensive outreach strategies to users from disadvantaged communities. Under this proposed contract amendment, T.Y. Lin International would continue to provide technical assistance in the development of this DAA, including additional coordination meetings with the Environmental Technical Working Group (ETWG), the Stakeholder Work Group (SWG), and with Caltrans on the Planning and Environmental Linkages Study (PEL) for SR 37. Attachment A includes a summary of T.Y. Lin International and its project team's small business and disadvantaged business enterprise status.

	The SAFE budget, as proposed, will have a slight operating deficit of \$369,000, which will be covered from available reserves of approximately \$12.5 million at the end of FY 2019-20. Total operating revenue for the proposed FY 2021-22 SAFE Budget is \$21.4 million, up \$376,000, or 1.8%. Total operating expenses for the proposed FY 2021-22 Operating Budget are \$21.8 million, up approximately 1.8% from FY 2020-21. There are no new positions, however one position was shifted from another fund to support SAFE. The slightly higher expenses created the operating deficit, similar to FY 2020-21.					

#### **Operating Revenue**

SAFE is primarily funded through specialized revenue utilized to assist motorists on the local roads. The main sources of revenue are DMV Registration Fees as well as State Local Assistance and Senate Bill 1 (SB1). Major funding sources are listed below (in millions):

The SAFE funding sources combined are relatively stable with only a 1.8% differential between the FY 2020-21 and FY 2021-22 budgets, respectively.

#### **Operating Expense**

The proposed operating expenses for FY 2021-22 are \$21.8 million, up from \$21.4 million in FY 2020-21, less than 2%. Highlights include:

The SAFE Budget as proposed will continue the important program of assisting motorists and reducing congestion in the region.

#### **Capital Projects**

We propose to transfer \$1.5 million to capital projects. The two new projects are:

1)	Incident Management	\$1.0 million

The \$1.5 million transfer will bring the total capital programming to just over \$9 million.

#### **SAFE Operating Reserves**

The goal of all MTC operating funds is to maintain fully funded reserves as necessary to meet contractual and liquidity needs as well as economic uncertainties. At SAFE, the restricted reserves are set equal to six months of operating revenue.

The total SAFE designated reserve was just over \$12.5 million at the close of FY 2019-20.

The projection for FY 2021-22 is \$11.8 million with about \$10.6 million (50% of budgeted operating revenue) designated and restricted to cover the projected FY 2021-22 deficit, contractual and project budgets, as well as \$8.3 million designated as an operating reserve. The reserve balance, \$1.2 million (10%) is undesignated and available for further programming. However, no changes to the reserve designations are possible without future SAFE approval.
