Overview of MTC's CARE Program and Call for Projects Process.

Background:

In 2021, the Metropolitan Transportation Commission (MTC) adopted the Bay Area's most recent Regional Transportation Plan and Sustainable Communities Strategy (SCS), *Plan Bay Area 2050* (PBA 2050). PBA2050 outlines the region's plan, incorporating equity through careful consideration of investments and policies that affect historically and systemically marginalized, underserved and excluded groups, including people with low incomes, people with disabilities and communities of color. PBA 2050 identified strategy "T2 – support community-led transportation enhancements in Equity Priority Communities." Since 2005, the <u>Lifeline Transportation Program</u> (LTP) has programmed over \$300 million, and advanced 300+ projects identified in <u>Community Based Transportation Plans</u> (CBTP). Through lessons learned from the previous six cycles of LTP and the application of <u>MTC's Equity Platform</u>, LTP is being redesigned to address administrative fund source barriers to better align with community project needs while resourcing and centering community voice and power-building to strengthen community assets. This item, which was called "Community Choice" at the time, was presented to the Policy Advisory Council Equity and Access Subcommittee on November 30, 2022 and most recently to MTC's Transit Finance Working Group on July 5, 2023.

MTC's CARE Program

MTC's Community Action Resource and Empowerment (CARE) Program is a funding program to develop equity-based partnerships and provide resources to expand mobility access and opportunity to all communities while focusing on the underserved, overburdened, and MTC's Equity Priority Communities. The fund will award \$21 million in state (Regional Early Action Planning 2.0) and federal (One Bay Area Grant 3) funds starting in fiscal year 2023-2024. Below are key components of the Program:

- **Goal**: The goal of the program is to improve mobility and access to opportunity by advancing community-rooted initiatives identified in CBTPs.
- Investment Areas: The Program is envisioned to undertake three focus investment areas: participatory budgeting project implementation, technical assistance for project development, and community power-building and engagement. Community power building means advancing community-anchored approaches that ensure frontline communities have representation and power both at the policy-level and local investment decision-making.

• Purpose:

- O Project Implementation Strategy: The Program serves as providing a baseline source of funding to 1) implement high priority, neighborhood-level, community projects identified through a participatory budgeting process; 2) advance project development to increase readiness/competitiveness for additional funding sources.
- Community Power-Building and Engagement Strategy: In addition to these project implementation strategies, the Program seeks to invest in community power-building by 1) supplementing outreach and engagement conducted by community-based organizations, and 2) supporting community-based organizations and local governments with technical assistance/capacity building resources to advance community-based transportation initiatives.

In addition to coordinating with county transportation agencies and transit operators, MTC is exploring partnerships that address improving mobility and access to opportunity outcomes with the Bay Area Air Quality Management District and health and social service sectors.

Next Steps

As a first step prior to the "Call for Projects" process, CARE is releasing a "Call for Interest Survey." The survey can be accessed <u>here</u>. Bay Area public agencies, including cities, counties, transit agencies, and county transportation authorities (CTAs) are invited to submit project ideas.

MTC'S COMMUNITY ACTION RESOURCE AND EMPOWERMENT (CARE) PROGRAM GUIDE – Call for Interest Process

Background and Goals of MTC's CARE Program

In 2021, the Metropolitan Transportation Commission (MTC) adopted the Bay Area's most recent Regional Transportation Plan and Sustainable Communities Strategy (SCS), *Plan Bay Area 2050* (PBA 2050). PBA2050 outlines the region's plan, incorporating equity through careful consideration of investments and policies that affect historically and systemically marginalized, underserved and excluded groups, including people with low incomes, people with disabilities and communities of color. PBA 2050 identified strategy, "T2 – support community-led transportation enhancements in Equity Priority Communities." Since 2005, the Lifeline Transportation Program (LTP) has programmed over \$300 million, and advanced 300+ projects identified in Community Based Transportation Plans (CBTP). Through lessons learned from the previous six cycles of LTP and the application of MTC's Equity Platform, LTP is being redesigned to address administrative fund source barriers to better align with community project needs while resourcing and centering community voice and power-building to strengthen community assets.

This inaugural funding cycle includes \$21 million in federal (OBAG) and state (REAP 2.0) funds. Below are key components of the Program:

- **Goal**: The goal of the program is to improve mobility and access to opportunity by advancing community-rooted initiatives identified in CBTPs.
- **Investment Areas:** The Program is envisioned to undertake three focus investment areas: participatory budgeting project implementation, technical assistance for project development, community power-building and engagement.

• Purpose:

- O Project Implementation Strategy: The Program serves as providing a baseline source of funding to 1) implement high priority, neighborhood-level, community projects identified through a participatory budgeting process; 2) advance project development to increase readiness/competitiveness for additional funding sources.
- Community Power-Building and Engagement Strategy: In addition to these project implementation strategies, a key element to operationalizing equity is investing in community power-building by 1) supplementing outreach and engagement conducted by community rooted organizations, and 2) supporting these community organizations and local government with technical assistance/capacity building resources.

In addition to coordinating with County Transportation Agencies and transit operators, MTC is exploring partnerships that address improving mobility and access to opportunity outcomes with the Bay Area Air Quality Management District and health and social service sectors.

Submitting Project Ideas

MTC is interested in understanding the funding need and potential projects/programs in Community Based Transportation Plans (that would apply for these funds) under the following areas:

- Community power-building and engagement addressing transportation or both transportation and housing.
- Technical assistance needed for project development to advance and position projects for additional, competitive funding; and,
- Projects/concepts that are ready to be implemented that have undergone a
 participatory budgeting process (or similar).
- Technical assistance and capacity building for community-based organizations and local government to advance transportation, mobility, and transit-oriented communities.

Eligible proposers (see eligibility section below) are encouraged to submit ideas on a wide range of projects, concepts, or needs that will accelerate, expand, and improve mobility and access to opportunity. Project ideas should support community-based transportation projects that:

- Are developed through a collaborative, diverse, and inclusive process that engages a
 broad range of stakeholders such as public agencies, transit operators, communitybased organizations and residents, and outreach to underrepresented communities.
 (Note: Transit vehicle, fixed route vehicle/guideway capital improvement projects
 will NOT be considered for this Program as existing programs/funding sources
 focus on these types of projects)
- Improve the range of transportation choices such as first-and last-mile shuttles, taxi voucher programs, and other projects.
- Address gaps and/or barriers identified in <u>Community Based Transportation Plans</u>
 or other substantive local planning efforts involving focused outreach to low-income
 populations such as countywide or regional welfare-to-work transportation plans, the
 Coordinated Public Transit-Human Services Transportation plan or other
 documented assessment of need.

Program and project ideas can include, but are not limited to technical assistance or implementation of:

- Lower cost capital improvement projects (e.g., bus stop upgrades, sidewalk improvements, multilingual signage)
- Active transportation infrastructure (e.g., sidewalk connectivity, new bike lanes)
- Mobility services (e.g., subsidized taxis and ride hailing services or volunteer transportation programs focused on serving persons earning a low-income or those seeking healthcare)
- Innovative pilot project advancing equity (e.g., neighborhood data collection and management, shared-use mobility such as ride sourcing, carsharing, bikesharing, etc.)

- Transportation-related workforce development programs (e.g., transportation related to building a pipeline of talent from technical trades to STAMPE – Science, Technology, Arts, Math, Policy, Engineering)
- Engagement, outreach, and education (e.g., programs that increase awareness, social connectedness with and for underserved communities related to transit/transportation)
 Submitting Through Survey Form or Video

MTC is collecting input and ideas through an Interest Survey online form or through recorded video content. MTC will use the submitted content to inform and develop regional funding and assistance programs that support the advancement of mobility and access to opportunity.

Following the development of any funding program, MTC will release a call for projects. MTC staff will work with eligible proposers to support the development of project proposals for the funding program.

Similar projects for the same public agency or set of agencies should be submitted as a single project (for example, a city interested in improving bus shelters at various sites should submit one form for all sites rather than a form for each proposed location).

Surveys are due July 21, 2023 deadline extended to July 26, 2023.

Eligible Project Idea Proposers

Surveys may be submitted by Bay Area public agencies, including Cities, Counties, Transit Agencies, and County Transportation Authorities (CTAs). Public agencies can coordinate and submit coordinated cross- jurisdictional project ideas, but a primary agency must be identified. Public agencies may partner with other entities such as non-profit organizations and community-based organizations. A public agency must serve as the grant recipient and fiscal agent for any project funded by a grant through MTC's CARE Program.

Next Steps and Schedule

Response to the Survey is due by July 21, 2023 deadline extended to July 26, 2023. MTC will host informational online meeting(s) on Wednesday, July 12 and Wednesday, July 19 at 1:00PM. The information session will provide an overview of the process and respond to questions.

MTC will review and summarize survey results and follow up with proposers as needed. Results will then inform the development of the Draft Funding Guidelines and Requirements of MTC's CARE Program.

MTC anticipates developing a baseline funding program of \$21 million for CARE, a Call for Projects initiated in late summer/September 2023, with REAP state funded awarded projects to be completed/funds expended by June 2026. Response to this interest and needs assessment will help inform the community-based investment priority categories, percentage allocation for each category, and overall grant design, implementation, and evaluation.

Potential Regional Transportation Measure: Proposed Goals, Principles, and Priorities

Subject:

Update on the potential 2026 regional transportation ballot measure, including draft goals, principles, priorities, and next steps for public engagement.

Background:

In January 2023, staff updated the Policy Advisory Council and the Joint MTC ABAG Legislation Committee on early efforts to engage stakeholders related to a potential regional transportation ballot measure slated for 2026. This was the first step in a process that sought to identify an expenditure plan concept and potential revenue source(s) by the end of 2023 to pursue enabling legislation in 2024, consistent with recommendations featured in Plan Bay Area 2050 and the Transit Transformation Action Plan. Since then, staff has completed public polling on Bay Area voters' priorities concerning transportation and re-convened with key stakeholders in advance of anticipated public engagement starting later this month.

Recent action on the state level to provide near-term transit operating assistance is a critical first step to averting the transit fiscal cliff. However, significant additional financial resources will be required over the medium to long-term to position our region's transit systems on a stable financial footing for the years and decades ahead. Furthermore, complementary investments to transform transit for the post-pandemic era and improve mobility and access to key destinations through other transportation improvements also require new revenues to realize.

Draft Goals and Focus Areas:

A potential 2026 regional transportation ballot measure should not be considered in isolation from the many actions being taken at the regional and local level to implement our adopted long-range plan, Plan Bay Area 2050. Instead, a regional transportation funding measure is one component of a suite of strategies to address the Plan's goals, including securing new funding for affordable housing through the planned Bay Area Housing Finance Authority's affordable housing bond in 2024, encouraging denser land use policies around station areas, supporting local action to protect vulnerable communities from climate change, and much more. In that

vein, staff recommends that the measure advance the Plan's five broadly supported goals to realize a more **affordable**, **connected**, **diverse**, **healthy**, **and vibrant region for all**. Based on feedback from our stakeholder engagement to date, staff identified three focus areas aligned with the Plan's vision that the measure could help to accelerate: **stabilize transit funding**; **make transit faster**, **safer**, **and easier to use**; **and enhance mobility and access for all**. These three focus areas had broad support from all stakeholder groups we met, with more significant divergence emerging regarding the extent to which each should be prioritized.

Draft Guiding Principles:

Before crafting an expenditure plan that could advance this vision, staff recommends also identifying guiding principles that should be kept in focus for the entirety of the expenditure plan development process but also specific line items. Four guiding principles are suggested below to evaluate expenditure plan concepts to ensure regional goals are being actively advanced throughout:

- The expenditure plan and each category of funding should be **equitable** insofar that funding should be prioritized toward providing benefits to residents of Equity Priority Communities and other marginalized groups, such as older adults and persons with disabilities.
- The expenditure plan and each funding category should be **climate-friendly**, insofar that only greenhouse gas (GHG) -reducing or GHG-neutral projects should be funded.
- The expenditure plan should be **adaptable**, recognizing the region's future remains highly uncertain.
- The expenditure plan should be **cohesive**, enabling a measure that both maximizes regional impact and is easy to communicate to the public.

Draft Expenditure Priorities:

Based on stakeholder input and public polling, staff recommends moving forward developing an expenditure plan that positions sustaining transit operations as a high priority while also integrating other categories of investments necessary to advance regional goals. While the share of investment in transit operations relative to other priorities remains a topic for further exploration this fall as transportation revenue forecasts come into focus, four other complementary expenditure categories are also being explored as documented in Attachment A.

Next Steps:

Staff seeks feedback from the Policy Advisory Council on the draft goals, principles, and priorities for the potential transportation ballot measure. Further refinements will be made this summer based on feedback received through the public engagement process. Staff will then return to the Council to share the proposed goals and principles for the ballot measure, with time to refine funding levels, expenditure priorities, and potential revenue source(s) later in the fall. This timeline should enable MTC to work with legislators in Sacramento to advance authorizing legislation in 2024 that incorporates feedback received this year.



Plan Bay Area 2050+: Scope and Schedule

Subject:

Update on scope and schedule for Plan Bay Area 2050+, a minor update to the long-range regional plan slated to kick off this summer.

Background:

Plan Bay Area is the long-range, fiscally constrained regional plan for transportation, housing, the economy, and the environment, updated every four years. Developed in compliance with federal and state regulations and guidelines, it satisfies Regional Transportation Plan (RTP) and Sustainable Communities Strategy (SCS) requirements for the nine-county San Francisco Bay Area.

A joint project of ABAG and MTC, Plan Bay Area is adopted by both the ABAG Executive Board and the Commission, first with the original Plan Bay Area (July 2013), Plan Bay Area 2040 (July 2017), and most recently Plan Bay Area 2050 (October 2021). A modified version of this item was presented to the Joint MTC Planning with the ABAG Administrative Committee on July 14, 2023.

Plan Bay Area 2050+ Scope and Schedule:

Plan Bay Area 2050+ is a limited and focused update of Plan Bay Area, which is kicking off this month, with an anticipated adoption date of fall 2025. Plan Bay Area will be updated in consultation with a wide range of partners, including federal, state, regional, county, local and Tribal governments, as well as community organizations, stakeholders, and the public.

Because it is a limited and focused update that will not require a concurrent Regional Housing Needs Allocation (RHNA) process, Plan Bay Area 2050+ will leverage the solid foundation of Plan Bay Area 2050, including its adopted vision and guiding principles as well as its overall strategic framework and organization. As such, key priorities for the Plan Bay Area 2050+ process include: (1) educating the public and partners on the purpose, strategies, and real-world impact of the long-range plan, (2) leveraging findings from ongoing high-profile implementation efforts to inform targeted refinements to select plan strategies, and (3) updating planning and

technical assumptions to reflect the realities of the post-COVID environment more fully. The

expected timeline and key milestones for Plan Bay Area 2050+ are included in Attachment B.

In parallel to Plan Bay Area 2050+, MTC will be advancing Transit 2050+, a comprehensive re-

thinking of the six transit-related strategies in Plan Bay Area 2050's Transportation Element,

necessitated by the rapid changes in commute patterns brought about by the COVID-19

pandemic, significant reductions in anticipated transit revenues through 2050, and the challenges

posed by the region's fragmented transit system. The parallel Transit 2050+ planning process

results will feed directly into the Plan Bay Area 2050+ Final Blueprint development in 2024.

Next Steps:

A first round of public engagement – including pop-ups, workshops, webinars, and an online

survey – will take place this summer for both Plan Bay Area 2050+ and Transit 2050+. Staff will

return to the Council to provide updates on Plan Bay Area 2050+ in the fall.



Plan Bay Area 2050: Refresher

- Adopted in October 2021, Plan Bay Area 2050
 represents the most comprehensive regional
 vision to date, leveraging deep community
 engagement and a strong commitment to equity
 when planning for an uncertain future.
- This long-range plan responded to clear direction from policy leaders to be "bold and unflinching" in identifying what it would take to address many of the region's thorniest policy challenges.
- Since adoption, ABAG and MTC have been singularly focused on advancing plan implementation to achieve regional outcomes.




