RE: Clipper® Contract Action:

i. Contract Change Order Amendment– Clipper® Card Procurement: Cubic Transportation Systems, Inc. (Cubic) (\$2,000,000)

Staff recommends that the Operations Committee authorize the Executive Director or his designated representative to negotiate and enter into the following contract action, which was approved by the Clipper® Executive Board on November 28, 2016:


i. Contract Change Order Amendment– Clipper® Card Procurement: Cubic Transportation Systems, Inc. (Cubic) (\$2,000,000)

Since its inception, the Clipper® program has issued over five million cards. Demand in 2015 and 2016 has remained steady, with the program issuing 55,000 new adult cards each month. In addition, the transit operators' expansion of their institutional programs (i.e., VTA's Eco Pass; and AC Transit's EasyPass and UC Berkeley Class Pass) drives demand for cards.

The Clipper® program partially offsets the cost of cards by charging most customers a \$3 card acquisition fee. The Clipper® program waives this fee for youths, seniors and Autoload customers. Fees related to Regional Transit Connection (RTC) Discount ID Card are collected by the RTC Program. Historically, the Clipper® program also waived the \$3 fee for adult cards issued through institutional programs, but the Clipper® Executive Board now requires payment for those cards as well. This Change Order Amendment will be primarily funded from the Clipper® cardholder fee account held by MTC.

This change order amendment will require Cubic to purchase Clipper® cards for distribution to customers. Cubic is neither a small business nor a disadvantaged business enterprise.

Staff recommends that this Committee authorize the Executive Director or his designee to negotiate and enter into one or more contract change order amendment(s) with Cubic in an amount not to exceed \$2,000,000 for the services described above.
