RE: Third Quarter MTC SAFE Financial Statements - March 2017

Please find attached for Committee receipt the MTC SAFE financial statements for the third quarter ended March 31, 2017.

SAFE Program

The third quarter vehicle registration fees of \$4.9 million are slightly higher than the budgeted amount, due to an increase of registered vehicles.

Now that the audit is complete, funds totaling \$74,000 from FY 2015-16 are expected to be added to the budget as contract carryover encumbrances.

FSP Program

Total program expenditure through the third quarter is \$5.4 million and 89% is for the tow related expenses.

Capital Program

The total life-to-date budget for the Capital Programs is \$24 million. As of the end of the third quarter of FY 2016-17, life-to-date expenses for those programs plus encumbrances total \$17 million.





Background

In May 2012, the MTC Operations Committee approved a contract change order with Cubic to engage a firm to assess Cubic's financial and system controls associated with fare processing, financial reconciliation, cardholder support services, card fulfillment, information system operations and card account management functions. These tasks are completed via a standard approach called a Statement on Standards for Attestation Engagement No. 16 Report (SSAE 16 Audit). Transit operators require this as part of their annual audit, particularly as Clipper[®] collects an ever-larger share of their fares.

Industry leading practices recommend conducting annual audits to maintain vendor focus on controls. This change order amendment (Amendment 5) will allow Cubic to engage a firm to perform the SSAE 16 Audit for FY 2017-18.

The first SSAE 16 Audit was completed in November 2013. Following completion of this report, the change order was subsequently amended to include SSAE 16 Audits for FY 2013-14, FY 2014-15, and FY 2015-16. Each year, these audits provide an attestation report to state that management controls were tested as effectively meeting risk management objectives.

Cubic is neither a disadvantaged business enterprise (DBE) nor a small business enterprise (SBE) and currently has no subcontractors.

This item was approved by the Clipper[®] Executive Board on April 17, 2017.

Recommendation

Staff recommends that the Committee authorize the Executive Director or his designated representative to negotiate and enter into a contract change order amendment with Cubic for services as described in this memorandum, in an amount not to exceed \$200,000.

RE: <u>Contract – High Occupancy Vehicle Enforcement Pilot Study: California Highway Patrol</u> (\$575,000)

This memorandum requests Committee approval to enter into a contract with the California Highway Patrol (CHP) to provide enforcement services for the High Occupancy Vehicle (HOV) Enforcement Pilot Study in an amount not to exceed \$575,000, subject to the Executive Director's approval of Regional Measure 2 (RM2) Capital funds via delegated authority under MTC Resolution No. 3620. This approval is being requested early so that CHP can initiate its process to draft the contract.

Background

In May 2016, staff presented data to the Committee that showed that more than half of Bay Area HOV lanes fail to meet federal speed standards as reported by Caltrans (2014), and that HOV lane occupancy violations exceeded Caltrans' maximum acceptable threshold of 10% in many locations as reported by MTC (Managed Lanes Implementation Plan, 2015). The Committee tasked staff with identifying specific ways to improve HOV lane performance. More recently, in January and March of 2017, the Committee expressed interest in legislative solutions to occupancy enforcement such as establishing a new state or regional enforcement patrol separate from CHP. At this time, staff is pursuing two pilot projects it hopes will inform any potential legislative solution to enforcement:

- 1. Automated Vehicle Occupancy Detection (VOD) Technology Pilot MTC released a Request for Qualifications in March, and expects to recommend award of contract(s) in June 2017; and
- 2. HOV Enforcement Pilot Study (this item) MTC is requesting approval of a contract with CHP for enforcement services at the May 12 Committee meeting.

The HOV Enforcement Pilot will study how to improve HOV lane performance in the Bay Bridge and other bridge corridors through increased CHP resources. The pilot will:

- Test the impact of regularly enforcing HOV occupancy levels over a sustained period of time;
- Explore different enforcement strategies, including leveraging vehicle occupancy detection technology as applicable;
- Gather data on cost and effectiveness; and
- Produce a study that reports on pilot results to inform future decision-making.

The goal is to reduce HOV violation rates, which should improve HOV lane performance increasing the attractiveness of carpooling and transit as alternatives to driving alone and boosting person-throughput in congested bridge corridors. Operations Committee May 5, 2017 Page 2

Staff proposes to enter into a contract with the CHP to perform more intensive HOV occupancy enforcement services at a few locations starting with the Sterling Street on-ramp to the Bay Bridge in San Francisco. CHP would be paid on an overtime basis, as is the case for other reimbursable services contracts with CHP. MTC and CHP would jointly identify several enforcement strategies and a timeline to test them. This pilot would also coordinate with the VOD Pilot to inform and test how technology could support CHP enforcement. MTC will collect before/after data on citations issued by CHP, observed HOV occupancy violations, person-throughput and other performance measures. The main product of this pilot will be a study to analyze and document impacts on HOV lane performance and inform future decision-making about how to provide the most cost-effective enforcement possible. The pilot is expected to take about one year from when the contract is executed, but depends on coordination with the VOD Pilot.

Recommendation

Staff recommends that the Committee authorize the Executive Director or his designated representative to negotiate and enter into a contract with CHP to provide enforcement services for the HOV Enforcement Pilot Study in an amount not to exceed \$575,000, subject to approval of RM2 Capital funds.

Background

Staff briefed this Committee last month on plans to procure a Next Generation Clipper[®] (C2) system. Based on the current schedule, a Next Generation Clipper[®] vendor would be selected in late 2018 and would then begin design of a new system. Transition from the existing Clipper[®] system to a new system would begin in late 2020.

The existing Clipper[®] contract with Cubic Transportation Systems, Inc. ("Cubic") ends in November 2019. At the request of the Clipper[®] Executive Board, Clipper[®] staff have negotiated a change order to the existing contract with Cubic to extend the operation and maintenance (O&M) for up to five years in order to assure a smooth customer transition to C2. The \$25M annual cost of this change order is equivalent to the operating costs paid today (slightly more than \$2M per month). The Cubic contract extension is for a maximum of five years and could be terminated earlier, as detailed below.

Scope of Work

The proposed contract change order has the following key terms:

- An extension of the current O&M term beginning November 3, 2019 of not less than two and up to five years;
- MTC retains the right to terminate the contract for convenience at any time, by written notice, per the existing, federally-required clause in the current Clipper[®] Contract;
- If MTC provides at least one year advance notice of termination, Cubic's termination cost recovery is limited to early rent termination costs;
- No change in existing O&M requirements or payment terms for the first two years of the extension;
- The remaining years (Years 3-5), if any, to be paid for on a Time & Materials (T&M), capped at the monthly average cost of the first year extension, plus any rent increases beyond Cubic's current lease term;

- Key Performance Indicators (KPIs) will continue in full force as long as the current scope of work remains intact; after that, only those KPIs related to specific O&M services to be performed by Cubic in their entirety will be subject to KPIs;
- Cubic agrees to reasonably cooperate in good faith with the C2 Contractor in the event of a transition; and
- Cubic will maintain the system in a state of good repair pursuant to the current Contract during year one and any additional year performed under the current contract terms, after which asset replacement will be paid for by MTC, unless caused by Contractor's failure to perform maintenance.

The proposed contract extension would be a sole source contract change order, based on Cubic's unique capability to perform the C1 O&M work on the existing system.

Cubic is neither a disadvantaged business enterprise nor a small business enterprise and currently has no subcontractors.

This item was approved by the Clipper[®] Executive Board on April 17, 2017.

Recommendation

Staff recommends that the Committee authorize the Executive Director or his designated representative to negotiate and enter into a contract change order with Cubic for services as described in this memorandum, in an amount not to exceed \$25,000,000 per year, subject to inclusion in each fiscal year's budget.
