This memorandum seeks approval from the Authority for a contract with Iteris, Inc. (Iteris) in an amount not to exceed \$300,000 to provide on-call transportation planning services related to before and after evaluations for the I-680 Express Lane in Contra Costa County between Martinez and Walnut Creek, subject to approval of the Bay Area Toll Authority (BATA) FY 2017-18 budget.

#### **Background**

BAIFA, in partnership with the Contra Costa Transportation Authority, is preparing to deliver the I-680 Northern Segment express lane in Contra Costa County by converting the existing southbound high-occupancy vehicle lane between Martinez and Walnut Creek to an express lane and adding a new express lane to connect the gap in the HOV/HOT system on I-680 near the I-680/SR-24 interchange. The Northern Segment will be an extension of BAIFA's I-680 Express Lanes between Walnut Creek and San Ramon opening in September 2017. Construction of the Northern Segment will begin by early 2018. Staff estimates that the I-680 Northern Segment express lane will open to traffic in 2020.

Staff will collect before and after data to measure the impacts of the I-680 Northern Segment Express Lane. The initial data collection will occur this Fall 2017 before construction activities commence, and will establish baseline conditions. Baseline conditions will later be compared to data collected after the lanes are open and traffic has stabilized. The data to be collected, including travel time/speed, volumes, and vehicle occupancy, will be used to evaluate various performance measures, such as travel time savings and reliability, vehicle/person throughput, level of service, delay, and duration of congestion.

#### **Selection Process**

In February 2016, MTC issued a Request for Qualifications to pre-qualify firms to provide on-call transportation engineering and planning services to support various Service Categories, including:

- a) Freeway Active Traffic Management
- b) Travel Demand Management
- c) Connected Vehicles/Autonomous Vehicles and Advanced Technology
- d) Data Analytics and Performance Assessments
- e) Arterial Operations
- f) General Planning

At its June 10, 2016 meeting, the Operations Committee approved a competitively pre-qualified panel of fourteen consultants to provide on-call transportation engineering and planning services in the Freeway Active Traffic Management service category, and eleven consultants in the Data Analytics and Performance Assessments service category on an as-needed basis for use by MTC and its affiliated agencies, including BAIFA.

On May 5, 2017 BAIFA invited all pre-qualified consultants in either the Freeway Active Traffic Management or the Data Analytics and Performance Assessments service category to submit a budget, project schedule, and staffing plan to conduct before and after evaluations for the I-680 Northern Segment Express Lane. MTC received proposals from four firms: DKS Associates, Iteris, Mott MacDonald, LLC., and TJKM. A panel of BAIFA staff performed a review of the proposals and evaluated the proposals based on each firm's previous similar experience, approach to completing the work, reasonableness of costs, and written communication.

Based upon this evaluation, staff recommends the selection of Iteris. Iteris had the most cost-effective proposal by taking into account scope areas that could be performed more efficiently, thereby reducing project costs. Additionally, Iteris has local knowledge of the San Francisco Bay Area freeway corridors, and expertise in both big data analytics and in-field data collection. The table below provides the final rankings based upon staff evaluations:

#### Recommendation

Staff recommends that the Authority authorize the Executive Director or his designee to negotiate and enter into a contract with Iteris in an amount not to exceed \$300,000 to provide on-call transportation planning services related to before and after evaluations for the Contra Costa I-680 Northern Segment express lane project, subject to the approval of the FY 2017-18 BATA budget.

### Memorandum

This memorandum requests Authority approval to issue a purchase order for Pacific Gas & Electric (PG&E) to provide electric utility services for the operations of the I-680 Express Lanes in Contra Costa County between Walnut Creek and San Ramon and the backhaul fiber optic communications for FY 2017-18 network (Backhaul) in an amount not to exceed \$229,000 plus a contingency of \$34,000, subject to the adoption of the Express Lanes Program Operating budget. These services cannot be procured competitively as PG&E is the only electric utility provider in the area.

#### **Background**

The I-680 Express Lanes will convert the existing I-680 northbound and southbound high-occupancy vehicle (HOV) lanes to express lanes in Contra Costa County between Walnut Creek and San Ramon. The Backhaul is a planned metropolitan area data network that will transport traffic and toll data between the MTC express lanes on I-680, I-880 and I-80; the toll system host at the Benicia-Martinez Toll Plaza; and the toll operations centers at Caltrans District 4 and the Bay Area Metro Center. The PG&E services will power tolling and communication equipment within the I-680 corridor.

The total estimated cost for PG&E service for the I-680 Express Lanes and Backhaul for FY 2017-18 is \$229,000. Staff also requests authorization of a \$34,000 contingency to prepare for unanticipated costs due to first year of Express Lanes and Backhaul operations. A summary of the estimated expenses for the I-680 Express Lanes and Backhaul projects are shown in the table below.

#### Recommendation

This item would authorize the Executive Director or his designee to issue a purchase order to SSP Data for network engineering services to oversee the installation and ongoing operations of the associated fiber optic communications network (Backhaul), subject to the adoption of the Express Lanes Program Operating budget.

#### **Background**

The Backhaul is a planned metropolitan area data network that will be used to send traffic and toll data between the BAIFA express lanes on I-680, I-880, and I-80; the toll system host at the Benicia-Martinez Toll Plaza; and the toll operation data centers at Caltrans District 4 and the Bay Area Metro Center. BAIFA's investment leverages existing communications infrastructure owned by Caltrans and BART and has been designed to accommodate future use by traffic management systems operated by Caltrans, MTC and the Bay Area Toll Authority. Construction of the Backhaul began in February 2016 and staff anticipates operations of the Backhaul to begin in July 2017 prior to opening of the I-680 Express Lanes in Contra Costa County between Walnut Creek and San Ramon.

BAIFA has procured network engineering services from SSP Data since February 2017 under Executive Director authority. SSP Data was selected using a collaborative intergovernmental procurement agreement from the General Services Administration, which satisfies BAIFA's procurement requirements. The services have been instrumental in providing technical review and oversight of the Backhaul network implementation and coordination with Backhaul stakeholders including the Backhaul contractor, the express lanes toll system integrator, and Backhaul designers. Staff recommends procuring network engineering services for FY 2017-18 to support the completion of the Backhaul installation and for ongoing operations.

Attachment A includes a summary of the small business and disadvantaged business enterprise status for SSP Data.

#### Recommendation

Staff recommends that the Committee authorize the Executive Director or his designee to issue a purchase order for network engineering services to SSP Data in an amount not to exceed \$300,000, subject to the adoption of the Express Lanes Program Operating budget.

## Memorandum

RE: BAIFA Resolution No. 16 - FY 2017-18 Express Lanes Program Operating Budget

The FY 2017-18 budget is the first operating budget for the express lanes program. The I-680 Contra Costa Express Lanes between Walnut Creek and San Ramon and the backhaul communications network (Backhaul) are anticipated to be in operation for 10 months in FY 2017-18. To cover first year operating expenses of \$8.6 million, the FY 2017-18 budget anticipates using a combination of express lane toll revenue and funds previously set aside for this purpose in the BATA Express Lanes Capital Budget. The FY 2017-18 operating budget is shown in Attachment A.

#### **General Toll Revenue - \$5.2 million**

Staff is estimating a total of 1.2 million trips on the express lanes which will generate \$5.2 million in toll revenue in FY 2017-18. This is a rough estimate since it will be the first year of BAIFA revenue operations. Staff will be able to better estimate revenue in the future when there is some historical data.

#### Other Revenue/Transfers In - \$3.4 million

Violation Revenue – Staff is estimating \$0.5 million in revenue from toll violations. This is a conservative estimate based on the number of violations on the I-580 express lanes.

BATA Express Lanes Capital Funds Transfer In – In planning for Express Lane operations, staff anticipated a need to subsidize operating costs on this segment of I-680. As such, staff planned to cover up to three years from capital funds. To cover the balance of FY 2017-18 operating expenses, staff will allocate \$2.9 million in BATA Express Lanes Capital funds previously set aside for capitalized operations and maintenance in the Express Lanes Program Expenditure Plan (BAIFA Resolution No. 9). These funds will be transferred from the BATA Capital Budget to the FY 2017-18 BAIFA Operating Budget.

#### **Operating Expense**

Total cost for the I-680 Express Lanes operations, including operations of the Backhaul, is proposed to be \$8.6 million for FY 2017-18. Highlights of the FY 2017-18 budget include:

#### Express Lane and Backhaul Operations and Maintenance - \$6.6 million

FasTrak® Operations and Maintenance - \$1.8 million

- \$1.3 million for the FasTrak® Regional Customer Service Center (RCSC) operations. The RCSC will provide customer service, distribute toll tags, process violations, and collect tolls for the express lanes.
- \$240,000 for banking/credit card fees.
- \$225,000 for BATA financial services.

Express Lanes Operations and Maintenance - \$4.1 million

• \$4.1 million for daily express lanes operations and maintenance including: toll operators in the Regional Operations Center, enforcement by California Highway Patrol, maintenance by BAIFA's roadway contractor and Caltrans, and PG&E utility services.

Backhaul Operations and Maintenance - \$0.7 million

\$0.7 million for Backhaul operations plus maintenance and utility services. Notably, BAIFA is
unique among Bay Area express lanes in supporting a fiber communications network of this
extent.

#### Express Lanes Administration - \$2.0 million

• \$2.0 million for staff support, insurance and financial audit costs.

Staff seeks Authority approval to amend the Express Lane Program Expenditure Plan (Expenditure Plan) based on updates to the I-880 Express Lanes (Project). Staff also seeks approval for the Executive Director or his designee to award a contract for civil construction services to Flat Iron West (Flat Iron) in an amount not to exceed \$44,875,182 plus a contingency of \$10,739,546, subject to receipt of the construction permit from Caltrans, the approval of the Bay Area Toll Authority (BATA) FY 2017-18 budget, and amendment of the Expenditure Plan. Staff seeks approval to award to the second lowest bidder should the Flat Iron bid be found not responsive or Flat Iron found to be not responsible and to award to the third lowest bidder should the second lowest bid be found not responsible.

#### **Background**

The Project will convert 51 miles of existing I-880 high-occupancy vehicle lanes to express lanes in Alameda County between Hegenberger Road/Lewelling Boulevard and the Santa Clara County Line. Civil roadway improvements include construction of new foundations for overhead signs, structures and lighting; installation of conduit, subsurface vaults and signs; reconstruction of median barriers; restriping freeway lanes; and paving to prevent pavement scarring. The Project also includes installation of fiber and connections to partner agency fiber and leased-line services for the backhaul communications network. In addition to the Project, Caltrans has secured separate funding for projects to replace the median barrier and to rehabilitate the pavement on I-880. To minimize the overall construction duration and impacts to the public, BAIFA agreed that Caltrans would install express lanes foundations as part of its median barrier replacement project (under construction since Spring 2016) and include express lanes paving in its paving project (to advertise later this year). This memorandum recommends award of the contract for the remaining civil construction work. Upon substantial completion of the civil work, BAIFA will install toll equipment under its existing Toll Systems Integrator Contract. The I-880 Express Lanes are projected to open in 2019. Caltrans has agreed to issue a construction permit prior to reaching an agreement with BAIFA on the terms of the Operations and Maintenance Agreement. The principal outstanding issue with the agreement is the cost-sharing formula for any needed reconstruction of the Express Lane in the future.

#### **Expenditure Plan Modifications**

In November 2016, subsequent to the last revision to the Expenditure Plan, staff revised the project scope to address new scope required by Caltrans for widening at access locations, lighting and overhead sign structures. At that time, staff reported a cost estimate of \$114,100,000 and advised that BAIFA might need to

adjust the expenditure plan based on the bids for the I-880 civil construction contract. In the past several months, staff updated the cost estimate to \$120,000,000 to reflect increased contingency for the backhaul communications network (based on lessons learned on I-680) and additional pavement work (based on agreement with Caltrans to avoid pavement scarring.) As described below, bids for the civil construction contract exceeded the engineer's estimate and staff recommends updating the Expenditure Plan, BAIFA Resolution No. 9, based on a revised cost estimate of \$132,466,000 for I-880.

To accommodate this cost increase, staff recommends adding \$23,891,000 to the Expenditure Plan, as shown in Attachment A. These funds have been in the BATA Express Lanes Capital Budget since it was established in FY 2013-14 but were previously not assigned within the Expenditure Plan. In addition, staff recommends transferring \$30,796,000 from Program Contingency to the I-880 Project, leaving a contingency of \$5,128,000. This remaining contingency is considerably lower than the \$18,100,000 estimated value of program risk in the most recent Quarterly Report. Staff plans to be diligent in managing cost and risk while seeking new funding opportunities.

#### **Contractor Selection Process for I-880 Civil Construction Contract**

BAIFA issued an Invitation for Bid (IFB) for I-880 Express Lanes Civil Construction on April 25, 2017 and held a bidders' conference on May 8, 2017. On June 13, 2017, three bids were received and opened at a public bid opening. Per the IFB, award, if made, shall be to the lowest responsible and responsive bidder factoring in the Small Business Enterprise (SBE) Bid Preference.

For bid comparison purposes, BAIFA's SBE Bid Preference grants a five percent discount to the total bid amount when certified SBE Prime Contractors perform at least forty percent of the work or when at least forty percent of the work is subcontracted to certified SBE firms. The use of a SBE Bid Preference does not alter the total amount of the bid submitted by a bidder or the contract executed. As set forth below, the five percent discount is applied to the Total Bid Amount (A) resulting in the SBE Bid Preference Amount (B), from which the Bid Rank (C) is determined.

All three bids are very close in price and are considerably higher than the engineer's estimate of \$35,300,000. The discrepancy is due largely to rapidly evolving market conditions, an environment not addressed well in the industry's standard process for developing the engineer's estimate. In the last several months demand for both public and private construction for electrical work and concrete, a large part of this contract, has grown quite rapidly. At the same time, the number of qualified firms specializing in electrical work has decreased. As such, staff does not see an opportunity to reduce costs by rebidding the contract.

Staff is requesting a contract contingency of \$8,975,036 (20% of the bid amount), to cover unknown project costs not in the scope of work, plus \$1,764,510 for supplemental work items, which are not in the scope of work but may be needed. The total contingency is \$10,739,546 for the top ranked bid. Attachment B includes a summary of Flat Iron and its project team's SBE and disadvantaged business enterprise status.

### Memorandum

This memorandum seeks approval from the Authority to amend a contract with HDR Engineering, Inc. (HDR) in an amount not to exceed \$817,700 for design services during construction of the I-880 Express Lanes (Project), subject to the approval of the FY 2017-18 Bay Area Toll Authority (BATA) budget and the amendment of the Express Lane Program Expenditure Plan.

#### **Background**

The Project will convert 51 miles of existing I-880 high-occupancy vehicle lanes to express lanes in Alameda County between Hegenberger Road/Lewelling Boulevard and the Santa Clara County Line. Civil roadway improvements include construction of new foundations for overhead signs, structures and lighting; installation of conduit, subsurface vaults and signs; reconstruction of median barriers; restriping freeway lanes; and paving to prevent pavement scarring. The Project also includes installation of fiber and connections to partner agency fiber and leased-line services for the backhaul communications network (Backhaul). In addition to the Project, Caltrans has secured separate funding for projects to replace the median barrier and to rehabilitate the pavement on I-880. To minimize the overall construction duration and impacts to the public, BAIFA and Caltrans have agreed Caltrans will install express lanes foundations as part of its median barrier replacement project (under construction since Spring 2016) and will include express lanes paving in its paving project (to advertise later this year). Under a separate item on the June BAIFA agenda, staff is recommending BAIFA award a contract for construction of the remaining civil work. Upon substantial completion of the civil work, BAIFA will install toll equipment under its existing Toll Systems Integrator Contract with Transcore ICP. The I-880 Express Lanes are projected to open in 2019.

In January 2014, after a competitive procurement, the BATA Oversight Committee authorized eight firms to provide on-call construction design services. The Request for Qualifications (RFQ) allowed selected consultants to work not only for BATA but also for BATA's affiliated agencies, including BAIFA. The RFQ specified the lead agency could directly assign work to a particular firm based on expertise and availability or could conduct informal solicitations among qualified firms to assign the work. BAIFA authorized the current contract to HDR for \$7,000,000

following a competitive procurement from the on-call design services bench. HDR has completed Plans, Specifications and Estimates (PS&E) for the Express Lanes elements in the Caltrans median barrier contract as well as the Express Lanes civil contract. HDR's scope also includes providing design services during construction for both contracts.

#### This amendment would:

- 1) Replenish the funds available in the contract for design services during construction While the decision to construct some Express Lanes civil elements in the Caltrans median barrier and paving contracts will reduce the impact of construction on the driving public, it also increased the cost for coordination during design. In addition, Caltrans required substantial modifications to the plans and permit application. Caltrans provided new comments on the Final PS&E submittal, thus requiring an additional round of comment resolution, re-design and multiple resubmittals. As a result, HDR expended approximately \$300,000 of the budget that had been reserved for design services during construction.
- 2) Provide funding for design services during construction for the Backhaul in the I-880 corridor, which is included in the I-880 Express Lanes civil construction contract. BAIFA staff initially expected to issue separate contracts for construction of the Backhaul in each corridor. However, based on the experience of the I-680 Backhaul design and construction, staff elected in 2016 to integrate Backhaul construction along I-880 into the Express Lanes civil construction contract. Design services for the Backhaul have been provided by Atkins North America, Inc. (Atkins) under the Toll System Manager contract, which expires in December 2017. Since the Backhaul and Express Lanes civil work will be performed under a single contract, it is more effective to have all design services during construction under a single contract. This amendment would allow Atkins to provide design services during construction for the Backhaul as a subcontractor to HDR. The budget for this work is \$510,000.

The funds for this work are subject to approval of the proposed revision to the Express Lane Program Expenditure Plan, BAIFA Resolution No. 9, Revised addressed in a separate item on the June BAIFA agenda. Attachment A includes a summary of HDR and its project team's small business and disadvantaged business enterprise status.

#### Recommendation

Staff recommends that the Authority authorize the Executive Director or his designee to negotiate and enter into a contract amendment with HDR in an amount not to exceed \$817,700 for the work specified herein, subject to approval of the BATA FY 2017-18 budget and amendment of the Express Lane Program Expenditure Plan.
