Staff requests BAIFA to authorize an amendment to the cooperative agreement with the Contra Costa Transportation Authority (CCTA) for delivery of civil improvements for I-680 Express Lanes in an amount not to exceed \$34,549,000. This funding is for civil roadway construction to extend the I-680 Express Lane between Rudgear Road and Marina Vista in the southbound direction.

Background

BAIFA and CCTA are partnering to deliver express lane projects on the I-680 corridor in three projects shown in Attachment 1.

- 1. The first express lanes will open this fall on the "Southern Segment", between Walnut Creek and San Ramon in the northbound and southbound directions.
- 2. The second project, the subject of the cooperative agreement amendment, will extend the southbound express lanes to the "Northern Segment" of I-680 between the Benicia Bridge and Walnut Creek. The project will convert an existing HOV lane from Marina Vista Avenue to North Main Street to an express lane (Southbound Conversion) and construct a new lane from North Main Street to Rudgear Road (Southbound HOV Completion). When coupled with BAIFA's I-680 Southern Segment express lane project, this results in a continuous express lane on I-680 southbound from Martinez to the Alameda County line. This project is funded in BAIFA's Express Lanes Program Expenditure Plan (BAIFA Resolution No. 9, Revised) and the civil construction contract will be ready to advertise in early 2018. Once construction is complete, BAIFA will operate the express lane.
- 3. The third project, not presently funded, will implement express lanes on the "Northern Segment" in the northbound direction. This project includes a challenging gap from the express lanes in the Southern Segment (project #1) to the existing high-occupancy vehicle lanes beginning at SR-242. MTC and CCTA are pursuing funding for "Innovate 680," a set of technology, operational and capacity strategies to complete the express lanes and improve operations.

The Express Lane Program Expenditure Plan includes \$51,288,000 in BATA Express Lane Funds for the Northern Segment express lanes in the southbound direction (project #2). CCTA is the lead agency to deliver the civil roadway improvements, and BAIFA is the lead agency to deliver the toll system and backhaul communications network. The table below slows a total allocation of \$38,100,000 in BATA Express Lane Funds to CCTA. The total includes a contribution of \$5,945,000 for the new lane from

North Main Street to Rudgear Road (Southbound HOV Completion); other funds for this part of the project include Regional Measure 2, State Transportation Improvement Program and Measure J.

CCTA has reviewed project costs and contingency based on the current bid environment, including the I-880 civil construction bids BAIFA received in June 2017. Nonetheless, there remains considerable uncertainty about bid prices and the impacts of Hurricane Harvey in Texas, which has potential to drive up the costs of oil and labor.

In June 2015, BAIFA authorized a cooperative agreement with CCTA for an initial amount of \$3,551,000 to fund design and right of way phases for the express lane conversion. These phases are nearly complete with a forecast expenditure of \$2,486,000 in Express Lane Funds. The unspent funds will be applied to the construction phase. This cooperative agreement amendment will provide the balance of BATA Express Lane funds to CCTA for the civil construction contract as shown below:


Recommendation

The I-680 Contra Costa Express Lanes between Walnut Creek and San Ramon, sometimes called the "Southern Segment," are scheduled to open this fall. A number of final preparations are now in progress. This includes toll system testing to ensure correct trip building and tolling, notifying customers to get FasTrak®, and training staff for the Regional Operations Center located in the Bay Area Metro Center. The last steps prior to opening will be replacement of high occupancy vehicle signs and diamond markings with those for express lanes.

At your September meeting, staff will provide the latest news on opening and operation of the lanes, including expectations for tolls, traffic and performance monitoring, and a more specific schedule for opening the lanes.


Traffic






