RE: 2018 Draft MTC/ABAG Joint Advocacy Program

At the direction of the MTC and ABAG Legislation Committees' leadership, staff has developed the region's first joint advocacy program for the two agencies. Given that 2017 was such a banner year for transportation funding and affordable housing legislation, there's a good chance the Legislature and Administration may turn their attention to other matters in 2018. Nonetheless, with respect to housing, many of the legislators who authored bills that were enacted as part of the housing package indicated their intent to carry further legislation next year. In preparation for this, the draft program includes a number of housing policy items relevant to the addressing the region's housing shortage.

In addition to carrying forward longstanding goals from prior advocacy programs of the respective agencies, this draft seeks to help advance the underlying goals and action plan of *Plan Bay Area 2040*. The advocacy program serves as a public statement of the agencies' core legislative goals for the upcoming year, as well as a work plan to guide advocacy efforts in Sacramento and Washington, D.C. As bills are introduced, staff will return to the respective agencies' legislation committees to seek approval on specific bill positions that will subsequently be presented for approval to the Commission and Executive Board.

As part of our consultation and advisory process, staff will consult with various stakeholders over the next month. To date, staff has informally sought input for the 2018 Advocacy Program from the Housing Subcommittee of the ABAG Regional Planning Committee (RPC) and the MTC Policy Advisory Council. We also hosted a meeting of MTC's Partnership Legislative Committee to discuss MTC's ideas and hear about what staff from other transportation agencies, local jurisdictions and advocacy organizations are planning for next year. Staff also plans to formally present this document to the RPC and Policy Advisory Council over the next month. Based on discussion at your meeting and additional feedback received, staff will prepare a final 2018 Advocacy Program for your consideration at another joint meeting in December or January, depending on schedule availability, prior to final approval by the Commission and Executive Board.

We look forward to hearing your feedback and developing a more comprehensive Bay Area regional advocacy agenda for 2018.

1. Transportation Funding	A. Defend Senate Bill 1 (Beall)	Oppose any statewide ballot measure that proposes to repeal the new fuel taxes and registration fees enacted by Senate Bill 1 (Beall, 2017). Collaborate with local, regional, and statewide organizations to highlight the benefits SB 1 is providing to improve the condition of local streets and roads and the state highway system, support public transit systems and implement bicycle and pedestrian improvement projects across the region.
	B. Secure passage of Regional Measure 3	Assuming placement of Regional Measure 3 on the ballot in 2018, staff will develop public information materials to help inform the public about the benefits of the proposed toll increase and how the expenditure plan will improve mobility within the Bay Area's seven state-owned bridge corridors.

Cap and Trade Funding	In collaboration with other statewide organizations, defend the existing transportation and housing programs funded by cap and trade and seek opportunities to direct additional cap and trade funds towards these purposes. Support administrative and/or legislative efforts to streamline funding applications and simplify program administration.

Definition of Disadvantaged Communities	Monitor legislation related to the definition of disadvantaged communities (DACs) as it relates to a local jurisdiction being able to qualify for certain cap and trade funding and other relevant funding programs. Seek opportunities to broaden the definition so that it includes all socio-economically disadvantaged communities. Monitor and engage in any administrative efforts related to updating the CalEnviroScreen, the state's current DAC screening tool developed by the Office of Environmental Health Hazard Assessment (OEHHA).

2. Housing Supply/ Affordability	A. CASA implementation	Consistent with <i>Plan Bay Area 2040's (Plan)</i> Action Plan, work with Bay Area regional partners to evaluate, and where appropriate, help implement CASA's state legislative recommendations to advance the <i>Plan's</i> housing performance targets. CASA recommendations are expected to address increasing housing supply, improving housing affordability, and strengthening preservation and anti-displacement measures.
	B. Housing funding	Support and pursue efforts to augment state funding for housing and related infrastructure, including resources to help local jurisdictions plan for new housing. Collaborate with local, regional and state partners to highlight the potential benefits of the \$4 billion housing bond authorized by SB 3 (Beall, 2017). Monitor and engage in legislative or administrative efforts related to allocating state housing resources to maximize funding to Bay Area communities.
	C. Incentivize production	Pursue opportunities to reward local jurisdictions that produce new housing and preserve the existing affordable housing stock with additional state funds. Incentives could include augmented resources for parks, infrastructure, schools or other investments that support complete, sustainable communities in growing jurisdictions.
	D. Reform state housing law	Engage in efforts anticipated to be led by Senator Wiener regarding ways to update the Regional Housing Needs Allocation (RHNA) process. Potential areas for legislative action include changing the types of units that the State Housing & Community Development Department deems eligible to be counted as part of its RHNA review and modifying the methodology by which the state develops its overall estimate of total housing units for each region so that it incorporates economic factors that fuel demand for housing, as well as demographic data.
	E. Lower housing construction costs and facilitate greater housing production	Partner with Bay Area and statewide affordable housing organizations, the Bay Area Council, Silicon Valley Leadership Group, and other interested parties to pursue opportunities to lower the cost of housing construction and facilitate increased production of market-rate and affordable housing units.

	F. North Bay Wildfires	Work with local partners to advocate for state funding, resources, and other emergency relief measures to aid and support rebuilding and recovery efforts following the devastating 2017 North Bay wildfires.
3. Climate Change & Energy	A. Accelerate the transition to a low carbon future	Support legislation to accelerate the transition to a low carbon future through changes to the vehicle fleet as well as incentives for low carbon buildings.
	B. Improve energy and water efficiency	Support legislation designed to enhance the energy and water efficiency of buildings, including commercial, multifamily and single-family homes. Also support proposals to boost the use of renewable energy and electrification of energy.
4. Resilience	A. Protect existing and future housing stock from natural hazards, such as earthquake and fire	Support efforts to expand the retrofit of existing residential housing, with a focus on multifamily developments, while also strengthening standards for new construction beyond “life safety” to “shelter in place” so that new housing can better withstand a major earthquake. Focus on opportunities to retrofit affordable housing through preservation projects funded from newly-augmented state housing revenues. Engage in efforts at a state and regional/local level to pursue additional funding to support the retrofit of existing properties.
	B. Relieve congestion and mitigate the effects of sea level rise on S.R. 37	In partnership with the State Route 37 Policy Committee and its representative agencies, support legislation and other efforts to address sea level rise, reduce congestion and improve safety on State Route 37.
5. HOV Lanes	Improve HOV lane performance	Pursue legislation to improve the performance of high-occupancy vehicle (HOV) lanes by ensuring greater compliance with passenger occupancy requirements. Explore various options, including but not limited to securing additional state funding for dedicated HOV-lane enforcement units, whether staffed by California Highway Patrol or local law enforcement; a citizen reporting line, similar to the HERO program established over 30 years ago in the State of Washington; and pilot programs to test the benefits of technology-based enforcement. Ensure MTC

		and other regional transportation agencies have a decision-making role in the selection of HOV segments to prioritize for additional enforcement efforts to ensure cost-effectiveness. Explore and pursue other creative options to improve compliance and performance of the lanes.
6. Bus Service	Authorize “bus-on-shoulder”	Support efforts to authorize buses to use the highway shoulder, known as “bus-on-shoulder” during periods of heavy traffic. This is currently allowed in 13 metropolitan areas in the U.S. (including Seattle, San Diego, Miami, Minneapolis/St. Paul, Atlanta, and the Washington, D.C. area) to help speed up bus service in highly-congested corridors. Require collaboration with the California Highway Patrol in the development of guidelines to determine which roadways qualify for the access to ensure public safety.
7. Active Transportation	Improve roadway safety for all users	In partnership with the City and County of San Francisco, San Francisco Municipal Transportation Agency, the City of San Jose and others, continue to support legislation to help achieve Vision Zero — aimed at eliminating all traffic-related serious injuries and fatalities. Support proposals to increase enforcement of traffic laws protecting pedestrians and bicyclists, including proposals to authorize automated speed enforcement on a pilot program basis, such as provided for in AB 342 (Chiu, 2017).

Shared Mobility	Support policies that enable technological innovations to improve mobility, while protecting the public’s interest	Monitor legislation and regulations related to shared mobility, such as transportation network companies and real-time carpooling, to ensure that mobility benefits are maximized, and access to critical data for transportation and land-use planning and operational purposes is assured.

Connected and Autonomous Vehicles	Monitor and engage in legislation and regulations to facilitate deployment of connected vehicles and autonomous vehicles	In partnership with Bay Area cities and counties, transit agencies, the business community, and other transportation organizations, engage in regulatory and legislative efforts related to connected and autonomous vehicles with the goal of accelerating their safety, mobility, environmental, equity and economic benefits. Similar to the “shared mobility” strategy, support access to critical data for transportation and land use planning and operational purposes.

Budget Narrowly Approved

On October 26th, the House voted 216 to 212 to pass the Senate's version of the 2018 Budget blueprint. This clears the way for Congress to pass a tax bill without Democratic support – the measure includes special procedural directives that will allow the Senate to pass a tax reform bill with a simple majority vote, rather than a 60-member threshold. The Budget also provides leeway for a tax plan to add up to \$1.5 trillion to the deficit over 10 years. The Senate passed their budget blueprint on October 19th on a 51 to 49 vote with a proviso that the House could take up the Senate Budget without appointing a House-Senate conference committee.

During the Senate's Budget debate, we worked with Senator Kamala Harris (D-Calif.) on an amendment to bolster the transit Capital Improvement Grant program, the funding source for New Starts transit projects. The only other amendment her office has introduced was related to funding for the Northern California wildfires. The Senate Democratic Leadership ultimately decided to prioritize only amendments directly related to tax reform, so neither of these amendments received a vote.

Autonomous Vehicle (AV) Legislation

Throughout October, we have worked with MTC staff and national partners to develop an amendment to the Senate's American Vision for Safer Transportation through Advancement of Revolutionary Technologies Act. The bill would establish a national framework for autonomous vehicle regulation and reaffirm federal authority over motor vehicle safety standards in order to facilitate testing and deployment on public roads across the United States. However, there is a concern that a section of the current bill language could expose reasonable state and local regulations, statutes, or policies related to traffic safety or congestion management to legal challenges. We are close to an agreement that would support final legislation that reaffirms the federal role in regulating vehicle safety while ensuring state and local governments continue to exercise traditional authority over the operation of vehicles on public roadways.

White House Signals Support for a Gasoline/Diesel Tax Increase

During the week of October 23, 2017, President Trump's Chief Economic Advisor, Gary Cohn told House Members that the Administration would be open to increasing the federal gasoline/diesel tax. Earlier in October, the Trump Administration signaled that Public Private Partnerships would not support the President's \$1 trillion infrastructure campaign promise.

House Transportation and Infrastructure (T&I) Committee hearing on Highways and Transit

On October 11th, I attended a House T&I Committee hearing on Highway and Transit infrastructure needs. Transit, highways, labor unions, manufactures, and the construction industry gave testimony. The bulk of the hearing centered on the need for additional federal funding and certainty.

- Geoff Anderson will be stepping down from his position as President and CEO of Smart Growth America in January 2018.
