








## **Revenue Generation — Simplified**


# **Funding Sources: Federal**

### Annual Revenue Amounts — 2016







# **General Process for Programming Funds**

- 1. Prepare program guidelines, typically approved by Commission
- 2. Conduct project selection or fund assignment process
- 3. Funding recommendations considered at Commission
- 4. Implement program/projects varies by program (file grant applications, allocate funds, enter into agreements, etc.)
- 5. Monitor, assess, adjust/amend
- 6. For state/federal competitive programs, MTC may endorse projects
- 7. Stakeholder outreach happens throughout process

# **Federal Programs**

## Transit Capital Priorities: \$475 M

- FTA formula funds apportioned by Urbanized Areas (UA)
- Based on operators' highest scoring needs (capped)
- Replacement of buses, trains, ferries and fixed guideway are highest priority

# **Specialized Programs – with Caltrans**

- **FTA 5310** senior, disabled, elderly transportation services and coordination
  - Approx. every two years, \$4 M/yr
- FTA 5311 Rural transit services
  - Annual program, \$2 M

# **One Bay Area Grant:**

### Funding: STP & CMAQ (Five years, FY 2018 – 22):

- Support the Sustainable Communities Strategy
  - Promote investment in Priority Development Areas
     (PDAs) and Priority Conservation Areas (PCAs)

### County Program: \$386 M

- Provides flexibility to spend on local priorities
- Incentivizes Housing
- Regional Program: \$476 M
  - Support regional initiatives and key programs

# **State Programs**

## **Active Transportation Program:**

- State program for bicycle/pedestrian focused projects
  - 50% Statewide Competitive Program
    - MTC region awarded \$32M out of \$132M (FY 2017)
  - 10% Small Urban and Rural Program
  - 40% Large Urbanized Areas (Regional) Program
    - MTC guidelines and scoring mirror state's, plus regional considerations
    - Regional program = approx. **\$20 M**

# State Transportation Improvement Program (STIP):

- State's five-year spending plan for State and Federal funding retained by the State
- 75% Regional Transportation Improvement Program (RTIP) – Programmed by regions / counties
- 25% Interregional Transportation Improvement Program (ITIP) – Programmed by state
- Approximately \$52 M annually Has been highly volatile; expected to stabilize and increase with SB1

# Major Funding Programs: Local / Regional

## Fund Estimate: \$654 M

- Adopted Annually
- Fund Sources = TDA, STA, AB1107, Bridge Tolls, LCTOP
- Basis for transit providers' budgets

## STA Population-Based: \$29M

- Part of Annual Fund Estimate
- Supports small operators, paratransit, Lifeline program, Clipper/511

## **Regional Measure 2:**

- Funds transit and highway projects in bridge corridors
- Capital program = 39 projects totaling \$1.5B (nearly complete)
- Operating program = 13 projects ranging from express and late night bus service to ferry service to metro service; \$43 M/yr

# Other Bridge Toll Programs: \$16M

• AB664, 2%-5% – Transit capital, ferries, Bay Trail

# **Examples of Special Studies and Policy Analysis**

### Transit Sustainability Project

- Analysis of transit operator cost effectiveness and efficiency, and service
- Requires transit operators to meet one of three performance targets related to cost containment

## Asset Management

- Manage StreetSaver software used by every Bay Area city/town to inventory road assets and conditions – annual Pavement Condition Index (PCI) report for best and worst roads
- Inventory of all transit assets in region required by FTA and used to assess maintenance needs/costs

## • **TIP Investment Analysis**

- TIP is a federally-required document, listing major regional projects (approx. 900)
- Every two years, analyze how region's investments are distributed including to minority and low income communities

# Transit Coordination

- SMART Bus coordination study
- BART-AC Transit fare coordination study

# **Upcoming Initiative Related to Housing Crisis**

- Per Commission direction, and consistent with CASA:
  - Staff to develop potential criteria to link housing performance (including production, preservation, and protection) with funding decisions, that would consider all funding sources
  - Complete by July 1, 2018 for public/stakeholder and Commission review
- Past housing-related actions have included:
  - Direct investment (modest) example: TOAH program
  - Funding conditions (significant) example: OBAG county program
  - Rewards (in the middle) example: "80k x 2020" program







#### RE: 2018 Draft MTC/ABAG Joint Advocacy Program

At the direction of the MTC and ABAG Legislation Committees' leadership, staff has developed the region's first joint advocacy program for the two agencies. Given that 2017 was such a banner year for transportation funding and affordable housing legislation, there's a good chance the Legislature and Administration may turn their attention to other matters in 2018. Nonetheless, with respect to housing, many of the legislators who authored bills that were enacted as part of the housing package indicated their intent to carry further legislation next year. In preparation for this, the draft program includes a number of housing policy items relevant to the addressing the region's housing shortage.

In addition to carrying forward longstanding goals from prior advocacy programs of the respective agencies, this draft seeks to help advance the underlying goals and action plan of *Plan Bay Area* 2040. The advocacy program serves as a public statement of the agencies' core legislative goals for the upcoming year, as well as a work plan to guide advocacy efforts in Sacramento and Washington, D.C. As bills are introduced, staff will return to the respective agencies' legislation committees to seek approval on specific bill positions that will subsequently be presented for approval to the Commission and Executive Board.

As part of our consultation and advisory process, staff will consult with various stakeholders over the next month. To date, staff has informally sought input for the 2018 Advocacy Program from the Housing Subcommittee of the ABAG Regional Planning Committee (RPC) and the MTC Policy Advisory Council. We also hosted a meeting of MTC's Partnership Legislative Committee to discuss MTC's ideas and hear about what staff from other transportation agencies, local jurisdictions and advocacy organizations are planning for next year. Staff also plans to formally present this document to the RPC and Policy Advisory Council over the next month. Based on discussion at your meeting and additional feedback received, staff will prepare a final 2018 Advocacy Program for your consideration at another joint meeting in December or January, depending on schedule availability, prior to final approval by the Commission and Executive Board.

We look forward to hearing your feedback and developing a more comprehensive Bay Area regional advocacy agenda for 2018.

#### CASA Steering Committee – September 27, San Francisco

We hosted the first meeting of the policy-level CASA Steering Committee here at the Bay Area Metro Center. While mostly an introductory session, I was pleased with the significant turnout of members, including dual MTC/ABAG board members Cortese, Mackenzie, and Pierce, MTC Commissioner Schaaf, and ABAG Board Member Julie Combs. The next regularly scheduled meeting of the committee will be in January 2018.

#### Polling on Gas Tax Repeal – October 2, Newport Beach

A statewide poll has found that 54% of California voters would vote against a possible ballot measure to repeal the taxes and fees contained in the Senate Bill 1 transportation funding package approved by the Legislature earlier this year. The cross-tabs reveal that the level of opposition among regions of the state is highest in the Bay Area at 60%.

#### State of the Estuary Conference – October 10-11, Oakland

Kudos to the San Francisco Estuary Program for another stellar conference that drew hundreds of participants to the Scottish Rite Temple in Oakland. I attended a provocative panel discussion involving Resources Agency Secretary John Laird, Assemblyman Rob Bonta of Alameda, and ABAG Board Member Dave Pine.

#### Bay Area Partnership – October 20, San Francisco

The latest meeting of the multi-agency Bay Area Partnership was focused on two programs that will see dramatically augmented funding levels from the passage of SB 1: the State Transportation Improvement Program (STIP) and the State Transit Assistance (STA) program. You have a committee recommendation before you today on our proposal to link STIP funding to housing production. The STA policy issues will be arriving at your doorstep by the end of the calendar year.
