Biographies of the Policy Advisory Council candidates'

Nominees for Chair:

Randi Kinman, a former planning commissioner for the City of San Jose, worked as a volunteer in the City of San Jose's Strong Neighborhoods Initiative program. She represents and works with communities of color and low income individuals, developing residents' leadership skills while providing training and education. Ms. Kinman is currently chair of both the Sherman Oaks Neighborhood Association and the Burbank/Del Monte Neighborhood Advisory Committee, as well as a trustee for the West Valley-Mission Community College District. She has served as chair of the Policy Advisory Council and chaired the Regional Transportation Plan 2035 Equity Analysis subcommittee that supported inclusion of a snapshot analysis of data gathered on regular intervals between regional transportation plans.

Nominees for Vice Chair

Carlos Castellanos has worked in the Bay Area for over 20 years in the fields of planning and housing. The director of housing development for MidPen Housing Corporation-one of the nation's leading nonprofit developers, owners and managers of high-quality, affordable housing-Mr. Castellanos has a Master's degree in city planning and transportation engineering. He is experienced in working with local jurisdictions, labor unions and businesses to promote and achieve local and disadvantaged population hiring goals. He was a member of MTC's Minority Citizens Advisory Committee, where he chaired the Regional Transportation Plan 2035 Equity Analysis subcommittee and served on the subsequent Equity Analysis subcommittee that supported inclusion of a snapshot analysis of data gathered on regular intervals between regional transportation plans.

Cynthia L. Murray is the CEO of North Bay Leadership Council, representing employers in Marin, Sonoma and Napa counties. Her expertise is in transportation, housing, sustainability, and economic competitiveness. As a former Marin County Supervisor and Novato Councilmember, she has years of experience in land use and transportation planning, and has served on local transportation boards including the Transportation Authority of Marin, Golden Gate Bridge Highway & Transportation District, and SMART. She led the campaign to include and pass the SMART train on the 2008 ballot and continues to fight to address local problems with Highway 37 and secure funding to widen Highway 101 through the Narrows.



RE: Futures Overview

Since early 2010, MTC and ABAG staff have focused significant resources on the technical analysis, local engagement, and public outreach necessary to produce the integrated Regional Transportation Plan/Sustainable Communities Strategy (RTP/SCS). The culmination of these efforts – Plan Bay Area (2013) and Plan Bay Area 2040 (2017) – have moved toward a regional consensus on broadly-shared principles such as focused growth, investment in alternatives to single-occupant vehicles, and "fixing it first" before expanding the system – all with an aim of reducing per-capita greenhouse gas emissions and housing the region's population.

At the same time, statutory constraints on the RTP/SCS can make it challenging to explore the growing number of pressing issues facing Bay Area residents and policymakers. Political, economic, environmental, and technological uncertainties suggest a new approach that acknowledges risk factors rather than holding them constant across all scenarios evaluated (e.g., housing control totals, tax revenues, or the market share of autonomous vehicles). Peer agencies in Philadelphia, Chicago, and Atlanta have pioneered a "futures"-based planning approach to go beyond the statutorily-required process.

Topics to be Explored through *Futures*

External forces – such as new technologies, unexpected natural or manmade disasters, economic booms and busts, and political volatility – may fundamentally alter the region's trajectory and its policy responses through 2050. Integrated Planning Program staff have developed an 18-month "blue sky" planning effort (tentatively titled *Futures*) to tackle a suite of challenging questions that transcend the traditional RTP/SCS framework, including:

- What might different levels of autonomous vehicle adoption in coming years mean for our pipeline of traditional transportation investments and should we change course?
- What strategies should we consider to better prepare our built infrastructure including housing and job centers for increasingly-frequent disasters?
- How should the Bay Area respond if economic output, population, and employment suddenly boom or bust are certain projects more or less effective in that case?
- What actions can the Bay Area take to improve our resilience to national and international geopolitical and economic shifts?

Futures is not a visioning exercise – the intent would not be to choose a preferred scenario for advancement into the RTP/SCS. Instead, *Futures* would allow policymakers, planners, and the public to explore multiple sets of external conditions and think through policy and investment solutions that make sense in each distinct future. Ultimately, policies and projects that make sense across multiple futures – thus demonstrating their resilience to potential headwinds – would be considered top

priorities for incorporation in the next RTP/SCS. That separate but closely related effort would kick off in mid-2019 at the conclusion of *Futures*, with a "preferred scenario" identified by early 2020 - a process that would be informed by the three *Futures* initiative components below.

Components of the Futures Initiative

- 1) *Futures Planning* In lieu of traditional scenario planning where funding and growth are distributed based on fixed control totals and fixed future assumptions, *Futures* will create a handful of divergent futures where the Bay Area must respond in very different ways. As discussed above, the purpose of this work would be to identify strategies and investments that allow the Bay Area to move forward with high-performing strategies and investments that perform well regardless of what happens in the decades ahead. Key milestones include:
 - Selection of specific futures for analysis: June 2018
 - Identification of current policy gaps for each future: September 2018
 - Collaborative development of policy solutions for each future: Fall 2018
 - Report detailing "win-win" strategies across futures: May 2019
- 2) **Project Evaluation** Expanding upon the project evaluation framework used in *Plan Bay Area* and *Plan Bay Area 2040*, major transportation investments will be evaluated across the various futures to better understand how they would perform with differing assumptions about autonomous vehicles, overall regional growth, gas prices, and other traditionally exogenous factors. Key milestones for this work include:
 - Finalization of project evaluation framework: July 2018
 - Release of draft project performance results: March 2019
 - Approval of final project performance results: June 2019
- 3) *Policy Analyses* To address a limitation of past planning cycles where individual policies were not explored in depth outside of the scenarios framework, staff proposes to conduct roughly five to seven analyses of broad, topical focus areas. The primary objective of each analysis will be to identify high-impact policies related to that topic area that support the region's guiding principles. To be released at events across the nine-county region, topics will include the following:
 - Autonomous vehicles & future mobility: June 2018
 - Travel demand management & climate mitigation: September 2018
 - Regional growth strategies: December 2018
 - Future of jobs: March 2019
 - Regional governance: June 2019
 - Design & better buildings: September 2019

Public outreach, combined with ongoing stakeholder engagement, will inform each of the three components. The initial round of outreach, commencing this month, will include pop-up events across the region to "meet people where they are", combined with an online survey. Input received from the public will be a primary input when developing the guiding principles of *Futures*.

Staff anticipates that social equity will emerge as one of the core guiding principles for the *Futures* initiative, which means it will be carefully considered across the suite of project deliverables. Engaging a diverse cross-section through public outreach is critical to the success of this effort, with a focus on communities of concern and younger generations. Furthermore, analysis of divergent futures will not only quantify regionwide performance outcomes in each future, but also consider how the conditions in each future affect different cross-sections of our diverse region.

Integrating Related Planning Processes into *Futures*

- **Housing:** Staff will work to incorporate consensus recommendations from the ongoing CASA Committee to House the Bay Area process, which seeks to increase housing production at all levels of affordability, preserve existing affordable housing, and protect vulnerable populations from housing instability and displacement. CASA's final report is slated for release in late 2018.
- **Resilience:** Sea level rise mapping from the Adapting to Rising Tides project, combined with adaptation strategies identified through case studies, will be used to develop appropriate adaptation strategies unique to each future. Earthquakes such as potential earthquake scenarios explored through the HayWired project and other natural disasters will also be integrated into each future to explore potential policy responses under varying circumstances.

Next Steps

In the coming months, staff will reach key milestones on several major deliverables currently underway:

- April: guiding principles across all futures; initial public engagement/outreach
- June: policy analysis #1 (autonomous vehicles) recommendations; proposed futures for further study; overview of project evaluation process
- September: policy analysis #2 (resilience) recommendations; midpoint report on futures analysis; overview of fall 2018 collaborative workshops

Staff looks forward to the committee's input on the proposed Futures effort.

Background

State and federal statutes require metropolitan planning organizations such as MTC to adopt participation plans to provide the public and stakeholders with opportunities to be involved in the transportation planning process. MTC's current <u>Public Participation Plan</u> (PPP) was adopted in 2015 and informs interested residents on how to engage in the range of MTC's planning and funding allocations. Appendix A to the Public Participation Plan highlights planning and decision milestones, and public engagement opportunities, for Plan Bay Area 2040 — the region's last long-range transportation and land-use blueprint.

For the past two planning cycles, MTC and ABAG have engaged in more traditional planning and outreach techniques and strategies for both Plan Bay Area (adopted in 2013) and Plan Bay Area 2040 (adopted in 2017). However, given the ever-changing economic, technological and climate conditions in the Bay Area, a more innovative planning and engagement program is warranted, one that can assist with analyzing a range of future impacts and developing solutions to these impacts. This upcoming planning and outreach effort (tentatively titled *Futures*) will help to create a broad range of options for the Bay Area. Although a separate effort, the results of the *Futures* work will inform the next Regional Transportation Plan/Sustainable Communities Strategy (RTP/SCS), tentatively being referred to as "Next Plan."

With work on *Futures* and the Next Plan slated to begin in early 2018, staff will release a draft update to the PPP this spring. This memo provides an overview of the anticipated process and schedule for this public engagement blueprint (Attachment A).

Proposed Approach

We are conducting some research now to inform the PPP update. Inputs include or will include:

- Reviewing recommendations from an evaluation of Plan Bay Area 2040 public engagement activities, including conducting calls with other metropolitan planning organizations and partner agencies to inquire about public engagement best practices;
- Implementation of an online and paper survey to ask the best methods to engage the public, partner agencies and stakeholder groups. This survey is available in English, Chinese and Spanish and sent/distributed to stakeholder groups, interested parties and the public in January 2018;
- Conducting focus groups with representatives from community-based organizations in low income communities and communities of color, along with other stakeholder groups to request input; and
- Presentations at MTC's Policy Advisory Council, among other committees, to request input.

Presentation at February Meeting

At your February meeting, we hope to hear your ideas about public engagement methods. In particular, we hope to hear:

- How best to present detailed investment and policy choices in a way that is transparent;
- Which specific techniques or initiatives that have worked well for your agency or community in engaging the public on planning issues;
- Ideas for meaningful comment opportunities that go beyond public meetings;
- How social media or other online forums have assisted your public engagement efforts;
- Preferred methods for receiving updates about the process; and
- Ways that your agency or organization might assist MTC and ABAG in disseminating information about the Next Plan.

MTC and ABAG anticipate an extensive outreach effort with local governments (cities, counties, congestion management agencies, and transit agencies) and the public as part of the process of developing *Futures* and the Next Plan. We hope to use new/innovative public engagement methods, and we would like your input and experience with use of more non-traditional engagement strategies. We look forward to hearing your input.

Public Participation Plan Implementation Plan Schedule

Updating the PPP can be viewed as a key first step to making the update to Plan Bay Area 2040 transparent and accessible. We look forward to hearing your ideas on how to have a productive dialogue on transportation and land-use issues impacting the region in a way that encourages all to participate. Key dates leading up to adoption of the Draft PPP are listed below.







• FTA Warning Shot, December 29, New York

A recent letter from the Deputy Federal Transit Administrator to a key New York state official expresses numerous concerns about the ongoing project to construct another set of rail tunnels under the Hudson River to serve New York City. The existing tunnels are over 100 years old. This is probably the most important transit project underway in the country, and the letter appears to signal that the Trump Administration has found yet another policy area in which to reverse course from its predecessor. This is a worrisome development for major capital projects nationwide.

• CASA Technical Committee, January 17, San Francisco

The CASA Technical Committee met at the Bay Area Metro Center to discuss potential elements of a "grand bargain" of policy initiatives that would make progress on the 3 P's that we have focused on throughout the CASA project: protection of current tenants, preservation of existing affordable housing, and production of more housing for residents of all walks of life. The CASA Steering Committee will take up the same conversation at its next quarterly meeting on January 24.


Map of the Month: State Gas Tax Increases Since 1993

Each month Executive Director Steve Heminger presents a new map to the Commission to help explain important trends in the Bay Area, across the nation and around the world. Below is the January 2018 Map of the Month: *State Gas Tax Increases, 1992 - 2017.*

With passage of SB 1 in 2017, California has joined the ranks of 38 states – both red and blue – and the District of Columbia that have stepped up in the face of Congressional inaction and passed legislation to raise their own state gas taxes since Congress last did so in 1993. This map reaffirms that infrastructure investment can, and often does, transcend party lines, or as Norm Mineta used to say: "There is no such thing as a Democratic bridge or a Republican road." The largest transportation investment in state history, SB 1 will invest \$52 billion in California's roads, bridges and transit systems over the next decade with ongoing annual revenues of over \$5 billion per year thereafter.

Glossary of Transportation Planning Acronyms and Terms February 2018

(CASA) Committee to House the Bay Area	A diverse, multi-sector set of partners from across the Bay Area convened by MTC to build an actionable political consensus around increasing housing production at all levels of affordability, preserving existing affordable housing and protecting vulnerable populations from housing instability and displacement. It is structured around a Steering Committee and Technical Committee composed of leaders from the region's private, philanthropic, governmental and nonprofit sectors, including social equity and environmental advocates, the business and technology communities, labor groups, market rate and affordable housing developers, and representatives from across the region.
(EIR) Environmental Impact Report	State law requires that an EIR shall be prepared if there is substantial evidence that a project may have a significant effect on the environment. A draft EIR shall be included as part of the review and approval process whenever a public hearing is held on the project. Following adoption of a final EIR, the lead agency makes a decision whether to proceed with the project.
(FTA) Federal Transit Administration	U.S. Department of Transportation agency that provides financial and planning assistance to help plan, build and operate rail, bus and paratransit systems. The agency also assists in the development of local and regional traffic reduction programs.
(GHG) Greenhouse Gases	Any of the gases — including carbon dioxide, methane and ozone — whose absorption of solar radiation is responsible for the greenhouse effect, in which the atmosphere allows incoming sunlight to pass through but absorbs heat radiated back from the earth's surface. Greenhouse gases act like a heat-trapping blanket in the atmosphere, causing climate change.
The HayWired Earthquake Scenario	A joint project with the U.S. Geological Survey to study regional impacts from magnitude 7.05 earthquake on the Hayward fault, and inform the policy discussion about economic resilience
(MPO) Metropolitan Planning Organization	A federally required planning body responsible for the transportation planning and project selection in its region. MTC is the nine-county San Francisco Bay Area's MPO.
(PPP) Public Participation Plan	The Public Participation Plan is adopted by MTC and updated on a regular basis. It provides important information on how you can get involved in transportation planning and funding decisions. This plan is required by state and federal law, and is intended to promote an open and transparent process.
(RHNA) Regional Housing Needs Allocation	The Regional Housing Needs Allocation process is a state mandate regarding planning for housing in California. ABAG is responsible for allocating this state-determined regional housing need among all of the Bay Area's nine counties and 101 cities. Factors used by ABAG in its allocation process include projected household growth, existing employment and projected employment growth, and projected household and employment growth near transit.

(RM3) Regional Measure 3	In 2017, the Legislature approved SB 595 (Beall), which authorizes a new ballot measure, known as Regional Measure 3 (RM3) that could increase tolls on the region's seven state-owned toll bridges for the first time since 2010. If approved by a majority of voters in Alameda, Contra Costa, Marin, Napa, San Francisco, San Mateo, Santa Clara, Solano and Sonoma counties, revenues from a toll increase of up to \$3 would be used to finance a \$4.45 billion slate of highway and transit improvements in the toll bridge corridors and their approaches.
(RTP) Regional Transportation Plan	A master plan to guide the region's transportation investments for at least a 20-year period. Updated every four years, it is based on projections of growth in population and jobs and the ensuing travel demand. Required by state and federal law, it includes programs to better maintain, operate and expand transportation. The Bay Area's long-range regional transportation plan (RTP) and sustainable communities strategy (SCS) is known as <u>Plan Bay Area 2040</u> .
(RTP/SCS) Regional Transportation Plan / Sustainable Communities Strategy	The Sustainable Communities Strategy (SCS) is an integrated land use and transportation plan that all metropolitan regions in California must complete under Senate Bill 375. In the Bay Area this integration includes ABAG's Projections and Regional Housing Needs Allocation (RHNA) and MTC's Regional Transportation Plan (RTP).
(SB 1) Senate Bill 1	SB 1 – the Road Repair and Accountability Act of 2017 – was passed by a two-thirds majority in the California Legislature and signed into law by Governor Jerry Brown. As the largest transportation investment in California history, SB 1 is expected to raise \$52.4 billion for transportation investments statewide over the next decade.
(SB 375) Senate Bill 375	Senate Bill 375 (Steinberg) became law in 2008. It includes two main statutory requirements and a host of voluntary measures. It is designed to complement AB 32, which requires the state to reduce its GHG emissions to 1990 levels by 2020. The first requirement is to reduce per-capita carbon dioxide (CO2) emissions from cars and light duty trucks, primarily by building more compact communities with better access to mass transit and other amenities, so people have more transportation choices and do not have to drive as much. The second requirement is to house 100 percent of the region's projected 25-year population growth, regardless of income level.
