Attached are the BATA financial statements for the eight month period ending February 2018 (67% of the budget year). Major highlights of the eight month statement include:

(1) **Revenues**: Toll bridge revenue generated for the first eight months of the fiscal year is \$480 million which is slightly below the budget by 0.7%.

Total interest revenue earned at the end of February is \$22 million, about \$10 million higher than the budget as a result of higher interest rates. Year to date (YTD) violation revenue is \$15.5 million, about the same amount as this time last year.

The YTD Build America Bonds subsidy payments from the U.S. Government remained at \$48 million at the end of February. Overall revenue for the first eight months is \$574 million, about 69% of the total budgeted revenue for the fiscal year.

- (2) **Expenses:** Total expenses of \$239 million is 29% of the total budget. Expense activity will pick up later in the year as debt service payments and contract services come due.
- (3) **Transfers to MTC and SAFE**: The budgeted annual 1% administration fee for MTC and operating contribution to SAFE were transferred at the beginning of the new fiscal year. Total amount transferred for the 1% administration fee was \$7.5 million, while the contribution to SAFE was \$200,000 for FY 2017-18.
- (4) **Contract carryover encumbrances**: Funds totaling \$1.5 million from FY 2016-17 were added to the budget as prior year contract carryover encumbrances.

Staff requests approval of a contract amendment with Zoon Engineering, Inc. (Zoon Engineering) for on-call construction management services for integration of toll bridge rehabilitation construction on the San Francisco-Oakland Bay Bridge (SFOBB) Seismic Replacement Project in an amount not to exceed \$350,000.

Staff is proposing to maintain a minimal level of Zoon Engineering construction management support to aid toll bridge rehabilitation program funded projects being constructed as part of the SFOBB East Span Replacement Project. Rehabilitation funded scope includes parking improvements at the Oakland Touchdown, work on Yerba Buena Island, and other rehabilitation work. Zoon Engineering will provide construction management, inspection, documentation, coordination and administration support.

Background

In January 2014, after a competitive procurement, this Committee authorized the Executive Director to enter into contracts with eight firms, including Zoon Engineering, to provide on-call construction management services. Zoon Engineering was selected to provide construction management support for oversight of the rehabilitation work due to its extensive specialized experience on large toll bridge structures dealing with traffic control, electrical inspection, and integrating electrical components and construction management on the entire SFOBB.

Zoon's current contract amount is \$1,960,000. Staff proposes to amend its contract to continue its existing work scope in an amount not to exceed \$350,000. Staff is requesting an additional \$350,000 for Zoon Engineering to continue to support work through FY 2018-19 for such projects as parking improvements at the Oakland Touchdown and work on Yerba Buena Island being constructed as part of the east span replacement project. Attachment A includes a summary of Zoon Engineering's small business and disadvantaged business enterprise status.

Recommendation

Staff recommends that the Committee authorize the Executive Director or his designee to negotiate and enter into a contract amendment with Zoon Engineering to perform on-call construction project management services for integration of rehabilitation work on the SFOBB, in an amount not to exceed \$350,000.

This memorandum requests approval of a pre-qualified panel of consulting firms to provide oncall toll bridge asset management program support services for the seven state-owned toll bridges in the San Francisco Bay Area for a two-year period ending April 14, 2020.

Background

On January 24, 2018, BATA issued an Request for Qualifications (RFQ) to select a panel of prequalified consulting firms to provide on-call asset management program support for the seven state-owned toll bridges ("Bridges"). Caltrans continues to own and operate the Bridges and will continue in its role as such, including inspecting, maintaining, and rehabilitating the Bridges. The pre-qualified panel is intended to provide BATA with outside expertise on bridge management and to supplement Caltrans' asset management efforts. Caltrans is supportive of BATA providing supplemental support for this effort on the Bridges. The selected panel of firms would be on-call starting April 15, 2018 for a two-year term. The first set of contracts would be executed under this procurement in May 2018 as work is identified. Not all firms would be immediately under contract.

BATA anticipates that the following tasks will be assigned under this procurement: providing program and project management support, updating toll bridge asset inventory, collecting and archiving as-built records of toll bridges and related facilities, prioritizing preservation activities, developing/implementing asset management plan(s), systems and practices, reviewing rehabilitation plans, and assisting and performing site investigations of the bridges, including suspension cables, post-tensioning strands, structural paint/coatings, and other bridge components.

BATA has budgeted two million dollars (\$2,000,000) in the Toll Bridge Rehabilitation Program for this effort. Additional funding may become available in future fiscal years subject to approval of future BATA budgets.

Procurement Process

In response to the RFQ, staff received Statements of Qualifications (SOQs) from a total of six consulting firms. All firms were found to meet the minimum qualifications. An evaluation panel consisting of BATA and Caltrans staff reviewed all of the SOQs and scored them based on

weighted evaluation criteria including the firm's and staff's expertise and experience, qualifications of key staff, availability of staff, and communication ability. Based on the evaluation, staff recommends selecting all firms to provide BATA with the most flexibility for successful project delivery. The proposed consultants (in alphabetical order) are as follows:

All selected firms submitted very strong SOQs and have extensive experience and expertise. All of these firms have available resources and local offices, which will allow BATA to quickly access technical assistance as needed. All selected firms demonstrated strong qualifications of key staff and a depth of specialized expertise within their project teams to cover all areas in relation to the scope of work. Attachment A includes a summary of the selected firms and their project teams' small business and disadvantaged business enterprise status.

Recommendation

Staff recommends that this Committee approve the pre-qualified pool of firms identified above to provide on-call toll bridge asset management services for a two-year term from April 15, 2018 through April 14, 2020. Staff will return to this Committee for contract approval in each instance in which a contract or amendment exceeds the Executive Director's delegated signature authority.

This item would authorize the Executive Director or his designee to issue a purchase order in an amount not to exceed \$3,238,183 to TransCore LP to purchase FasTrak® Flex toll tags, subject to approval of future BATA budgets.

Background

In April 2016, BATA issued an Invitation for Bid (IFB) to procure FasTrak® Flex toll tags to support the regional Express Lanes operations through June 2018 until the state-wide transition to 6C protocol. The IFB allowed for BATA to procure a base amount of 568,000 Flex tags (355,000 non-retail Flex toll tags and 213,000 retail flex tags). The IFB also allowed for an option to purchase an additional 200,000 Flex tags to be executed by June 2018.

In June 2016, this Committee authorized a purchase order to TransCore LP to purchase the base tag quantities. Staff is now requesting approval to exercise the option to purchase the remaining 200,000 tags available under the IFB. This will allow sufficient supply of tags until receipt and validation of 6C Flex tags which are anticipated to be delivered in early 2019. This quantity will also allow six to nine months of additional supply if there are unanticipated delays in receiving 6C Flex tags.

Recently adopted regulations require all California tolling agencies to ensure that their tolling systems are able to read 6C protocol toll tags by January 1, 2019 and may begin issuing 6C toll tags, though the current Title 21 toll tags may continue to be used until 2024. BATA plans to begin a procurement for 6C Flex tags in the upcoming months. The vendors are still ramping up for the California market and 6C Flex tags are in the testing and certification stage.

To ensure a continuous supply of Title 21 Flex tags until the procurement of 6C tags is completed and 6C Flex tags can be delivered to BATA, staff is requesting authorization to purchase the remaining 200,000 option quantities on the IFB. Staff is currently forecasting a need of 170,500 non-retail Flex tags and 29,500 retail Flex tags for a total cost of \$3,238,183.

Recommendation
