






Where do Bay Area residents experience the most traffic frustration?













Casual Carpool Destinations in SF (Zip Codes)

Survey Findings

- A third of respondents casual carpool 5 days a week in the morning; a quarter casual carpool 5 days a week in the evening.
- 71% of casual carpoolers travel to downtown San Francisco; 23% travel to other parts of San Francisco; 6% travel outside of San Francisco.
- The most popular reasons passengers use casual carpool are to save time and money.
- 50% of users learned about casual carpool through a friend or family member.
- Covered shelter, lighting, and improved signage would improve casual carpool locations.

Summary

Similar to past long-range planning cycles, staff is proposing to conduct a project performance assessment of major transportation investments as part of both *Horizon* and *Plan Bay Area 2050*. This effort would seek to identify high- and low-performing projects both to understand the efficacy of specific projects under varying external conditions (i.e., futures) and to inform the development of the Preferred Scenario's transportation investment element. In the coming weeks, staff proposes to begin updating information on projects included in *Plan Bay Area 2040* first and to initiate the submission process for transformative investments in early June. Opportunities for input on the specific project performance methodologies will occur at RAWG meetings this summer.

Background and Proposed Approach

Plan Bay Area 2040 was the region's second long-range plan with a comprehensive evaluation of uncommitted transportation investments, scoring them with a quantitative benefit-cost ratio – evaluated using Travel Model One – and a qualitative targets score based on the adopted performance targets of that plan. The project performance assessment helped to identify 11 high-performing projects that were prioritized for regional discretionary funding in the Plan and 18 low-performing projects that were subject to further scrutiny through the compelling case process. The project performance assessment helped to identify the most effective investments and provide a transparent process to redirect billions of dollars from low-performing projects to higher-performers, given the fiscally-constrained nature of the Plan. For those seeking additional information on this effort, documentationⁱ and final resultsⁱⁱ can be found on MTC's website.

Staff recommends conducting a third cycle of project performance assessment using a methodology that would be consistent between *Horizon* and *Plan Bay Area 2050* to ensure comparable results. Each project would be evaluated in the following ways:

- Benefit-cost assessment using Travel Model Two (primary assessment)
- Guiding principles assessment using qualitative criteria (secondary assessment)
- Supplemental assessments: project-level equity analysis; benefit-cost confidence assessment (similar to Plan Bay Area 2040)

Key enhancements/changes from *Plan Bay Area 2040* are highlighted below:

- Analysis of each transportation project in each future (i.e., four benefit-cost ratios rather than just one) this will allow stakeholders to understand how a project would be more or less effective under different external conditions (autonomous vehicle fleet penetration, population/employment, gas prices, etc.). It will also allow for identification of high-performers as projects that are most resilient to changing conditions, rather than a single set of assumptions.
- Use of Travel Model Two to incorporate wider range of impacts upgrades to include autonomous vehicles, TNCs, transit crowding, and other new features will improve our ability to forecast a broader spectrum of benefits; further methodology upgrades to the benefit-cost tool (CoBRA) can be considered this summer.
- **Reforms to the qualitative assessment** in lieu of the targets assessment, a new "guiding principles assessment" would use qualitative criteria to identify how a project would affect the Guiding Principles being developed for *Horizon*. Unlike past cycles, the assessment would be used solely to flag projects that do not support one or more of the Guiding Principles. It would play a secondary role compared to the benefit-cost analysis.

Staff is currently looking for input on the revised framework at this time and will return to RAWG this summer for input on the specific methodologies for each component of the *Horizon / Plan Bay Area 2050* Project Performance Assessment. Staff will also be seeking input on the project performance framework from the MTC Planning Committee in June or July, given their interest in both the benefit-cost and targets assessments during *Plan Bay Area 2040*.

Projects Subject to Performance Assessment

Prior cycles of project performance focused on uncommittedⁱⁱⁱ capacity-increasing projects with costs^{iv} greater than \$50 million (in *Plan Bay Area*) or \$100 million (in *Plan Bay Area 2040*). Staff proposes to raise the threshold for major projects subject to analysis this cycle and establish two cost tiers:

- Tier 1 major projects greater than \$1 billion
- Tier 2 major projects greater than \$250 million but less than \$1 billion

Staff is also looking for input on how to ensure that project costs for new transportation investments ensure that the facility will be protected from sea level rise through year 2100°, either through project sponsor confirmation of adaptation features or MTC/ABAG-BCDC analysis this summer to assign additional costs to projects in zones at risk.

Several other project types would also be subject to project performance under this proposal:

• A package of lower-cost projects (e.g., a network of rapid bus lines) that all fall below the \$250 million threshold could be evaluated concurrently in either round of analysis.

iii Uncommitted projects are projects that are seeking discretionary funding (i.e., not fully funded), are not yet under construction, and are not 100% funded with local dollars.

^{iv} Costs were defined in 2013 dollars for *Plan Bay Area* and 2017 dollars for *Plan Bay Area* 2040. Costs will be in 2021 dollars for *Horizon* and *Plan Bay Area* 2050. Costs include capital costs and gross operating & maintenance costs between years 2021 and 2050.

^v Per BCDC guidance, transportation projects that would still be operating through 2100 should be prepared for sea level rise ranging from 3 feet to 10 feet above today's mean higher high water level.

- Non-capacity increasing resilience projects (i.e., investments needed to protect a preexisting transportation facility from inundation by 2050^{vi}) would be identified by
 MTC/ABAG in collaboration with BCDC and the asset owner/operator for evaluation
 using the same framework as capacity-increasing projects.
- Operational strategies (e.g., comprehensive road pricing) with costs below the thresholds identified above would be accepted through the Transformative Investments Request process; a small number of the most promising strategies (~5) would be evaluated using the same framework as capital and operating projects.

Transformative Investments Request & Submission Process

Given that the Project Performance Assessment will stretch between spring 2018 and fall 2019 and straddle both long-range planning efforts, staff proposes to break the process into phases as shown in the table below. In addition to a multi-phase process with a more limited number of projects in each phase, staff also plans to allow non-government agencies to submit visionary projects for consideration in the Project Performance Assessment this summer. Major transit operators also would be able to submit directly to MTC.



Transformative Investments Submission How Will Projects from Public Be Selected?

- In September, a "jury" of publicand private-sector experts will review projects & strategies proposed by the public to identify the best ideas that merit further evaluation.
- Criteria will be identified at a future RAWG meeting, but feasibility/deliverability, alignment with Guiding Principles, and potential efficacy in solving regional challenges would likely be considered when narrowing down the list.



Integrating Resilience Investments

- Given the scope of Horizon and Plan Bay Area 2050, MTC/ABAG is interested in evaluating noncapacity-increasing projects that are specifically designed to improve resilience of the system, in particular to address sea level rise.
- Facilities at the highest level of risk through 2050 include: SR-37, SR-237, US-101 (Marin, San Mateo, Santa Clara), bridge approaches, and several transit facilities.
- Open question: should resilience projects unrelated to transportation infrastructure be assessed through this element of Horizon/PBA 2050 as well?



Integrating Operational Strategies

- For Horizon, staff is also interested in exploring transportation strategies that are operational in nature, with costs below the project performance cost thresholds but with significant regional impacts.
- Similar to projects submitted by the public, the "jury" of experts will select a handful of the most promising operational strategies for analysis.
- Example strategies:
 - Odd-even license plate days
 - Comprehensive speed camera network
 - Significant vehicle VMT tax
 - Regional ban on gas/diesel-powered vehicles

Work Plan Recommendations

MTC Regional Advisory Working Group

The Regional Advisory Working Group (RAWG) plays a key role in the development process for the Horizon initiative and Plan Bay Area 2050. Council members are invited to attend RAWG meetings if you want to follow these long-range planning efforts more closely. RAWG will meet nearly monthly throughout much of the Horizon and Plan Bay Area 2050 development process. Work on Plan Bay Area 2050 will begin June 2019 and equity analyses are currently scheduled to begin early 2020.

RAWG has no set membership, but includes local city and county staff as well as staff from county Congestion Management Agencies, transit operators and county health departments. Representatives from other advocacy groups and interested local residents also attend. Because it is primarily a staff-to-staff group, RAWG meets during the workday and their agenda will include more technical topics than what will be presented and discussed at meetings of the Policy Advisory Council. RAWG meetings are audiocast over the Internet and archived on the web. Please check the MTC meetings page for upcoming RAWG meetings.

MTC College Summer Internship Program

Bay Area's 511 Service Now Available on Amazon Alexa Devices

MTC has added another feature to the Bay Area's 511 traveler information system by integrating two of the most popular 511 features — traffic conditions and real-time transit departure times — with Amazon's virtual personal assistant, Alexa. Bay Area travelers can now get this information on any Alexa-enabled device, including an Echo, Dot, or Tap.

Once an Alexa-enabled device is set up, transit riders should go to the 511 SF Bay skill page on Amazon and click "Enable," and then ask Alexa for departure times using their stop ID. 511 provides departure times for nearly 20 Bay Area transit agencies, including BART, Muni, Caltrain, and AC Transit. Transit riders can look up their stop ID in the 'Transit Departures' tool on 511.org. Drivers can ask Alexa for information about traffic conditions before heading out by saying the name of a Bay Area highway, bridge, city, or hotspot (such as an airport, stadium, or landmark). The 511 SF Bay Alexa skill provides incidents, road closures, construction announcements, and slowdowns. Traffic-condition locations available on Alexa can be found at 511.org.

Tour of the New Salesforce Transit Center

The Transbay Transit Center, now called the Salesforce Transit Center, is set to become fully operational later this year. The construction is governed by the Transbay Joint Powers Authority, and the structure will be the city's transportation hub, eventually including Caltrain and high-speed rail. A tour of the new Transit Center is being scheduled for members of the Council on July 11th at 3:00 p.m., following the July Council meeting. The tour will be limited to 12 members; a second date will be scheduled soon. Expect more information at a later date. SMART Gets Larkspur Funding, April 9, Washington DC

The U.S. Department of Transportation (DOT) announced that Sonoma-Marin Area Rail Transit (SMART) received its long-delayed grant of \$22 million to extend the rail service from San Rafael to the Larkspur Ferry Terminal - only a boat ride away from San Francisco. MTC is the other major funder for the extension with Regional Measure 2 toll funds.

Measure AA Funds Hit the Street, April 11, San Francisco

The governing board of the San Francisco Bay Restoration Authority has allocated the first \$18 million in grants from the nine-county parcel tax approved by the voters in June 2016. 
Richmond Bridge 3rd Lane, April 20, San Rafael

Commissioners Connolly, Glover, and Worth were on the dais at the ribbon-cutting event for opening the "running lane" on the shoulder of the lower deck of the Richmond-San Rafael Bridge. The lane opened later that day during afternoon commute hours. Still under construction is the bicycle/pedestrian path on the shoulder of the upper deck. The bike path is slated for completion later this year.

Map of the Month: The High Stakes of Census 2020

Each month Executive Director Steve Heminger presents a new map to the Commission to help explain important trends in the Bay Area, across the nation, and around the world. April's Map of the Month highlights potential issues with the Census Bureau's recent decision to include a question about citizenship in the upcoming 2020 Census. Though the issue of adding this question to the census largely has been thought of as a partisan one, a deeper investigation reveals there may be consequences for both parties. The map uses data from the Census Bureau's new Response Outreach Area Mapper (ROAM) and shows predicted mail non-response rates. The darker blue areas depict low mail-in response areas. While these areas tend to be most concentrated in immigrant-dense areas along the West Coast, battleground states like Colorado and Florida as well as states like Mississippi and the Carolinas with difficult-to-reach populations could also be adversely affected. Undercounts in those areas may lead to loss of congressional seats in states that might otherwise expect to gain seats after the 2020 Census. Undercounts also would lead to a loss of funding for states, since many federal programs base funding on population counts.
