This memorandum requests Committee approval for MTC to enter into a contract amendment with CH2M Hill, Inc. (CH2M Hill) in an amount not to exceed \$600,000 for continued technical oversight and advice services for the Clipper[®] program in FY 2018-19.

Background

In 2009, MTC entered into a competitively-procured, multi-year contract with Booz Allen Hamilton to provide technical oversight for the design and implementation of Clipper[®], as well as technical support for operations and maintenance through 2019. Booz Allen Hamilton assigned this contract to CH2M Hill in 2011.

Under the proposed amendment, CH2M Hill will provide support for the following activities in FY 2018-19 on an as-needed basis:

- 1. Administration of the Clipper[®] Contract, including change notice and change order development, proposal evaluation, and independent engineer's estimates;
- 2. Development and maintenance of a master schedule summarizing all work in progress;
- 3. Support transit operator requests for expansion and replacement of Clipper[®] equipment;
- 4. Delivery of various system modifications, including support for testing, distribution, and reports;
- 5. Management of card inventory and oversight of the Clipper[®] retail network;
- 6. Development and oversight of institutional programs, products, and strategy; and
- 7. Technical operations, including financial reconciliation and reporting, data analysis and reporting, asset management, and evaluation and support of system and device maintenance.

Attachment A includes a summary of CH2M Hill and its project team's small business and disadvantaged business enterprise status.

This item was approved by the Clipper[®] Executive Board on June 4, 2018.

Recommendation

Staff recommends that the Committee authorize the Executive Director or his designated representative to negotiate and enter into a contract amendment with CH2M Hill for continuing technical oversight and support of the Clipper[®] program as described in this memorandum, in an amount not to exceed \$600,000, bringing the total contract amount to \$15,557,566.

This memorandum requests Committee approval of the PASS FY 2018-19 Cycle of Projects and contract amendments with the following firms in the specified amounts: DKS Associates (\$230,500); Iteris, Inc. (\$237,300); Kimley-Horn and Associates, Inc. (\$404,800); and TJKM Transportation Consultants (\$294,100).

Background

The region's arterials carry heavy traffic and experience significant congestion during peak and non-peak periods. For nearly 25 years, MTC has been administering the PASS or similar service to provide technical assistance to Bay Area agencies to re-time traffic signals in order to improve signal performance. Over the past five years, almost 1,600 signals have been successfully re-timed.

i) PASS FY 2018-19 Cycle of Projects

For the FY 2018-19 cycle, MTC continued to set the PASS Call For Projects (CFP) corridor eligibility requirements to focus on arterials that: 1) function as reliever routes to nearby freeways; 2) serve transit lines with high transit ridership; or 3) carry higher levels of average daily traffic (ADT) or peak hour volumes. Due to limited funds available for PASS, the program continued to require local funding match as an eligibility requirement in order to leverage regional discretionary funds with local dollars. The local match constitutes the local agencies' contribution towards the PASS technical consultant services.

On March 16, 2018 MTC issued PASS guidelines and subsequently received 14 applications that nominated one or more arterial corridors for signal timing technical assistance. Applications were received from jurisdictions in Alameda, Contra Costa, Santa Clara, Marin and Solano Counties. Staff evaluated each application against the following project evaluation criteria: 1) ability to meet PASS goals – improve travel time and travel time reliability, improve air quality, and improve safety for motorists, transit riders, pedestrians, and bicyclists; 2) project readiness; and 3) project management capacity. Based on the evaluation, staff recommends approval of

nine applications with 249 intersections, as identified in Attachment A, for the FY 2018-19 cycle. The total estimated cost to deliver the recommended projects is \$1,203,100 including \$223,860 covered by local matching funds to cover consultant and hardware costs, plus a contingency of \$20,760.

ii) Contracts - PASS Technical Consultant Services: DKS Associates (\$230,500); Iteris, Inc. (\$237,300); Kimley-Horn and Associates, Inc. (\$404,800); and TJKM Transportation Consultants (\$294,100).

On May 4, 2017, MTC released a mini-Request for Qualifications (RFQ) from the On-Call Transportation Engineering and Planning Services Bench to select consultants to provide technical assistance for the PASS FY 2017-18 Cycle with an option to renew services for an additional year. In July 2017, this Committee approved contracts with DKS Associates, Iteris, Inc., Kimley-Horn and Associates, Inc. and TJKM Transportation Consultants, with an option to extend the performance period for one year. Based on the satisfactory work conducted by the consultants to date, staff recommends extending the consultant contracts and adding funds to deliver the PASS projects listed in Attachment A.

Attachment B includes a summary of the consultants' and their project teams' small business and disadvantaged business enterprise status.

Recommendation

Staff recommends that this Committee approve the PASS FY 2018-19 Cycle of Projects listed in Attachment A. Staff also recommends that this Committee authorize the Executive Director or his designee to negotiate and enter into contract amendments with the following consultants in the specified amounts (comprised of the PASS grant and local match) to provide technical assistance for the PASS projects through June 30, 2019: DKS Associates (\$230,500); Iteris, Inc. (\$237,300); Kimley-Horn and Associates, Inc. (\$404,800); and TJKM Transportation Consultants (\$294,100).

The match constitutes the local agencies' contribution towards the PASS project cost, which consists of the technical consultant services and hardware costs.

Summary

This memorandum requests Committee approval for MTC to enter into a contract amendment with Iteris, Inc. in an amount not to exceed \$548,071 to provide systems engineering services for the Innovative Deployments to Enhance Arterials (IDEA) Program.

Background

The Bay Area has over 33,000 directional miles of arterials and local streets and approximately 11,000 traffic signals. Some major arterials carry heavy traffic and experience significant congestion during the weekday peak periods, which can lead to loss of productivity, unreliable travel for autos and transit vehicles, and reduced safety for bicyclists and pedestrians.

Over the past 20+ years, MTC has provided technical assistance to cities/counties to implement lowcost, low-technology solutions by updating signal timing plans through the Program for Arterial System Synchronization (PASS). In 2014, MTC launched an experimental initiative – Next Generation Arterial Operations Program – which implements technology-based strategies, such as adaptive traffic signals, transit signal priority, and real-time traffic monitoring – to modernize how cities/counties operate arterial signal systems. Through this program, recipient agencies have seen improvements in travel time, traffic flow, and throughput.

Last year, MTC launched the IDEA Challenge Grant Program to implement cutting-edge arterial improvement projects that could benefit all modes. The IDEA Program includes two categories of projects: Category 1 deploys mature, commercially-available technologies; and Category 2 deploys new, higher-risk Connected and Automated Vehicle technologies. MTC awarded a total of \$13 million to 16 projects (ten Category 1 and six Category 2). A summary of the 16 projects is included in Attachment A. The focus of this memo is on five Category 2 projects that will deploy connected vehicle applications, automated vehicles applications and virtual bicycle detection technology for signal operations.

Procurement Selection Process

In February 2016, MTC issued a Request for Qualifications to pre-qualify firms to provide on-call transportation engineering and planning services to support various service categories through June 30, 2019. The selection criteria for service included an evaluation of the strength of the firms experience in Freeway Active Traffic and Travel Demand Management, Connected and Autonomous Vehicles, as well as Arterial Operations.

On May 2, 2018, MTC issued a mini-procurement and invited 16 pre-qualified consultants to submit proposals to provide systems engineering support services for the five Category 2 projects.

MTC received proposals from three firms: Iteris, Inc., Jacobs Engineering, and Kimley-Horn and Associates, Inc. A panel consisting of MTC staff performed an evaluation of the proposals based on each firm's qualifications and experience, approach to completing the work, price, cost effectiveness, and written communication. Based upon the evaluation panel's scores, Iteris, Inc. and Kimley-Horn and Associates, Inc. were invited for in-person interviews, which were held on June 18. Proposers presented their qualifications, answered questions about their proposals, and discussed their approach to the scope of work.

Based on the written proposals and the results of the interviews, staff recommends the selection of Iteris, Inc. due to the firm's demonstration of qualifications and experience in systems engineering, as well as its approach to completing the scope of work for high-risk connected and automated vehicle technology projects. The table below provides the final ranking based upon the panel evaluations:

Iteris, Inc. is neither a small business nor disadvantaged business enterprise and currently has no DBE subcontractors for the work described in this memorandum.

Recommendation

Staff recommends that the Committee authorize the Executive Director or his designated representative to negotiate and enter into a contract amendment with Iteris Inc. for a not-to-exceed amount of \$548,071 for the above-described work.

This memorandum requests Committee approval for a contract amendment with URS Corporation Americas (URS) in an amount not to exceed \$400,000 to continue design services during construction for two Bay Bridge Forward projects – Commuter Parking Initiative and West Grand Ave. HOV/Bus Only Lane. In addition, the amendment will allow URS to proceed with preliminary engineering for the extension of the West Grand Ave. HOV/Bus Only Lane.

Background

FR:

The Commuter Parking Initiative is intended to increase Transbay person throughput by providing more opportunities for commuters to park and share rides in transit and carpools. MTC is constructing commuter parking lots at I-80/Buchanan Ave. in Albany, and at I-880/High St. and I-880/ Fruitvale Ave. in Oakland using California Department of Transportation (Caltrans) airspaces underneath the freeway. MTC has entered into a maintenance agreement with Caltrans that allows MTC to develop, operate, and maintain the commuter parking lots. The three locations combined will have approximately 800 parking spaces and will include new bus stops and carpool/passenger loading areas, as well as lighting and perimeter fencing for safety and security. MTC will charge parking fees to cover operations and maintenance costs. As part of Bay Bridge Forward, MTC staff is also working with AC Transit to pilot a new express bus service to serve new Transbay riders at the lots.

The West Grand Ave. HOV/Bus Only Lane is intended to increase Transbay person throughput by providing access and operational improvements for transit buses and eligible carpools through the conversion of approximately 1,300 feet of the right shoulder on the West Grand Avenue on-ramp and northbound I-880 connector to a bus lane.

Procurement Process

In January 2014, after a competitive procurement, the BATA Oversight Committee authorized the Executive Director to enter into contracts with eight firms, including URS, to provide on-call design services on behalf of MTC. In September 2014, MTC conducted an informal solicitation among the eight firms under the 2014 design services pool for the commuter parking project. As a result, staff determined that URS's firm and staff qualifications, expertise and experience in engineering and design services associated with the development of commuter/transit parking lots would be most advantageous in delivering the engineering and design work contemplated by MTC.

In January 2016, the Operations Committee authorized the Executive Director to enter into a contract with URS for design services related to preparing environmental studies and design and engineering plans for the candidate commuter parking sites. These activities fell within the scope of work outlined in the on-call design services procurement, but were outside the scope of the earlier informal solicitation. Thus, this contract was a direct award to URS as permitted by the on-call design services procurement.

In February 2016, after a competitive procurement under the 2014 design services pool for the West Grand Ave. HOV/Bus Only Lane project, staff recommended URS because of their understanding of the project and its challenges, the proposed management team, staff experience, and the capacity of qualified personnel to complete the project according to schedule.

This amendment will add \$400,000 to the contract, bringing the contract total to \$2,498,000. Attachment A includes a summary of URS and its project team's small business and disadvantaged business enterprise status.

Recommendation

Staff recommends that the Committee authorize the Executive Director or his designee to amend a contract with URS Corporation Americas to continue design services in an amount not to exceed \$400,000.

This memorandum requests the Committee's approval to enter into a five-year contract, with options to extend the term for up to an additional five years, with Enterprise Rent A Car Co. of San Francisco, LLC ("Enterprise") in the amount of \$9,550,000. The purpose of the contract is to grow the regional vanpool fleet, provide vanpool data to the National Transit Database, and increase the Bay Area's share of FTA 5307 transit funds.

Background

To encourage vanpooling in the region, MTC will offset the cost to vanpoolers for vans enrolled in the 511 Vanpool Program by \$350 per month per van, which amount may be adjusted during the Program. Lowering the cost of vanpooling to customers has been shown to grow the vanpool fleet in other parts of the country. In exchange for the offset, Enterprise will gather data from vanpoolers, and MTC will report it to the Federal Transit Administration's (FTA's) National Transit Database (NTD). This will increase Bay Area reported vehicle passenger miles and increase the Bay Area's share of federal Section 5307 funds. MTC will fund the first three years of the vanpool program using about \$4 million in Congestion Mitigation and Air Quality (CMAQ) and Transportation Fund for Clean Air (TFCA) funds. In the following two years, MTC intends to use about \$6 million of new Section 5307 funds obtained from NTD reporting to pay for the program.

By Program Year 5, staff aims to grow the Bay Area vanpool fleet from 525 vans to 700 vans. This would represent significant progress toward reaching the 1,030 vans needed by 2035 for greenhouse gas emissions reductions described in Plan Bay Area 2040's Final Travel Modeling Report (July 2017). Once the fleet increases to 700 vans, the annual program budget would be \$3 million. This investment is anticipated to generate about \$10 million of additional Section 5307 funds per year. The \$7 million balance would be available for other transit capital needs.

Staff recommends a maximum ten-year contract period of performance to support continuity and accountability of NTD reporting. This would not preclude MTC from rebidding the contract early in the event of unsatisfactory performance, new private sector vendors that MTC may want to add, or some other reason.

Procurement Process

On February 5, 2018, MTC issued a Request for Proposal (RFP) to find eligible vanpool providers to participate in the vanpool program. An email advertising the availability of the RFP on MTC's website was sent to 1,033 individuals/firms. MTC received two proposals, which

were evaluated by a panel of MTC staff. The evaluation criteria, listed in order of importance, included: 1) Qualifications [35%]; 2) Approach [35%]; and 3) Best value/fleet pricing [30%].

Enterprise and Yazdan Irani dba Airport Van Rental Inc. ("AVR"), submitted proposals with vanpool rental/lease rates as shown below:

While the proposed rental/lease costs per month for both proposers came in at reasonable rates, staff decided to short list only Enterprise for further discussions. AVR's rates were higher than Enterprise's by an amount similar to the value of the proposed subsidy, and vanpoolers in the Bay Area would have lower costs across the board under Enterprise. Furthermore, Enterprise presented a stronger approach to achieving the program's goal of lowering the price point of vanpooling and increasing its attractiveness. Also, AVR has never run a turnkey vanpool program, including matching passengers to form vanpools or meeting NTD data reporting requirements, whereas Enterprise has over 65 public sector contracts for turnkey vanpool services, including 19 with Metropolitan Planning Organizations or Councils of Government.

The panel entered into discussions with Enterprise on May 8, and later issued a Request for Best and Final Offer (BAFO) to clarify proposal details. After a thorough review of the BAFO, the evaluation panel unanimously recommended the selection of Enterprise. Enterprise has extensive experience providing turnkey vanpool services and collecting and packaging NTD data, provides vans to existing vanpoolers in the Bay Area, and understands the region's institutional issues, having worked with the 511 Rideshare Program and the County TDM agencies for many years. Enterprise's well-written proposal defined a comprehensive approach for completing project tasks, and demonstrated a clear understanding of the project elements and process needed to implement the project. Enterprise's vanpool rental/lease rates were also the most competitive.

Attachment A includes a summary of Enterprise and its project team's small business and disadvantaged business enterprise status.

Recommendation

Staff recommends that the Committee authorize the Executive Director or his designated representative to negotiate and enter into a five-year contract with Enterprise Rent A Car Co. of San Francisco, LLC, in an amount not to exceed \$9,550,000 to provide turnkey vanpool services and related vanpool data to support National Transit Database reporting.
