Background

This paper is the second in a series of Perspective Papers contributing to Horizon, a regional initiative exploring how the Bay Area can thrive in an uncertain future. The Horizon initiative is a comprehensive Bay Area planning effort to go beyond transportation and housing policies and consider economic development, resilience and the effects of emerging technologies for the next long-range transportation and sustainable communities strategy, Plan Bay Area 2050. Each Perspective Paper seeks to identify strategies to improve regional outcomes under a wide range of future conditions. This paper identifies high-impact policies to support Horizon's Guiding Principles and help to achieve vehicle miles traveled (VMT)¹ per capita reduction targets.

Priority Strategies

The San Francisco Bay Area is a global center for technological innovation and a region of rich natural beauty. It is a desirable location to live, work and play, and as a result, has been growing and thriving economically. The transportation system, however, has not kept pace with this growth mainly due to limited land availability and financial resources, leading to growing traffic congestion that has negative impacts on health, productivity and climate. Looking to 2050, the need to reduce traffic congestion, relieve transit crowding, and improve mobility is critical.

This paper, Toward a Shared Future: Strategies to Reduce Congestion, proposes seven strategies for a more mobile Bay Area by 2050, a place where everyone has a suite of travel options to consume on demand, regardless of where they live, work and play. This is primarily achieved by building on and supporting changing travel and ownership preferences arising from new mobility services and technological innovation.

These strategies have traditionally been called "Transportation Demand Management" as they focus on reducing the demand for vehicle travel by improving the reliability, flexibility, convenience and cost of other modes. The strategies were chosen for their potential to reduce congestion or VMT, and their ability to achieve Horizon's Guiding Principles to make the Bay Area more Affordable, Connected, Diverse, Healthy and Vibrant.



¹ VMT is a basic measure of the amount of vehicle travel generated in a specified geographic area. One vehicle traveling one mile constitutes one vehicle mile, regardless of its size or the number of passengers. VMT refers to the number of vehicle miles traveled within the region during a typical weekday. VMT is a common measure of roadway use and economic activity and has a strong correlation with congestion.

The seven priority strategies work together to achieve a vision for 2050 when all transportation, regardless of mode or roadway used, can be consumed on a per-use basis (where transportation is provided as a service rather than having to be owned), with incentives supporting active or multi-passenger options:

- 1. Multi-Service Trip Planner and Transportation Wallet
- 2. Free Feeder Services to High Capacity Transit
- 3. Tolling All Highways and Bridges
- 4. Cordon Pricing
- 5. Parking Tax
- 6. Vehicle Trip Reduction Requirements on Development
- 7. Parcel Lockers and Freight Consolidation Centers

Together, the strategies promote choice, better connectivity, and improved interoperability between all services, public and private. These strategies rely on each other to achieve this vision by 2050; without better services that are easy to access, pricing cannot be introduced to effectively reduce VMT.

Next Steps

This *Perspective Paper* introduces a set of priority strategies for the region to consider. It is important to emphasize that the paper is intended to serve as an interim deliverable of the overall *Horizon* process. The strategies described in the Paper serve as a starting point for a more robust discussion this fall, when MTC and ABAG staff will engage stakeholders on strategies that can overcome various challenges facing the region across multiple *Futures*. This process will identify a narrowed-down list of strategies most effective in multiple Futures to carry forward into Plan Bay Area 2050.

MTC/ABAG will hold a public event releasing this Perspective Paper on Wednesday, September 26, 2018, 6:00PM – 8:00PM, at WeWork Valley Towers in downtown San Jose. The event will highlight a similar presentation of the material and engage experts and the audience in a panel discussion about these topics.





Tolling of All Bridges and Highways


Parking Tax A tax on off-street parking facility owners or users.

VMT Reduction Potential A 25% parking tax could reduce parking demand by 7.5%

Free to priced parking typically reduces solo commuting by 10% to 30%





Required TDM for New Development

Reducing single occupancy vehicle trips with developer provided programs that could include transit passes, bike/carshare on site and real time transportation information displays.








What's Next for Strategies Identified?

Dear Committee Members:

The Building Industry Association of the Bay Area (BIA) appreciates the opportunity to comment on Perspective Paper #2. Reducing congestion is vital for the Bay Area and BIA is pleased that MTC and ABAG are prioritizing the issue in the Perspective Paper series.

BIA has the following comments and concerns regarding the Perspective Paper's overall approach and the specific strategies identified:

- The Paper's title and the presentation summary refer to "congestion reduction." That appears to be the "sales pitch" (to borrow a phrase from the presentation). However, all of the strategies identified are aimed at "VMT reduction," *i.e.*, getting people out of their cars. Whatever the merits of the overall goal of VMT reduction or the specific strategies to achieve it, when the average Bay Area resident or in-commuter is "pitched" on addressing congestion reduction, that person is going to expect that at least some of the strategies will focus on the supply side of the equation either by expanding the transportation network's capacity or its efficiency so that *when they drive* they experience less congestion.
- With respect to the proposed strategies to reduce VMT, BIA has concerns about the proposal to impose new mandates (and costs) on new development projects if it were to include housing or mixed-use projects. The already astronomical cost of new housing construction in the Bay Area is well-documented. Adding to this cost by requiring housing developers (and ultimately buyers and renters) to pay for public transportation for future residents or "demand management" programs would be inconsistent with the paramount Horizon guiding principle that "All Bay Area residents and workers have sufficient housing options they can afford."
- BIA also believes it is inappropriate to present the "Required TDM for New Development" (to the extent it were to include residential and mixed-use projects) as advancing the Horizon's "Healthy" goal. That goal relates to conserving "the region's natural resources, open space, clean water and clear air." Affixing the "Healthy" label to the new development mandate would seem arbitrary.

• Increasing the supply of housing (for-sale and rental) for all income levels within the Bay Area region is one of the most effective strategies for reducing congestion and VMT. In-commuting from the Central Valley and Sacramento areas is a massive contributor to VMT. Increasing housing availability and choices within the Bay Area ought to be identified as a key congestion/VMT reduction strategy in the Perspective Paper.

Background

With the staff consolidation in July 2017, the planning departments of MTC and ABAG combined to become a 40 plus person strong integrated regional planning program (IRPP). The team is currently working on several important initiatives including CASA – the Committee to House the Bay Area, *Horizon*, establishing an Economic Development District, and a development of a funding strategy for the remaining gaps in the Bay Trail. A Strategic Plan is being developed to support the advancement of a dynamic, effective, high impact IRPP. MTC hired LeSar Development Consultants to develop a refined strategic plan for the new regional planning program and assist with key components of an implementation framework for the plan for the near-and mid-term. LeSar Development Consultants have significant expertise and experience related to organizational change, strategic planning for public entities, and priority setting for newly merged or expanded entities.

Approach

The development of the strategic plan will occur over an approximate 9 month timeframe, with guidance from a technical advisory committee comprised of staff from across the regional planning program, and will consist of four main tasks:

- 1. **Confirmation of Approach and Timeline** (*complete*): The consultant and advisory committee worked together to refine the purpose and need of the plan, as well as the best ways to engage and gather input from planning staff, executive staff, MTC and ABAG board members and commissioners, and external stakeholders. This task was completed in July 2018.
- 2. Assessment of Challenges and Opportunities (*in process*): In this phase, the consultant is gathering input from staff and other stakeholders through a combination of online surveys and inperson interviews. The purpose of this phase is to solicit feedback to better understand the day-to-day challenges faced by planning staff and opportunities to improve the program's impact on the region. The final product of this task will be a memo documenting the major findings identified through the surveys and interviews.
- 3. **Identify Key Drivers of Strategic Plan:** Based on the findings in previous phase, the consultant will lead a process to engage planning staff and others in identifying strategies to overcome challenges and pursue opportunities. This phase will likely include workshops with planning staff and conversations with executive leadership to discuss key findings and prioritize internal and external strategies to best position the planning program for success.

4. **Develop 5-Year Strategic Plan and Workplan Recommendations:** In the final phase of this work, the consultant will draft a five-year strategic plan for the program, as well as recommendations for improving the annual work planning process for Fiscal Years 2019-2020 and beyond. The process recommendations will position the planning program to better align their staff resources and activities with regional priorities, including methods for reprioritizing work plans as new needs emerge. The five-year strategic plan will identify the Bay Area's significant regional short-term needs and long-term challenges and opportunities to guide the program's work planning and prioritization through the year 2023.

Next Steps

The consultant has completed task 1 and work on task 2 is currently underway. The survey of planning program staff was completed in August, and the survey of MTC and ABAG board members and commissioners will be sent out the week of September 11. Interviews with planning staff and executive staff are underway. We welcome any feedback or input you have on the Strategic Plan development.
