Current law provides for the creation by local ordinance, or by ministerial approval if a local agency has not adopted an ordinance, of accessory dwelling units to allow single-family or multifamily dwelling residential use in accordance with specified standards and conditions. This bill would require the Treasurer, within 6 months of the effective date of these provisions, to develop the Help Homeowners Add New Housing Program with the purpose of assisting homeowners, as defined, in qualifying for loans to construct additional housing units on their property, including accessory dwelling units and junior accessory dwelling units. The bill would, with regard to the development of the program, require the Treasurer to consult with the California Housing Financing Agency and the Department of Housing and Community Development and would authorize the Treasurer to consult with private lenders.		
AB 168 Aguiar-Curry	Enrolled 9/4/2020	Assembly Enrollment	Planning and zoning: annual report: housing development: streamlined approvals. The Planning and Zoning Law requires the planning agency of a city or county to provide by April 1 of each year an annual report to the legislative body of the city or county, the Office of Planning and Research, and the Department of Housing and Community Development that includes, among other specified information, the status of the general plan and progress in its implementation. This bill would additionally require that this annual report include information on the progress of the city or county in adopting or amending its general plan or local open-space element in compliance with its obligations to consult with California Native American tribes, and to identify and protect, preserve, and mitigate impacts to specified places, features, and objects, pursuant to specified law.		

AB 291 Chu	Amended 1/23/2020	Senate Dead	Local Emergency Preparedness and Hazard Mitigation Fund. Would establish a Local Emergency Preparedness and Hazard Mitigation Fund to, upon appropriation by the Legislature, support staffing, planning, and other emergency mitigation priorities to help local governments meet emergency management, preparedness, readiness, and resilience goals. The bill would require the Office of Emergency Services to establish the Local Emergency Preparedness and Hazard Mitigation Fund Committee under the Standardized Emergency Management System Advisory Board.	
AB 323 Rubio, Blanca	Enrolled 9/4/2020	Assembly Enrollment	Newspapers: state agency advertising: worker status: independent contractors. Current law sets out the various responsibilities of the Department of General Services and state agencies in overseeing and implementing state contracting procedures and policies. Current law also provides that whenever any official advertising, notice, resolution, order, or other matter of any nature whatsoever is required by law to be published in a newspaper, the publication is required to be made only in a newspaper of general circulation, as specified. This bill would require the department to publish, on the department's internet website, an annual report by July 1 of each year containing specified information relating to payments for placement of marketing or outreach advertising material by each state agency. The bill would provide that these provisions are not intended to amend any of the above-described provisions relating to required publications of official advertising, notices, resolutions, orders, or other matters.	
AB 429 Nazarian	Amended 8/30/2019	Senate Dead	Seismically vulnerable buildings: inventory. Current law establishes a program within all cities and all counties and portions thereof located within seismic zone 4, as defined, to identify all potentially hazardous buildings and to establish a mitigation program for these buildings. The mitigation program may include, among other things, the adoption by ordinance of a hazardous buildings program, measures to strengthen buildings, and the application of structural standards necessary to provide for life safety above current code requirements. Current law requires the Alfred E. Alquist Seismic Safety Commission to report annually to the Legislature on the filing of mitigation programs relating to building construction standards from local jurisdictions. This bill would require the commission, by specified deadlines, to identify funding and develop a bidding process for hiring a third-party contractor to create an inventory of potentially vulnerable buildings, as defined. Current law establishes, among other housing programs administered by the Department of Housing and Community Development, the Multifamily Housing Program, pursuant to which the department provides assistance in the form of deferred payment loans to pay for specified eligible costs of development of specified housing projects. This bill would authorize the department, in administering the Multifamily Housing Program, to establish set-asides for specific project types or projects that serve specific target populations.	
AB 724 Wicks	Amended 4/25/2019	Assembly Dead	Rental property data registry. Would require the Department of Housing and Community Development to create a rental registry online portal, which would be designed to receive specified information from landlords regarding their residential tenancies and to disseminate this information to the general public. The bill would require the department to complete the rental registry online portal, the form necessary to support it, by January 1, 2021, and would require landlords who own or operate property that includes more than 15 dwelling units to register within 90 days and annually thereafter.	
AB 725 Wicks	Enrollment 9/8/2020	Assembly Enrolled	General plans: housing element: moderate-income and above moderate-income housing: suburban and metropolitan jurisdictions. The Planning and Zoning Law requires that the housing element include, among other things, an inventory of land suitable for residential development, to be used to identify sites that can be developed for housing within the planning period and that are sufficient to provide for the jurisdiction's share of the regional housing need determined pursuant to specified law. This bill, commencing January 1, 2022, would require that at least 25% of a metropolitan jurisdiction's share of the regional housing need for moderate-income housing be allocated to sites with zoning that allows at least 4 units of housing, but no more than 100 units per acre of housing. The Planning and Zoning Law, until January 1, 2026, authorizes a development proponent to submit an application for a multifamily housing development that is subject to a streamlined, ministerial approval process, as provided, and not subject to a conditional use permit, if the development satisfies specified objective planning standards, including, among other things, that the development is located on a site that satisfies specified location, urbanization, and zoning requirements. Current law requires a local government that determines that a development submitted pursuant to these provisions is in conflict with any of the objective planning standards to provide the development proponent written documentation of which standard or standards the development conflicts with and an explanation of the reasons, as specified. Measure RR: Caltrain 1/8-cent Sales Tax

Subject: A 1/8-cent sales tax on the ballot to provide dedicated funding for Caltrain, the

commuter rail service along the San Francisco Peninsula Corridor, through the

Overview: Various boards in the City and County of San Francisco and the counties of San

Mateo and Santa Clara agreed to place Measure RR on the November 2020 ballot. The measure will provide the commuter railroad its first dedicated source of tax revenue—a 1/8-cent (0.125 percent) sales tax for 30 years with proceeds eligible for operating, maintenance and capital purposes, consistent with the Caltrain business plan. If approved by 2/3 of voters among the three counties collectively, the tax would commence on July 1, 2021. The revenue stream from the new tax is estimated to be sufficient to cover the rail service's operating costs over this time

frame, thereby reducing financial pressure on the member agencies.

Recommendation: Support

Discussion Caltrain provides a vital public transit link for Bay Area commuters living or

working in San Francisco, Santa Clara, and San Mateo counties. While ridership is down dramatically due to COVID-19, the service provides a reliable alternative to the Interstate 280 and Highway 101, one that will be critical to mobility and containing greenhouse gas reduction in the future when shelter-in-place is lifted

and Bay Area residents resume a more normal level of travel.

Prior to COVID-19, Caltrain's fares covered 70 percent of its operating costs, the largest of any commuter railroad in the nation. Its ridership also skyrocketed over the last decade, with demand for the service now far-exceeding capacity, and creating a strong rationale for electrification of the service which will speed up travel and allow for more frequent headways in both directions. The Caltrain electrification project, the San Francisco downtown extension (DTX) and a planned extension to Gilroy are key capital projects that will also benefit from a new dedicated revenue source, as is the system's overall state of good repair. Finally, for the three public agencies that are represented on Caltrain's governing board—City and County of San Francisco, Samtrans and the Santa Clara Valley Transportation Authority— a dedicated sales tax for Caltrain will reduce their required contributions at a time when each faces budget challenges of their own.

For these reasons, staff recommends the committee refer to the Commission a support position on Measure RR.

Background: Earlier this summer, the SCTA board of directors voted to ask Sonoma County voters

to approve a 20-year extension of its existing 1/4-cent sales tax that will expire in 2025. The measure will appear as Measure DD on the November ballot. An early renewal would provide the certainty needed for SCTA to keep the project pipeline moving and provide matching funds for state transportation programs and other grant funds. The Measure DD tax renewal would sunset March 31, 2045. As a special tax,

Measure DD would require two-thirds voter approval.

Discussion: The current Sonoma County sales tax, approved in 2004 as Measure M, has helped

fund transportation projects throughout the county. The current ½-cent sales tax is not set to expire until April 2025, but all of its forecasted revenue—estimated to total approximately \$400 million over the 20-year period—is already committed to projects. The multimodal investment plan for the proposed 20-year sales tax extension—the "Go Sonoma Act," or Measure DD—would fund four programs in

two categories, as shown in the chart below:

Proposition 16: Statewide Ballot Initiative to Repeal California's Affirmative Action Ban

Subject:

Proposed support for Proposition (Prop) 16, a constitutional amendment to repeal the state's ban on the use of affirmative action by public agencies.

Background:

History of California's Affirmative Action Ban

California voters in 1996 approved Prop 209, a ballot initiative that banned the use of affirmative action in California. Specifically, Prop 209 amended the California Constitution to specify that the state cannot "discriminate against, or grant preferential treatment to, any individual or group on the basis of race, sex, color, ethnicity, or national origin in the operation of public employment, public education, or public contracting." Repeal of Prop 209 would enable California's public universities, the state, local governments, and other public entities to develop programs and policies that directly aim to increase opportunities for people of color and women in in admissions, hiring and awarding public contracts.

Leading up to Prop 209's passage by 55 percent of California voters, Ward Connerly—a member of the University California Board of Regents and the measure's key champion—contended that while affirmative action once helped to promote equal opportunity, it had outlived its usefulness. He testified before the United States Senate Judiciary Committee in April 1996 that "Affirmative action was meant to be temporary. It was meant to be a stronger dose of equal opportunity for individuals, and the prescription was intended to expire when the body politic had developed sufficient immunity to the virus of prejudice and discrimination." The official 1996 ballot argument in support argued that affirmative action was reverse discrimination that "perpetuate[d] the myth that "minorities" and women cannot compete without special preferences" and instead, the path to equality was to embrace a color-blind, race-blind, and gender-blind society." Prop 209's passage in California spurred similar affirmative action bans in nearly a dozen other states.

Racial Disparities Persist

Our 2020 reality is that race-based disparities persist. An August 2019 Economic Policy Institute study found that Black workers are twice as likely to be unemployed as white workers, and a similar disparity exists between Black college-graduates and their white counterparts. In the Bay Area, Black households in each of the region's nine counties earn, on average, less than their white counterparts. For example, the 2014 median average income for white households in Alameda County was \$92,000, more than twice the median income for Black households (\$42,900). The racial wage gap is even more stark in San Francisco, where white households earned more than three times that of Black households. Black, Native American and Latino households are also disproportionately more likely to be rent-burdened. iii

A comprehensive U.C. Berkeley study published in August 2020, *Affirmative Action*, *Mismatch, and Economic Mobility After California's Proposition 209* included findings from two decades of research indicating California's affirmative action ban has exacerbated inequalities. Researchers found that by multiple measures, the ban has been detrimental to Black and Hispanic students, decreasing their admissions into the University of California system, going to graduate school and—in particular for Hispanic students—earning a high salary.^{iv}

In June 2020, the U.C. Board of Regents unanimously voted in support of ACA 5 and the repeal of Prop 209 noting that "attempting to address racial inequality without actually considering race has proven to be challenging. Despite nearly two decades of effort and experimentation with race-neutral admissions at UC, the University's enrollment of students from underrepresented groups and recruitment of faculty of color falls short of reflecting the rich diversity of California's population."

Impact on Public Contracting

In addition to prohibiting affirmative action in hiring and college admissions, Prop 209 also prohibited race and gender conscious procurement policies by the State of California and local agencies. It is difficult to quantify the precise impact this had on minority and women business enterprises (WMBEs) since the state and many local agencies stopped requiring collection of race and gender data after the law's passage until subsequent legislation clarified that this was permissible. A 2015 study commissioned by the Equal Justice Institute estimates that WMBE's lost over \$1 billion per year in business relative to the share they had been receiving prior to passage of Prop 209. It also points to Caltrans' experience with its disadvantaged business enterprise (DBE) program—a requirement of federal funds—as an interesting case study of a race-neutral approach. In the four years prior to eliminating race as a factor in its contracting (a decision Caltrans made in response to an executive order in 1995 preceding Prop 209), Caltrans' had an average DBE contracting rate of 22 percent. This fell to an average of 4.6 percent from FY 2007-2011 after it shifted to a completely race-neutral approach. Caltrans currently administers its race-neutral DBE program in compliance with federal law with a statewide goal of 12.5 percent for its federally-funded transportation contracts.

What Would Proposition 16 Do?

Prop 16 is a legislatively referred constitutional amendment placed on the ballot by Assembly Constitutional Amendment (ACA) 5 (Weber, 2020). If voters approve the measure, California public entities would be permitted—within the bounds of federal law—to implement affirmative action programs that explicitly use race and gender as factors in college admissions, government hiring and public contracting. Case law from the U.S. Supreme Court would guide what specific policies and programs would be permissible. The Supreme Court has ruled that strict racial quotas and point systems in higher education admissions are unconstitutional but individualized, holistic reviews that consider race, when tailored to serve a compelling public interest (such as educational diversity), are permissible. The Senate Floor bill analysis of ACA 5 summed it up as follows: "In short, the repeal of Prop 209 would permit the use of race and/or gender as a "plus" factor in college admissions, public employment, and public contracting. It would not permit the use of quotas or policies that [are] broadly tailored and do not consider the totality of the individual college applicant, job applicant, or contract bidder."

Discussion:

In the Fall of 2019, MTC and ABAG received and supported the "Equity Platform" as a paradigm infusing equity through the portfolios of our regional agencies. While in advance of the social justice activism that gripped the nation in the wake of the violent death of George Floyd, the Platform underscored both the June 2020 joint statement issued by MTC Chair Scott Haggerty and ABAG President Jesse Arreguin and the Commission's subsequent Resolution 4435, all reaffirming the agencies' "commitment to meaningfully advance justice, equity, diversity and inclusion." Plan Bay Area 2050 also embraces equity as a core goal and recognizes that additional strategies are needed to ensure that the region can deliver "a just and inclusive Bay Area where everyone can participate, prosper, and reach their full potential"—the Platform's core vision.

Prop 16 is a unique opportunity for the Commission and Executive Board to support a statewide policy change that will provide state and public agencies across the Bay Area—including MTC and ABAG—a valuable tool to help create a more diverse workforce, contracting pool and student body, within the confines of federal law. Accordingly, staff recommends the committee refer a position of support to the Commission and the ABAG Executive Board.

ENDORSEMENT OF ASSEMBLY CONSTITUTIONAL AMENDMENT 5 AND THE REPEAL OF PROPOSITION 209 (NOVEMBER 2020 BALLOT)

EXECUTIVE SUMMARY

The Chair of the Board of Regents and the President of the University recommend that the Regents endorse Assembly Constitutional Amendment (ACA) 5 and the repeal of the provisions of Proposition 209. Proposition 209, the 1996 voter initiative codified as Article I, Section 31 of the California Constitution, prohibits the University from discriminating against or "granting preferential treatment" to any individual or group on the basis of race, sex, color, ethnicity, or national origin. Despite years of effort with race-neutral admissions at UC, UC enrollment of students from underrepresented groups and recruitment of faculty of color falls short of reflecting the diversity of California's population.

RECOMMENDATION

The Chair of the Board of Regents and the President of the University recommend that the Regents endorse Assembly Constitutional Amendment (ACA) 5 and the repeal of the provisions of Proposition 209 (1996), which prohibits use of race or gender as a factor in UC admissions decisions.

BACKGROUND

Assembly Constitutional Amendment 5 (ACA 5) by Assembly Member Shirley Weber aims to repeal Proposition 209 by placing a measure on the November 2020 ballot. ACA 5 requires a two-thirds vote in each house of the Legislature by June 25, the last day for an initiative measure to qualify for the general election ballot. If ACA 5 qualifies for the ballot and a majority of voters approve the measure in November, the provisions of Proposition 209 in the State constitution would be repealed and UC would be allowed to act in a manner consistent with federal and other applicable law related to public employment, education, and contracting.

ACA 5 passed the State Assembly by a vote of 60 to 14. The bill is currently in the State Senate awaiting referral to committee. ACA 5 is expected to be referred soon to both a policy and a fiscal committee and, if approved by majority votes, proceed to the Senate floor for action prior

to the June 25 deadline. If the Senate approves ACA 5 by a two-thirds margin, a measure would be placed on the ballot for November 2020.

The text of ACA 5 can be viewed here.

Proposition 209, the 1996 voter initiative codified as Article I, Section 31 of the California Constitution, prohibits the University from discriminating against or "granting preferential treatment" to any individual or group on the basis of race, sex, color, ethnicity, or national origin. Proposition 209 was precipitated by Regents' Special Policy 1 (SP-1) and Special Policy 2 (SP-2) in July 1995. SP-1 ended the use of race, ethnicity, and gender as criteria for admissions to UC or to any program of study. SP-2 prohibited the consideration of the same attributes in the University's employment and contracting practices. In May 2001, the Regents passed a new resolution (Regents Policy 4401, Policy on Future Admissions, Employment, and Contracting (Resolution Rescinding SP-1 and SP-2)) to rescind SP-1 and SP-2 and to reaffirm the University's commitment to a diverse student policy. This policy was mostly symbolic in nature as Proposition 209 had been codified in the California Constitution.

Regents Policy 4400, Policy on University of California Diversity Statement, last amended in 2010, renewed the University's commitment to "the full realization of its historic promise to recognize and nurture merit, talent, and achievement by supporting diversity and equal opportunity in its education, services, and administration, as well as research and creative activity. The University particularly acknowledges the acute need to remove barriers to the recruitment, retention, and advancement of talented students, faculty, and staff from historically excluded populations who are currently underrepresented."


After the passage of SP-1, UC saw a dramatic drop in the number and proportion of freshman from underrepresented groups admitted to and enrolling in UC's most selective campuses, UC Berkeley and UCLA. These declines drew widespread attention and led to a number of policies and programs to mitigate the effects of Proposition 209. These efforts included the following:

- Expansion of UC outreach programs (1997), including a 100 percent increase in State funding for Student Academic Preparation and Educational Partnerships (SAPEP) programs, followed by a 50 percent cut just four years later.
- Eligibility in the Local Context (2001) which offers guaranteed admission to qualified students in the top nine percent of each participating high school.
- Comprehensive review in undergraduate admission (issued in 2001 and last updated in 2012), the process by which students applying to UC campuses are "evaluated for admission using multiple measures of achievement and promise while considering the context in which each student has demonstrated academic accomplishment." In implementing comprehensive review, most UC campuses also adopted the holistic review of applicants by trained evaluators.

- Guidelines for Addressing Race and Gender Equity in Academic Programs (2015), a
 resource for University administrators considering measures that UC can legally implement
 to support its commitment to diversity.
- A number of systemwide and campus programs to diversify the professoriate and health professions including the President's and Chancellor's Postdoctoral Fellowship Programs; Advancing Faculty Diversity initiative, UC Programs in Medical Education (UC PRIME), and the UC-HBCU initiative, among many others.


Figure 1: URGs as Percentage of California Public High School Graduates and as Percentage of UC Systemwide Freshman Applicants, Admits, and Enrollees, Fall 1989 to Fall 2016

Despite these policy changes and programmatic efforts, UC has not kept pace with the diversity of students in California K-12 schools or with the overall California population. As shown in Figure 1 below, prior to Proposition 209, the proportion of freshmen from underrepresented groups (URG) averaged 19 to 20 percent, then dropped to 15 percent in 1998 then slowly increased over the next 20 years, reaching a peak at 37 percent in 2016—an increase that can be attributed to the increase in enrollment across all UC undergraduate campuses. Meanwhile, the percentage of URG students graduating from high school has nearly doubled to over 56 percent in 2016.

Among faculty ranks, UC has generally kept pace with the availability of URG doctorate recipients in most fields. However, UC has not kept pace with the availability of women PhDs in several fields, including STEM fields such as life sciences, physical sciences, and mathematics (Figure 2).

Despite UC's policy and programmatic changes, attempting to address racial inequality without actually considering race has proven to be challenging. Despite nearly two decades of effort and experimentation with race-neutral admissions at UC, the University's enrollment of students from underrepresented groups and recruitment of faculty of color falls short of reflecting the rich diversity of California's population.

An amicus brief submitted in 2016 by the University in *Fisher v. University of Texas* summarized the impact of Proposition 209 in short: "UC's many years of effort and experimentation with a wide variety of race-neutral approaches demonstrates that, at least under current circumstances in California, highly competitive public universities cannot maintain historic levels of diversity within their student bodies—much less reflect in their student bodies a growing state population of underrepresented minorities—using only race-neutral methods."

President Napolitano, the ten Chancellors, the systemwide Academic Council, the UC Student Association, and the UC Graduate and Professional Council have all publicly expressed their support for ACA 5 and the repeal of Proposition 209.

2020 Legislative Update on Priority Bills

Subject:

Overview of the 2020 state legislative session, with a focus on bills for which MTC and ABAG have taken a position.

Overview:

The Legislature's two-year 2019-2020 legislative session wound down to an anticlimactic close on August 31st. Due to the COVID-19 pandemic, there were far fewer days of active session and the number of hearings were substantially reduced. As recently as last week, members of the state Senate were diagnosed with the virus resulting in the cancelation of a critical day of floor session. Leadership in both houses asked members to narrow down their bills to those related to COVID or of an urgent nature. Given this environment, staff recommended substantially fewer bills for positions by ABAG and MTC – taking positions on just six bills this year. In sum, only two priority bills that MTC or ABAG supported reached the Governor's desk:

- SB 146 (Beall) authorizing virtual public outreach meetings and qualification of "pop up" meetings applicable to outreach requirements through 2022 (applicable for the duration of Plan Bay Area 2050). ¹
- SB 288 (Wiener) CEQA streamlining for sustainable transportation projects (including bicycle and pedestrian facilities and dedicated bus lanes) to accelerate such improvements and help with economic recovery (two-year sunset).

Priority Bills MTC and/or ABAG Supported That Did NOT Advance

- SB 902 (Wiener), proposed CEQA exemption for modest upzoning, was held in Assembly Appropriations Committee.
- SB 995 (Atkins) extended expedited judicial review provisions under the California Environmental Quality Act (CEQA) and adding affordable housing as an eligible project
- AB 3040 (Chiu), would have allowed moderate-income regional housing needs allocation (RHNA) credit for four-plexes was held in the Senate Appropriations Committee.
- AB 2621 (Mullin) would have established a framework for regional climate adaptation planning, laying the foundation for MTC and ABAG to play a key role in future climate adaptation efforts, in collaboration with other members of the Bay Area Regional Collaborative.
- SB 644 (Allen), an MTC priority bill introduced in 2019 that was intended to clarify statutes with regard to the permissible use of personally identifiable information collected by toll agencies and add clarity with regard to toll violation notice requirements.

¹ Due to time constraints, this bill was approved for a support position using both agencies' urgency procedures and will be placed on the September agenda of the Commission and ABAG Executive Board for ratification of those positions.

Other important transportation and housing bills that advanced include:

- AB 107 (Budget Committee)

 transit clean-up legislation to provide greater flexibility to transit operators with regard to expenditures from the State Transit Assistance (STA)-State of Good Repair program and removing Transit Development Act (TDA) and STA penalties associated with fare-box requirements.
- AB 1286 (Muratuchi) insurance requirements and local regulation of shared micromobility devices.
- AB 3088 (Chiu) eviction and foreclosure protections through January 1, 2021 already signed by Governor Newsom and takes effect immediately.
- SB 1351 (Beall) authorizes up to \$5 billion in state revenue bonds for projects in the State Highway Operation and Protection Program (SHOPP) backed by revenues from the vehicle-based Transportation Improvement Fee established in SB 1 (Beall, 2017)
- SB 182 (Jackson) requires local jurisdictions and councils of government to incorporate wildfire risk into their housing element updates and the regional housing needs allocation (RHNA) methodology.
- SB 356 (McGuire) SMART and authority to operate freight rail and address housing needs of employees.

Three notable bills that failed to advance this year include:

- SB 899 (Wiener) would have allowed churches to build 100 percent affordable housing on their parking lots.
- SB 1085 (Skinner) would have expanded density bonus to projects dedicating at least 20 percent of units to moderate-income households.
- AB 2057 (Chiu) proposed various near-term changes to improve the Bay Area transit rider experience and would have created a task force to study Bay Area transit issues. (Note, many of the themes proposed to be studied are being taken up by the Blue Ribbon Transit Recovery Task Force formed by the Commission in May 2020).

Update on COVID Relief Negotiations

Subject: Status update on a potential federal COVID-19 emergency aid package.

Discussion: As of the writing of this memo, Congress and the White House are still working towards closing a very wide gap between the broad \$3 trillion COVID-19 relief package passed by the Democrat-led U.S. House of Representatives back in May (the Health and Economic Recovery Omnibus Emergency Solutions (HEROES) Act) and the

Administration's call for a far narrower coronavirus economic relief bill.

With respect to MTC and ABAG priorities, the HEROES Act—which is serving as a marker for Democratic priorities—would provide nearly \$1 trillion in state and local government aid, make unprecedented investments in emergency rental and homeowner assistance to keep residents in their homes, and, of particular importance to Bay Area transit operators, would backfill for lost transportation revenues. (See Attachment A for a detailed bill summary). In contrast, state and local government aid, transportation backfill and housing funding fall outside of the far more limited approach championed by the White House.

Though negotiations are ongoing, it is highly unlikely that any deal will be finalized until after Congress returns to Washington, D.C. after the September 7th Labor Day holiday. Congress will then face pressure to address a number of "must pass" issues, including COVID-19 response and keeping the federal government funded into fiscal year 2021, before the November 2020 election becomes all-consuming.

HEROES Act Summary

State and local government, housing and transportation provisions of the HEROES Act are summarized below.

State and Local Government Aid

- \$875 billion in payments to state and local governments for COVID-19-related expenses, to respond to negative economic impacts of COVID-19 and, importantly, *to replace lost revenues (see note)*.
 - \$500 billion through the existing Coronavirus Relief Fund for states, territories and tribal governments. An additional \$40 billion would be available for territories and tribes.
 - o \$375 billion for local governments through a new Coronavirus Local Relief Fund
 - \$187.5 billion would be allocated to cities and towns of all sizes. Of the funds allocated to cities, 70 percent would be distributed by the U.S. Department of Housing and Urban Development (HUD) to cities over 50,000 in population (i.e. "entitlement" cities) according to the Community Development Block Grant (CDBG) program formula and the remaining 30 percent would be sent to states, which would be required to suballocate the entire amount to cities and towns based on population.
 - \$187.5 billion would be allocated to counties of all sizes based on each county's population relative to the total population of the nation's counties. The exception to that formula is that a current CDBG entitlement county would receive its entitlement amount if it is higher than what that county would receive under a population-based allocation.

Note: State and local governments were restricted from utilizing the \$150 billion in CARES Act direct aid to replace lost revenues.

• \$10 billion in CDBG assistance for local governments; Half of the funds would be allocated through the CARES Act-created flexible Community Development Fund—which combines features of the conventional CDBG program as well as precedents set by CDBG-Disaster Relief (CDBG-DR) supplementals in response to disaster. The remaining funds would be allocated through the traditional CDBG program.

Housing and Homelessness Assistance

- \$100 billion in emergency rental assistance to help low-income renters at risk of homelessness avoid eviction.
- \$75 billion for a Homeowner Assistance Fund to assist individuals with mortgage payments, property taxes, and other housing-related costs. Funding would be administered by states, territories and tribes.
- \$12.5 billion in homeless assistance funding. Of this, \$11.5 billion would be allocated through the HUD Emergency Solutions Grant program and \$1 billion would be provided for HUD Housing Choice Vouchers targeted to people at-risk of or experiencing homelessness.

- Nearly \$7 billion in traditional HUD rental assistance and public housing support.
- Tenant Protections: Expansion and extension of the CARES Act eviction and foreclosure moratoriums to one year and six months, respectively, after the date of the HEROES Act enactment.

<u>Transportation Funds</u>

- \$15.75 billion in public transportation assistance to supplement the \$25 billion in CARES Act public transit assistance.
 - \$11.75 billion, or nearly three quarters of the funds, would flow via formula to hard-hit regions; the Bay Area's transit operators would receive an estimated \$780 million.
 - \$4 billion would be administered by FTA; discretionary funds available to any transit operator with significant funding needs above and beyond those covered by CARES Act and HEROES Act formula allocations.
 - Like in the CARES Act, replacement revenues would be extremely flexible and would not require a local match (eligible for 100 percent federal share). Funding eligibilities would include operating costs to maintain service, to backfill lost revenue, paying for system cleaning, and paying administrative leave for operators or contractor personnel due to reductions in service. However, the bill would require that to the maximum extent possible, both HEROES Act and CARES Act funds should be directed to payroll and maintaining transit service.
- \$15 billion in highway emergency assistance to be allocated to states, territories and tribes. Of this, \$14.8 billion would be apportioned to states in proportion to each state's share of the total federal-aid highway program.
 - California would receive an estimated \$1.4 billion; of this, approximately \$30 million would be suballocated to MTC for projects in the Bay Area.
 - O Highway emergency backfill fund eligibility would be very flexible; Funds could be used for the traditional road, bridge, and bicycle/pedestrian projects eligible under the Surface Transportation Block Grant Program (STP) and to cover operating expenses, including paying employees, contractors, information technology needs and availability payments). Funding would also be eligible for flexing to public transit purposes, similar to under current law with respect to the largest highway programs. Like the transit replacement revenue, the emergency aid would not require a local match.
- Transit Public Health Requirements: The bill also includes new requirements that large transit operators require that passengers wear face coverings, that employees are provided with protective equipment, and that public transit vehicles, stations and facilities are sanitized in accordance with CDC guidelines. "Large transit operators" are defined as operators that serve urbanized area populations of over 500,000 individuals and that provided a minimum of 200,000 unlinked passenger trips in the most recent year for which data is available.

Congress Went on Recess

Congress left Washington, D.C., on August 6, 2020. The House of Representatives did return on August 22 to vote on a United States Postal Service financial assistance bill. Congress is expected to return to Washington, D.C., on September 8, 2020.

House Passes Fiscal Year (F.Y.) 2021 Transportation, Housing and Urban Development, and Related Agencies (THUD)Appropriations Bill

On July 31, 2020, the House passed its FY 2021 THUD Appropriations bill on a 217 to 197 vote.

The Senate has not yet introduced their version of any of the 12 Appropriations bills for FY 2021, thereby increasing the likelihood of a short-term continuing resolution that would extend federal funding beyond September 30 to avoid another government shutdown.

COVID Aid Stalls

Federal unemployment insurance expired on July 31, 2020. Then Congress left D.C. for the first week of August. The House Bill (H.R. 6800) at \$3.4 trillion passed in May. On July 28, 2020, Senate Republicans released a package totaling around \$1 trillion.

On August 27, 2020, it was reported that House Speaker Nancy Pelosi had attempted to reengage negotiations by reducing the House Bill by \$1 trillion. The White House Chief of Staff Mark Meadows rejected the offer.

Federal Transit Administration (FTA) sends Full Funding Grant Agreement (FFGA) for BART's Transbay Corridor Core Capacity Program

On August 6, 2020, the FTA sent a mandated 30-day review notice to Congress stating its intent to award an FFGA to BART.

BART requested approximately \$1.17 billion, which is 43.2% of the Transbay Corridor Core Capacity project's \$2.7 billion costs.

Legislative Intent Discussion with Rep. Desaulnier's Staff

On August 14, 2020, we discussed the legislative intent of Rep. DeSaulnier's legislation (H.R. 7962) related to transparency requirements for how transportation investement decisions are made. First off, Rep. DeSaulnier's staff concluded that this legislation, which would make significant changes to the Federal transportation planning process, isn't going anywhere this Congress.

Rep. DeSaulnier's staff did agree to have MTC review the proposed legislation and make recommendations in the future.

Coming and Going

Joel Szabat's nomination to be the United States Department of Transportation Under Secretary for Policy took one more step forward as the Senate Commerce, Science, and Transportation Committee approved his nomination on July 22, 2020. Senate approval is hopefully happening in September.

New Legislation

The House passed H.R. 4686 on July 29, 2020. The bill requires transportation network companies, such as UBER and Lyft, to establish and implement a system allowing passengers to verify the driver they have been matched with.
