

Subject:Presentation on the PDA Planning Program history, progress to date, and next steps.

Background: Since its inception, the PDA Program has funded more than 60 plans for cities throughout the Bay Area and enabled nearly 50 technical assistance projects to facilitate implementation of adopted PDA plans. The program is one of the primary tools for linking regional and local planning and for integrating land use and transportation planning. By rewarding cities that voluntarily plan for areas critical to the region's growth framework, the program embodies the Bay Area's collaborative approach to implementation. Plan Bay Area (2013) and Plan Bay Area 2040 (2017) dedicated funding for PDA Planning Grants and Technical Assistance, building upon previous funding through the FOCUS program.

Later this year, staff anticipates soliciting Letters of Interest from local jurisdictions for PDA planning and technical assistance grants, utilizing roughly \$6 million of the funding allocated to the program in the second round of the One Bay Area Grant (OBAG) program to support implementation of Plan Bay Area. This item highlights the progress of the program to date, identifies challenges and opportunities, and outlines the proposed approach to the upcoming call, including integration with ABAG's new Regional Early Action Program (REAP).

Progress to Date

To date, locally-adopted plans funded by the PDA Planning Program have added more than 100,000 homes and 75 million square feet of commercial floorspace in development capacity. This includes plans for PDAs around BART expansion stations and SMART stations, as well as multiple plans in eight of the region's nine counties. Examples of successful program-funded projects include:

- *Planning Grants.* The Warm Springs Community Plan, highlighted in Attachment A, exemplifies the potential of the program to link regional and community-scale planning for shared benefit. A PDA Planning Grant allowed the City of Fremont to complete a plan for an area that included a future BART station and the site of a former auto manufacturing plant during the Great Recession. Adopted in 2014, the community-driven plan positioned the area for implementation with the return of the real estate market and the opening of the Warm Springs BART Station in the late 2010s. More than half of the 5,000 planned units, starting with 500 units of affordable housing, an elementary school, and community park have either already been built or are currently under construction.
- *Technical Assistance Grants*. Through its seven grant cycles, the program has evolved to meet the changing needs of local jurisdictions. In advance of the first Plan Bay Area, smaller-dollar Technical Assistance grants were added to respond to shared implementation obstacles identified by cities with PDAs, and to allow cities to adapt to changes in the real estate market, state legislation, or community priorities. The current grant cycle, awarded in 2018, piloted a successful multi-city Technical Assistance grant that allowed three suburban jurisdictions to work together to update transportation impact analysis procedures to comply with state requirements established through Senate Bill 743.

Challenges and Opportunities

The upcoming call for Letters of Interest aims to address the challenges and opportunities that have surfaced during recent grant-funded projects and local engagement. These include support for incorporating racial equity into planning processes, adapting to recent state housing and transportation legislation, reducing administrative burden on local staff, and offering "over the counter" assistance for unanticipated obstacles that arise during plans. Other opportunities relate to increasing the share of permanently affordable homes and more effectively aligning commercial zoning with market feasibility. Finally, the call is an opportunity to align the PDA Planning Program with the 2019 Regional Growth Framework update, which revised the PDA definition to integrate equity, housing security, economic opportunity, and new mobility.

Integrating PDA and Housing Technical Assistance

The first phase of ABAG's Regional Early Action Program (REAP), which also funds local jurisdiction planning, will roll out in parallel with this round of PDA planning and technical assistance grants. REAP is being considered this month by the ABAG Housing Committee and the ABAG Executive Board. While REAP is squarely focused on housing and the PDA Planning Program sits at the intersection of housing and transportation, the programs fund many of the same activities, such as zoning amendments in PDAs and other areas near transit, and the same local staff would typically apply for grants from both programs. Given diminished local resources and the urgent need for regional support, staff propose to streamline the application process for REAP and PDA Planning Program through a single integrated call for Letters of Interest. Using a "checkbox" approach, local applicants would identify and describe the type(s) of support needed. Regional staff would match eligible needs with available resources from both programs, and return to the Planning Committee for authorization to proceed with recommended awards.

Next Steps: Staff anticipates issuing a call for Letters of Interest in December 2020. To ensure broad engagement, staff will host webinars, present at county planning director meetings, and establish "office hours" to assist prospective applicants. Staff anticipates returning in early Spring 2021 with recommended awards.







Context: Evolution of PDAs






