Under ABAG Executive Board agenda <u>Item 7.a.</u>, this is the ABAG Administrative Committee report for <u>December 17, 2020</u>.

The ABAG Administrative Committee met jointly with the MTC Planning Committee on <u>December 11, 2020</u>. The Committee received the following report:

- Plan Bay Area 2050: What's Next for 2021?
 - Presentation on the status of Plan Bay Area 2050 and anticipated milestones for the final phase in 2021.
 - This month, MTC/ABAG staff plan to release the analysis findings from the Plan Bay Area 2050 Final Blueprint, and concurrently release the Draft RHNA methodology.
 - Two informational webinars will be held in mid-December and early January for stakeholders, elected officials, and Bay Area residents.
 - Local jurisdictions and other stakeholders will also be eligible to sign up for virtual office hours later in December and in January.
 - Information on these opportunities is available on *planbayarea.org*.
 - Staff will then present the Final Blueprint and Draft RHNA Methodology to MTC/ABAG committees, the Commission, and Executive Board for approval in January.
 - The focus of 2021 will be on three remaining deliverables: the Implementation Plan, the Plan Document, and the Environmental Impact Report.
