**Subject:** 

This memorandum requests approval of a pre-qualified bench of consultants summarized on Attachment A ("Bench") to provide as-needed consulting assistance services to support MTC with quick-build design and engineering and construction management services. The term of the Bench is from March 1, 2021 to June 30, 2023, with an option to extend for an additional two years to June 30, 2025. Other public entities will be eligible to utilize firms on the bench for their own quick-build design and engineering and construction management services.

**Background:** 

On November 5, 2020, MTC issued a Request for Qualifications for the 2020 Quick-Build Design, Engineering, and Construction Management Services, Cycle 1 ("RFQ") inviting firms to submit Statements of Qualifications ("SOQ") for one or both of the following two service categories:

Service Category A: Design and Engineering Services Service Category B: Construction Management Services

An email notice of the opportunity was sent to over 2,800 individuals and firms. On December 9, 2020 MTC received 18 SOQs from firms, many of which applied to both service categories. The Minimum Qualifications required that teams must include at least one key person who is either a California licensed professional Civil Engineer or Architect. All SOQs were determined to meet the Minimum Qualifications. MTC declined to review one proposal due to a conflict of interest. Separate evaluation panels comprised of MTC and City of San Jose staff reviewed applicants for each service category based upon the following evaluation criteria specified in the RFQ, which are listed in descending order of importance:

1.	Quick-Build Experience	4	40%
2.	Key Personnel Experience		30%
3.	Previous Augmented/On-Call Staff Expo	erience 2	20%
4.	Presentation		10%
	Possi	ble Total:	100%

For each service category, the firms that the evaluation panels recommend for inclusion on the Bench are indicated with a number "1" in Attachment A. All recommended firms demonstrate an expertise in one or both of the service categories for which they were selected. The recommended firms provide a mix of local and national experience and expertise that will be valuable in helping local agencies design and implement quick-build projects in the Bay Area. Firms which are not recommended for inclusion on the Bench for a particular service category are indicated by the number "0" in Attachment A.

A summary of each firm's Disadvantaged Business Enterprise (DBE) status and Small Business Enterprise (SBE) status is listed by service category on Attachment B. For Design and Engineering Services, one DBE firm applied as a prime and was determined to be qualified. Seven other DBE firms will serve as subconsultants to one or more firms in this service category. For Construction Management Services, two DBE firms applied as primes to the bench, and both were determined to be qualified. One of those primes and nine other DBE firms will serve as subconsultants to one or more firms on the Bench. Of the 13 total DBE firms involved on the Bench, seven of them will participate either as a prime or subconsultant in both service categories.

Any firms approved in Cycle 1 will be eligible for work throughout the life of the Bench. Selection for entry into a contract with one of the pre-qualified consultants may take place by direct selection or via a mini-procurement, pursuant to MTC's Third-Party Contracting Policies and Procedures. Additional firms may be added to the Bench in response to re-issuance of the RFQ in later cycles given certain conditions.

Contract periods of performance and amounts will be determined on a per-contract basis based on the project solicited to the Bench. The amount included for this program in the proposed FY 2021-23 budgets will be determined on a per-contract and project basis. Staff will return to the Operations Committee for authorization of any contracts exceeding the Executive Director's signature authority.

**Issues:** None.

**Recommendation:** Staff recommends that the Operations Committee approve the pre-qualified

consultant bench identified in Attachment A to provide Quick-Build Design and Engineering and Construction Management services to MTC in the specified categories on an as-needed basis, for a period through June 30, 2023, with an option

to extend the Bench performance period through June 30, 2025.

**Subject:** 

Recommendation of First Data as the payment services vendor for the C2 regional fare payment system.

**Background:** 

A Request for Proposals for C2 payment gateway and acquiror services (the "C2 Payment Services RFP" or the "RFP") was issued on September 3, 2020. (A "payment gateway" transmits payment data and transaction authorization between the merchant — in C2, the "merchant" will be MTC – and the "acquiror", which is a bank that processes credit/debit card payments for a merchant.) The C2 Payment Services RFP is one of four RFPs which have been, or will be, issued to procure elements of the C2 system, consistent with the Clipper Executive Board's (CEB) vision for disaggregated procurement of the C2 system.

Four firms—First Data, Paymentech, Inc. dba J.P. Morgan ("J.P. Morgan"), Bank of America, and Global Payments, Inc.—submitted proposals in response to the RFP. An evaluation panel – made up of representatives from MTC and SamTrans, and supported by technical advisors from the IBI Group and BART — reviewed the proposals, and then held discussions with each proposer on December 8, 2020. Following those discussions, a Request for Best and Final Offers ("BAFOs") was issued by MTC on December 15, 2020, to all four proposers, and each firm timely responded. The RFP evaluation panel has completed its review and evaluation process, and staff now brings forward to this Committee the panel's unanimous recommendation of a vendor for C2 Payment Services.

The evaluation factors were: Firm and Team Qualifications and Experience (20%); Proposed System and Services (40%); Implementation and Management Plan (10%); Cost Effectiveness (25%); and Presentation (5%).

All proposers were found to meet the minimum qualifications, be compliant with the RFP requirements, and proposed solutions that generally cater to Clipper's use cases in an account-based fare payment system. Many of the solutions and processes offered are relatively standard and similar, since payment processing is a highly regulated industry and the vendors have extensive experience in it. Key vendor features that were considered, and where some differentiation could be discerned by the evaluation panel, included security and tokenization, reliability, reporting, and ability to support new technology. In this procurement, another important factor in determining a suitable vendor is the vendor's ability to integrate with systems of the C2 System Integrator – Cubic Transportation Systems, Inc. (Cubic).

If the staff recommendation is approved by this Committee, staff will endeavor to enter into a contract with First Data as soon as practicable, so that this vendor can participate in the C2 system design and implementation process. Staff seeks authorization for a contract that will extend through an initial five-year term of C2 transaction processing — such processing currently estimated to begin in approximately May 2022 — plus two optional one-year renewals.

In its price proposal submitted as part of its RFP proposal, First Data did not include any costs that would be payable during the pre-C2 transaction processing time period, unless during the C2 implementation process it is mutually determined that additional work is necessary by First Data beyond the scope of the RFP. \$200,000 is included in the FY 20/21 Clipper Capital Budget to pay for capital costs associated with the implementation of C2 payment services, and that amount is included in this request for contract authorization. Once C2 transaction processing begins, various transaction costs will be payable to First Data in accordance with the formula for allocating operating costs in a future update to the Clipper Memorandum of Understanding, and this request seeks authorization for \$21,550,000 in O&M costs— the estimated amount of total monthly costs over a five-year period based upon pre-pandemic Clipper transaction volume.

First Data is neither a small business nor a disadvantaged business enterprise. The CEB approved this recommendation of First Data at its January 25, 2021 meeting.

#### **Recommendation:**

Staff recommends the Operations Committee approve an award of a Contract to Fiserv, Inc. dba First Data Merchant Services, LLC, to act as C2 Payment Services vendor for the C2 regional fare payment system and authorize the Executive Director or designee to negotiate and enter into such Contract in an amount not to exceed \$21,750,000, as described above.

Subject: Contract Amendment – On-Call Design Services: Technical Assistance for West Grand Avenue HOV/Bus Lane Extension: URS Corporation Americas (URS).

**Background:** In January 2019, construction of the first phase of the West Grand HOV/Bus Lane

project was completed. This project converted approximately 1,300 feet of the right shoulder on the West Grand Avenue on-ramp/northbound I-880 connector approach to the San Francisco Oakland Bay Bridge (SFOBB) to a bus lane. The goal of the project was to increase Transbay person-throughput by providing access and operational improvements for buses and HOVs. Upon completion of the first phase of the project, significant operational improvements were observed, with up to 21 minutes of travel time savings for buses and HOVs during the morning commute. Despite these operational improvements, however, excessive queues still occur along West Grand Avenue before the start of the HOV lane, prompting the need to extend

the HOV/bus lane further east.

Phase 2 of the West Grand HOV/Bus Lane project proposes to extend the Phase 1 HOV/Bus Lane further east by converting an additional 2,500 feet of the right shoulder on West Grand Avenue between the West Grand Avenue on-ramp/I-580 Eastbound on-ramp split and the West Grand Avenue/Frontage Road intersection. The project will also include the construction of a multi-use path on West Grand Avenue between Maritime Street and Mandela Parkway to improve bicycle and pedestrian access.

In October 2016, after a competitive procurement for the Phase 1 project under the 2014 Design Services bench, this Committee approved the selection of URS because of its understanding of the project and its challenges, proposed management team, staff experience, and the capacity of qualified personnel to complete the project according to schedule. Under a proposed contract amendment, URS would continue to provide technical assistance in the design and stakeholder coordination of Phase 2 of the West Grand Avenue HOV/Bus Lane Extension project. Attachment A includes a summary of URS and its project team's small business and disadvantaged business enterprise status.

**Recommendation:** Staff recommends that the Operations Committee authorize the Executive Director or

**Subject:** 

Request for approval of a contract amendment between MTC and CH2M Hill, Inc. (CH2M Hill), for continued technical oversight and advisory services for the Clipper® program in FY 2020-21 and FY 2021-22.

**Background:** 

In 2009, MTC entered into a competitively-procured, multi-year contract with Booz Allen Hamilton to provide technical support and oversight for the design and implementation of Clipper® on the Bay Area transit operators, as well as technical support for Clipper® operations and maintenance through the completion of the contract--then November 2019. Booz Allen Hamilton assigned this contract to CH2M Hill in 2011. Over the past ten years, CH2M Hill has supported many implementation and operations and maintenance tasks, including deployment of Clipper® at multiple transit agencies, integration of ticket vending machines and faregates, card inventory and retail network management, and design, testing, and deployment support for numerous system modifications. In 2019 the CH2M Hill contract was extended up to five years to match the extension period of the Clipper Fare Payment System Integrator Contract (C1 Contract).

Under the proposed amendment, CH2M Hill would provide support for the following activities in FY 2020-21 and 2021-22 on an as-needed basis:

- 1. Administration of the C1 Contract, including change notice and change order development, proposal evaluation, and independent engineer's estimates;
- 2. Development and maintenance of a master schedule summarizing all work in progress;
- 3. Support for transit operator requests for replacement of Clipper® equipment;
- 4. Delivery of various system modifications, including support for testing, distribution, and reports;
- 5. Management of card inventory and oversight of the Clipper® retail network;
- 6. Development and oversight of institutional programs, products, and strategy; and
- 7. Technical operations, including financial reconciliation and reporting, data analysis and reporting, asset management, and evaluation and support of system and device maintenance.

The contract amendment would provide resources equivalent to 1.75 full-time staff, including subcontractors, to support the activities above, which equals just over \$300,000 per fully loaded full-time equivalent. In utilizing technical advisor services, MTC weighs the value of directly hiring staff versus contracting for specialized expertise. MTC recently prioritized several Clipper staff members to focus on the delivery of the next generation Clipper® system. This contract amendment would provide the necessary CH2M Hill resources to allow for the backfill of these positions.

The Clipper Executive Board approved this proposed contract amendment at its January 25, 2021 meeting.

CH2M Hill's and its subcontractors' small business enterprise and disadvantaged business enterprise status is set forth in Attachment A.
