SEVEN, I BELIEVE. 7A, MTC RESOLUTION 4567 AND ABAG RESOLUTION
NUMBER 10-2023 PRIORITY SITES NOMINATION CRITERIA. BACKGROUND
INFORMATION ON THE PRIORITY SITE PROGRAM AND LEADING TO
SOLICITATION OF LOCAL NOMINATIONS OF ELIGIBLE PRIORITY SITES.
THIS IS AN ABAG AND MTC ACTION ITEM. MARK SHORETT WILL PRESENT
ON THE ITEM.

MATT MALONEY: MATT MALONEY MTC AND ABAG. GOOD TO SEE ALL IN-12 PERSON. I WANT TO INTRODUCE THIS ITEM ON PRIORITY SITES. 13 EVERYTHING WE DO, THIS INITIATIVE STEMS FROM PLANNED BAY AREA 14 15 2050 WHICH AS YOU KNOW, PUSHED THE ENVELOPE IN ORDER TO REACH 16 OUR HOUSING PRODUCTION AND AFFORDABILITY GOALS. IN PARTICULAR, THE PLAN HAD TWO RELEVANT STRATEGIES. REINVENTING 20th CENTURY 17 MALLS AND OFFICE PARKS AS COMPLETE COMMUNITIES WITH MIXED 18 INCOME HOUSING, LOCAL AND REGIONAL SERVICES AND PUBLIC SPACES, 19 AND SECONDLY ACCIDENT ACCELERATING THE REUSE OF SURPLUS PUBLIC 20 21 LAND OWNED BY NON-PROFIT INSTITUTIONS TO MEET COMMUNITY HOUSING AND SERVICE NEEDS, EXPAND SMALL BUSINESS OPPORTUNITIES 22 AND CREATE COMMUNITY GATHERING SPACES. SO WITH THOSE 23 STRATEGIES WE CONTINUE TO FOCUS ON OUR REGIONAL GROWTH 24 GEOGRAPHIES LIKE PDAS TRANSIT-RICH AREAS, AND THE NEW TRANSIT 25

ORIENTED COMMUNITY AREAS BUT ALSO DEEP AFFORDABILITY IN TERMS 1 OF WHAT WE'RE TRYING TO DO WITH THESE PLACES. SO THIS IS THE 2 3 THIRD COMMITTEE THIS WEEK HAS DISCUSSED THIS ISSUE. SOME OF YOU HAVE BEEN A PART OF THOSE CONVERSATIONS SOME OF YOU HAVE 4 5 NOT. GIST A OUICK ORIENTATION ON THIS ISSUE. ON WEDNESDAY OF THIS WEEK, MTC'S ADMINISTRATION COMMITTEE APPROVED A GRANT OF 6 FUNDING OF STATE REAP \$2.0 OF 43 MILLION TO THE BAY AREA 7 8 HOUSING FINANCE AUTHORITY OR BAHFA. 28 MILLION OF THAT 43 MILLION IS FOR THIS PRIORITY SITES PROGRAM. AND JUST 9 YESTERDAY, THE BAHFA OVERSIGHT COMMITTEE JOINED BY THE ABAG 10 HOUSING COMMITTEE VOTED TO ACCEPT THAT FUNDING, AS WELL AS THE 11 RELATED SET OF SPECIFIC TERMS AND CRITERIA USED TO AWARD FUNDS 12 TO SPECIFIC SITES. SO WHAT WE'RE DOING TODAY IS WE'RE ZOOMING 13 OUT A BIT. OF THOSE SPECIFICS AND WHAT WE'RE FOCUSED ON TODAY 14 IS THE BROADER SET OF CRITERIA THAT WE LIKE TO USE TO 15 16 ESTABLISH WHAT IS HOPEFULLY A ROBUST PIPELINE OF PRIORITY SITES. YOU CAN THINK OF THIS PIPELINE AS A FINANCIALLY 17 UNCONSTRAINED LIST. IT'S VERY VITAL TO OUR LONG-RANGE PLANNING 18 IT HELPS US GROUND TRUTH INFORMATION AS WE GET INTO OUR NEXT 19 LONG RANGE PLAN. SINCE AS YOU KNOW IN PLANNED BAY AREA WE 20 DEVELOPED A FORECASTED PATTERN THERE IS KIND OF A DATA 21 INFORMATION IMPORTANCE TO US FOR THIS. IT GIVES US A GOOD POOL 22 OF APPLICANTS THAT THEN BAHFA WILL CONSIDER FOR FINANCIAL 23 SUPPORT, WITH A FOCUS ON PREDEVELOPMENT FUNDING. WHICH, FOR 24 BIG SITES LIKE THIS IS A BIG NEED GOING FORWARD. AND I THINK 25

LASTLY, AND ALSO IMPORTANTLY, GETTING THIS POOL OF PRIORITY 1 SITES ALLOWS US AS STAFF TO CONTINUE WITH OUR TECHNICAL 2 3 ASSISTANCE EFFORTS MOVING FORWARD. SO, I MEAN, THIS IS OBVIOUSLY A BIG DEAL FOR BAHFA. THIS IS REAL LIVE 4 5 IMPLEMENTATION MONEY FOR HOUSING. AT THE SAME TIME IT'S A GREAT OPPORTUNITY FOR CROSS COLLABORATION BETWEEN MTC AND ABAG 6 AND BAHFA AND I THINK WE ALL HAVE A ROLE TO PLAY, AND MARK HAS 7 8 A GOOD VIN DIAGRAM TO SHOW ON YOU THAT. TODAY WE'RE REQUESTING APPROVAL OF THE PRIORITY SITES CRITERIA FROM BOTH BODIES 9 10 TODAY, BOTH FROM THE MTC PLANNING COMMITTEE AND THE ABAG ADMINISTRATIVE COMMITTEE. SO I'LL PASS IT TO DO MARK WHO WILL 11 GIVE THE PRESENTATION. 12

MARK SHORETT: THANKS MATT. AND HELLO COMMITTEE MEMBERS. THANKS 14 15 FOR THE OPPORTUNITY TO BE HERE AND SPEAK WITH YOU TODAY. IF MY 16 COLLEAGUES IN THE BACK BOOTH E TECHNICAL STAFF COULD PLEASE PULL UP THE POWERPOINT PRESENTATION? GREAT. THANK YOU. SO, 17 LET'S GO TO THE NEXT SLIDE. MATT TALKED ABOUT THE WAY IN 18 WHICH, WHAT WE'RE GOING TO DISCUSS TODAY IS ROOTED IN PLANNED 19 BAY AREA 2050. TO ADD, I THINK, ONE MORE ELEMENT TO THAT, PART 20 21 OF THE PLAN WAS AN IMPLEMENTATION PLAN. IT WAS THE LAST SECTION. AND THAT REALLY CALLED ON STAFF TO ENGAGE A VARIETY 22 OF PARTNERS AND TOPIC AREA EXPERTS TO BEGIN TO IDENTIFY THE 23 POLICIES AND INVESTMENTS NEEDED TO ADVANCE EQUITABLE REUSE ON 24 THE LARGE-SCALE, MALL AND OFFICE PARK, AS WELL AS PUBLIC LAND 25

SITES THAT WERE CRITICAL TO HELPING A PLAN MEET ITS HOUSING 1 2 NEEDS AS WELL AS REDUCE GREENHOUSE GAS EMISSIONS. SO IT WAS ALSO CRITICAL, AS WE DID THIS, TO GROUND THE EFFORT IN THE 3 WORK OF LOCAL GOVERNMENTS AS THEY EMBARK ON THEIR MOST 4 5 CHALLENGING HOUSING ELEMENTS TO DATE. SO THAT WAS A BIG PART OF WHAT WE DID IN THE YEAR THAT FOLLOWED PLANNED BAY AREA 6 2050, WHICH INCLUDED RESEARCH, CONSULTATION, AND COLLABORATIVE 7 8 CONCEPT DEVELOPMENT. IN 2022, WE CAME BACK AND INTRODUCED THE PRIORITY SITES PROGRAM FOR FURTHER REGIONAL DISCUSSION AND 9 10 REFINEMENT INCLUDED A CONCEPT PAPER, WEBINARS, MEETINGS WITH LOCAL STAFF, COMMUNITY-BASED ORGANIZATIONS AND DEVELOPERS AS 11 WELL AS PRESENTATIONS TO THIS COMMITTEE AND A HOST OF OTHER 12 BARRING BAG AND MTC AND BAHFA COMMUNITIES. THE FOLLOWING IS 13 THE OUTCOME OF THIS COLLABORATIVE EFFORT. NEXT SLIDE PLEASE. 14 THE PRIORITY SITES PROGRAM HAS FIVE COMPONENTS WHICH WILL BE 15 16 CARRIED OUT BY ABAG, MTCS AND BAHFA IN COLLABORATION WITH LOCAL GOVERNMENTS COMMUNITY STAKEHOLDERS IN THE COMMUNITY AND 17 IT'S GOING TO COMPLEMENT THE LONG-STANDING INITIATIVES THAT WE 18 HAVE IN PLACE SUCH AS THE PRIORITY DEVELOPMENT AREA PROGRAM 19 AND OUR REGIONAL HOUSING TECHNICAL ASSISTANCE PROGRAM. THE 20 21 FIRST COMPONENT OF THIS WHICH HAS A STAR NEXT TO IT BECAUSE WE'RE GOING TO ASK YOU FOR AN ACTION ON IT IS TO ESTABLISH 22 PRIORITY SITES. SO FOLLOWING COMMISSION AND ABAG EXECUTIVE 23 BOARD APPROVAL OF THE ELIGIBILITY CRITERIA THAT ARE BEFORE YOU 24 TODAY, WHICH WE'LL DIVE INTO SHORTLY, STAFF WILL SOLICIT LOCAL 25

NOMINATIONS FOR PRIORITY SITES ONCE ESTABLISHED, PART OF A 1 PIPELINE OF SITES INTEGRATED INTO THE REGIONAL PLANNING 2 3 ACTIVITIES AND ALSO INFORMS OUR FUNDING STRATEGIES. THE SECOND COMPONENT IS FUNDING PILOT PROJECTS AND MATT ALLUDED TO THIS 4 5 EARLIER. IN DECEMBER 2022, THE PROGRAM COMMISSIONED \$28 MILLION INTO THE EARLY ACTION PLANNING GRANT PROGRAM, REAP TWO 6 7 TO ENABLE A SET OF TRANSFORMATIVE AFFORDABLE AND MIXED INCOME 8 HOUSING PROJECTS TO BREAK GROUND ON A HANDFUL OF PRIORITY SITES AND AGAIN EARLIER THIS WE'RE SOME OF YOU TOOK ACTION TO 9 GRANT THIS FUNDING. THE THIRD COMPONENT IS TO DELIVER 10 TECHNICAL ASSISTANCE. FOR EARLY STAGE PRIORITY SITES THAT ARE 11 NOT POSITIONED TO APPLY FOR PILOT FUNDING THE PROGRAM 12 ANTICIPATES PROVIDING TARGETED TECHNICAL ASSISTANCE, 13 COMPLEMENTED BY REGIONALLY APPLICABLE TOOLS TO ENABLE LOCAL 14 15 GOVERNMENTS AND EMERGING DEVELOPERS TO CONDUCT WORK NECESSARY 16 TO ENVISION AND ENTITLE PROJECTS ON THESE SITES. FOR PROJECTS FURTHER ALONG THE PROGRAM IS GOING TO OFFER RESOURCES FOR 17 18 IDENTIFYING AND PURSUING ADDITIONAL FINANCING WITH OTHER PUBLIC AGENCIES AND UTILITIES. FOURTH COMPONENT IS INTEGRATING 19 SITES INTO PLANNED BAY AREA 2050 PLUS, THE UPDATE TO PLANNED 20 BAY AREA 2050. ALL OF THE ELIGIBLE SITES ARE GOING TO BE 21 22 INCORPORATED INTO THE PLAN WHICH WILL REALLY SHARPEN THE 23 PROJECTED GROWTH PATTERN AND STRENGTHEN ITS CONNECTION TO THE ON THE GROUND KNOWLEDGE AND PRIORITIES, PARTICULARLY RELEVANT 24 IN THE CONTEXT OF THE HOUSING ELEMENTS. FIFTH, SET UP SITES 25

FOR FUTURE SUCCESS. SO, IN ADDITION TO PROVIDING THE PILOT 1 2 FUNDING THAT WE DISCUSSED, AS WELL AS TECHNICAL ASSISTANCE, 3 THE PROGRAM IS INTENDED TO EXPAND THE PIPELINE OF EQUITABLE HOUSING PROJECTS IN THE BAY AREA THAT ARE POSITIONED TO 4 5 UTILIZE EXISTING AS WELL AS FUTURE FUNDING, INCLUDING A POTENTIAL 2024 REGIONAL HOUSING INITIATIVE. NEXT SLIDE. MATT 6 TALKED ABOUT THE BIN DIAGRAM RELATED TO THE WAYS IN WHICH MTC 7 8 AND ABAG AND BAHFA ARE GOING TO COLLABORATIVELY DELIVER ON THIS WORK DRAWING ON THE FULL EXPERTISE OF STAFF. MTC AND ABAG 9 AS A REGIONAL PLANNING AGENCY ARE GOING TO ORCHESTRATE THE 10 SITE NOMINATION PROCESS IN CONCERT WITH LOCAL PARTNERS AND 11 INTEGRATE THE SITES INTO THE PRIMARY 2050 PLAN AND ADMINISTER 12 THE CAPITAL FUNDING THAT SOME OF YOU ACTED UPON EARLIER THIS 13 WEEK INCLUDING FIRST SET FUNDED BY PROJECTS LASTLY GOING TO 14 WORK COLLABORATIVELY TO DELIVER TECHNICAL ASSISTANCE AND WORK 15 16 TO SET UP SITES FOR FUTURE SUCCESS WHICH IS NUMBER 3 AND 5 AT THE BOTTOM YOU CAN SEE ALL OF THE CIRCLES COMING TOGETHER. 17 NEXT SLIDE PLEASE. TO LAUNCH THE PROGRAM, WE'RE REQUESTING 18 APPROVAL OF ELIGIBILITY CRITERIA FOR PRIORITY SITES. THE 19 NOMINATION CRITERIA ARE INTENDED TO BE SIMPLE AND TO 20 21 ACCOMMODATE A VARIETY OF SITES THAT REFLECT THE DIVERSITY OF 22 THE REGION'S COMMUNITIES. THESE CAN BE THOUGHT OF AS KIND OF A FLOOR. FIRST, ELIGIBLE APPLICANTS, THESE INCLUDE A LOCAL 23 GOVERNMENT OR THE DEVELOPER OF A PROJECT THAT'S ALREADY 24 ENTITLED BY A LOCAL GOVERNMENT. LOCATION TO SUPPORT FRAMEWORK 25

IF WE CAN GO TO THE NEXT 7 8 SLIDE WE'LL GET INTO THAT. SO TO CAST A WIDE ENOUGH NET TO ENABLE PARTICIPATION REGION-WIDE, WITHOUT LOSING THE OVERALL 9 GOAL OF LIFTING UP THE BAY AREA'S HIGHEST IMPACT PROJECTS, THE 10 CRITERIA FOR SITE CAPACITY, IN THIS CASE, THE NUMBER OF HOMES 11 THAT CAN BE BUILT ON THE SITE IS BROKEN INTO THREE CATEGORIES 12 THAT WERE REALLY INFORMED BY DISCUSSIONS WITH LOCAL STAFF, AND 13 I'LL PROVIDE AN EXAMPLE ON THE NEXT SLIDE OF EACH OF THESE. 14 FIRST REGIONALLY SIGNIFICANT SITES. THESE ARE SITES WITH 15 16 CAPACITY FOR GREATER THAN 500 HOMES IN A LOCALLY ADOPTED PLAN ZONING CODE OR ENTITLED PROJECT. SECOND COMMUNITY ANCHORS SITE 17 WITH CAPACITY FOR AT LEAST 100 HOMES AS WELL AS 10,000 SOUARE 18 FEET OF COMMUNITY SPACE. AND ONE OF THE THINGS WE HEARD IN 19 TALKING WITH SOME OF THE SMALLER CITIES IN THE REGION, WHO ARE 20 21 KIND OF HARD PRESSED TO HAVE THESE LARGER SCALE PROJECTS IS THAT THERE MIGHT BE A PROJECT OF 75 UNITS OR 60 UNITS THAT 22 MAKES UP A REALLY LARGE SHARE OF THEIR VERY LOW RHNA, AND IF 23 THAT'S THE CASE, WE WANT TO MAKE SURE THAT'S ALSO ELIGIBLE 24 THAT'S THE STANDARD USE YOU SEE IN THE INSTANCE OF AT LEAST 25

25% OF THE JURISDICTION IS VERY LOW OR LOW-INCOME RHNA IS 1 ACCOMMODATED ON-SITE. AND THEN LASTLY, PUBLIC SITES PORTFOLIO, 2 3 THIS CATEGORY ENABLES NOMINATIONS FOR MULTIPLE PUBLICLY OWNED SITES INTENDED TO BE DEVELOPED IN CONCERT WITH THE TOTAL 4 5 CAPACITY FOR AT LEAST 200 HOMES. NEXT SLIDE, PLEASE. SO, HERE'S SOME EXAMPLES OF EACH OF THESE SITE TYPES, JUST TO, 6 SORT OF, ILLUSTRATE IT FOR YOU IN THE PICTURE. FOR THE 7 8 REGIONALLY SIGNIFICANT CATEGORY EXAMPLES MIGHT INCLUDE AIRPORT FOR PLANNED REUSE OR AGING SHOPPING CENTER, NEXT SITE 9 COMMUNITY ANCHOR MIGHT BE MIXED USE PROJECT INCLUDES CULTURAL 10 CENTER AND AFFORDABLE HOMES. FOR PUBLIC SITES PORTFOLIO AN 11 EXAMPLE THAT WE ENCOUNTERED IN MEETINGS WITH LOCAL STAFF WERE 12 A SET OF DOWNTOWN CITY OWNED PARKING LOTS THAT WERE IDENTIFIED 13 IN THE HOUSING ELEMENT AND COULD BE MOVED FORWARD 14 15 COLLABORATIVELY TO ACHIEVE ECONOMIES OF SCALE AND MAKE DEEPER 16 LEVELS OF AFFORDABLE. NEXT SLIDE. SO THAT'S THE CRITERIA AND THIS DIAGRAM TRIES TO TIE TOGETHER ALL THE PROGRAM'S 17 COMPONENTS STARTING ON THE LEFT, WITH THE APPROVAL THIS MONTH 18 WE'LL BE ABLE TO ESTABLISH A PIPELINE OF REGIONAL PRIORITY 19 SITES AND AMONG THOSE UNIVERSAL SITES THOSE PROJECTS 20 21 DEMONSTRATING READINESS AND HOST EVER AFFORDABILITY, EQUITY AND MOBILITY BENEFITS WILL BE ABLE TO APPLY FOR THE PILOT 22 FUNDING ADMINISTERED BY BAHFA THAT WE DISCUSSED. ASSISTANCE. AND LOOK ALL THE WAY TO THE RIGHT IN THIS DIAGRAM, 1 ALL THESE SITES WILL BE INTEGRATED INTO PLANNED BAY AREA 2050 2 3 AND RECEIVE REGION WIDE SUPPORT TO SET THEM UP FOR FUTURE SUCCESS. NEXT SLIDE PLEASE. BEFORE TURNING TO NEXT STEPS, 4 5 LET'S ZOOM IN FOR A MOMENT INTO THE SECOND COMPONENT OF THE PROGRAM, THE PILOT FUNDING. AND I THINK THIS IS HOPEFULLY 6 HELPFUL FOR THOSE OF YOU THAT WEREN'T PRESENT AT SOME OF THE 7 8 COMMITTEE MEETINGS EARLIER THIS WEEK, WHERE ACTION TOOK PLACE. THE PROGRAM IS GOING TO PROVIDE \$28 MILLION TO ACCELERATE A 9 SELECT NUMBER OF PROJECTS ON ELIGIBLE PRIORITY SITES TOWARD 10 GROUNDBREAKING BY FUNDING PREDEVELOPMENT ACTIVITIES THAT, SORT 11 OF, GET THEM OVER THE FINISH LINE. BAHFA ADMINISTRATION OF 12 THESE FUNDS WAS ADVANCED THROUGH COMMITTEE APPROVALS EARLIER 13 THIS WEEK AND WAITS COMMISSION AND BAHFA BOARD APPROVAL AT THE 14 15 OF THE MONTH. THE INTENDED OUTCOME OF THE PILOT OR SET OF 16 PRECEDENT SETTING PROJECTS THAT LEVERAGE BAHFA'S EXPERTISE TO IMPLEMENT PLANNED BAY AREA 2050 LOCAL HOUSING ELEMENTS AND 17 DELIVER PROOF OF CONCEPT FOR POTENTIAL 2024 REGIONAL HOUSING 18 MEASURE. AND YOU CAN SEE THOSE RELATED APPROVALS AT THE BOTTOM 19 THAT ARE ALLOWING THIS TO MOVE FORWARD. NEXT SLIDE, PLEASE. 20 21 MOVING INTO NEXT STEPS, FOLLOWING ABAG AND COMMISSION APPROVAL OF THE ELIGIBILITY CRITERIA, WE'RE PLANNING TO RELEASE A CALL 22 FOR PRIORITY SITE NOMINATIONS IN APRIL WITH THE FIRST SET OF 23 SITES EXPECTED TO COME FOR APPROVAL MID-SUMMER AND A LARGER 24 25 SET COMING IN SEPTEMBER. ALSO 2 3 IMPORTANT TO MENTION THE PROGRAM, REAP 2.0 PROGRAM FOR THE \$28 MILLION THE CAPITAL MONEY THAT'S EVENTUALLY GOING TO FLOW, 4 5 THAT'S A PROGRAM ADMINISTRATED BY THE HCD AT THE STATE LEVEL AND ALSO AT THE AIR RESOURCES BOARD AND TRANSPORTATION 6 AGENCIES AT THE STATE OF CALIFORNIA THEY HAVE A LOT TO DO WITH 7 8 HOW THOSE GUIDELINES WERE SET UP SO THOSE GUIDELINES INCLUDE CRITERIA SUCH AS LOWER VEHICLE MILES TRAVELED AREAS AND 9 THEY'RE GOING TO BE SCRUTINIZING THAT CONNECTION TO LOW VMT 10 AND INFILL AND TRANSIT STATION AREAS AS WE BUILD THIS PROGRAM. 11 SO I THINK THAT'S THE MOST DIRECT CONNECTION. 12

WITH THAT WHEN WE TALKED ABOUT OUR ONE BAY AREA GRANT 17 PROGRAM WHICH DOES PROVIDE 375 MILLION TO COUNTIES INTO LOCAL 18 PROJECTS TO REALLY SUPPORT THE TRANSPORTATION ASPECT AROUND 19 OUR GROWTH GEOGRAPHIES SO I WANTED TO PUT IN CONTEXT THAT 20 WE'RE TRYING TO MAKE SURE THE FUNDING, \$750 MILLION OVERALL 21 22 HALF OF THAT GOES SPECIFICALLY TO PROJECTS THAT LOCALS 23 IDENTIFY AS HELPING SUPPORT THE TRANSPORTATION AND KNITTING THOSE PIECES TOGETHER THEY'RE SUPPORTING ONE ANOTHER. 24

SO YOU COULD HAVE A PRIVATE DEVELOPER THAT 15 16 POTENTIALLY HAD SEVERAL SITES, ONE SITES FOR THE AFFORDABLE HOURS PIECE, AND THEN IT COULD -- OKAY. THANK YOU. THAT'S -- I 17 18 THINK IT'S ESSENTIAL SINCE THE FAST MAJORITY OF OUR LAND IN THESE PDAS IS NOT PUBLICLY OWNED. THANKS. 19 20 V. PAT ECKLUND: THANK YOU. SO, THIS, SORT OF, THINKING IN A 7 8 LITTLE BIT MORE FROM THE DISCUSSION A LITTLE BIT YESTERDAY. SO, NOVATO DOES HAVE A SITE THAT IS RIGHT ACROSS THE STREET 9 10 FROM THE SMART STATION, AND THAT'S WHERE FIRE MAN'S FUND, THE MISSION OF FIREMEN'S FUND WENT OUT OF BUSINESS. SO THAT SITE 11 IS 63 ACRES, AND IT'S BEING PROPOSED FOR HOUSING, BUT WE'RE 12 HAVING A DIFFICULT TIME GETTING MORE AFFORDABLE UNITS. WE HAVE 13 A 20% INCLUSIONARY ZONING REQUIREMENT, BUT WE WOULD LIKE TO DO 14 MORE. IS IT POSSIBLE FOR NOVATO TO APPLY FOR A DESIGNATION OF 15 16 THIS AS A PDA AND THEN THE FUNDS AM WOULD COME TO THE CITY SO WE COULD BUY DOWN THE SOME OF THE UNITS SO THAT WE CAN MAKE A 17 HIGHER AFFORDABLE HOUSING COMMITMENT THERE? 18

20 MATT MALONEY: BOARD MEMBER EKLUND EVEN THE FACT IT'S A 21 TRANSIT-RICH AREA THE AREA ITSELF THAT SITE YOU'RE REFERRING 22 TO WOULD BE ELIGIBLE YOU COULD SUBMIT THAT TO BE ELIGIBLE TO 23 BE A PRIORITY SITE. IN TERMS OF INCLUSIONARY REQUIREMENT WE'RE 24 LOOKING FOR PROJECTS WITH DEEP AFFORDABILITY SO WE'RE HOPING



THAT JURISDICTIONS WOULD COME ABOVE THE INCLUSIONARY 1 2 REQUIREMENT THAT'S ALREADY ON THE BOOKS. 3 PAT ECKLUND: BUT IN ORDER TO DO THAT, YOU WOULD HAVE TO BUY 4 5 DOWN -- WE WOULD HAVE TO BUY DOWN SOME OF THE UNITS AND WE HAVE ABSOLUTELY HARDLY ANY AFFORDABLE HOUSING MONEY IN OUR 6 AFFORDABLE HOUSING FUND. BUT CAN THIS MONEY BE USED TO DO 7 8 THAT? IF WE GOT A COMMITMENT FROM THE DEVELOPER TO --9 MARK SHORETT: I'M GOING TO LET MY COLLEAGUE KATE HARTLEY COME 10 UP FROM BAHFA. 11 12 KATE HARTLEY: KATE HARTLEY DIRECTOR OF BAHFA. CURRENTLY NO THE 13 ELIGIBILITY CRITERIA WOULD NOT REWARD A DEVELOPMENT THAT HAS A 14 15 MINIMUM, MEETS THE MINIMUM INCLUSIONARY REQUIREMENT OF THE 16 LOCALITY. AND, SO, WHAT WE'RE REALLY TRYING TO DO IS PUT ADDITIONAL RESOURCES IN FOR PROJECTS THAT ARE STRIVING TO 17 INCREASE THE AFFORDABLE UNIT COUNT. 18 19 PAT ECKLUND: OKAY. 4	INCREASE THAT TO 25, 30%, THEN I BELIEVE THAT WOULD BE

6	BE ELIGIBLE BUT IF YOU CAN GO FARTHER I BELIEVE WILL BE
