BRIAN MAYHEW: AND YOU GET A YEAR END FINANCIAL REPORT WITH 9 THIS. AGAIN, I'LL REMIND YOU THAT THIS IS SUBJECT TO THE FINAL 10 AUDIT, AND YOU WILL GET THE FINAL AUDIT ON THIS IN A FEW 11 MONTHS. YOU ARE THE PROUD OWNERS OF A ONE AND A HALF BILLION 12 DOLLARS CONDUIT. IT ENDS THE YEAR -- IT IS IN REASONABLY 13 FINANCIAL SHAPE, AND THAT'S A GOOD PIECE OF IT. ABOUT A 14 15 MILLION DOLLARS IN FEES IS ABOUT WHAT WE EXPECTED. EXPENSES 16 WERE A LITTLE HIGHER, ABOUT \$1.1 MILLION. WE THINK THAT'S 17 GOING TO BE FINE IN THE FUTURE. MAIN REASON FOR THE EXPENSE SORT OF RUN UP LAST YEAR IS BECAUSE OF THE ENORMOUS LEGAL 18 EXPENSES THAT CAME FROM THE TRANSITION OF THE FAN EXECUTIVE 19 BOARD TO THE ACFA BOARD. THAT WAS, YOU KNOW, THERE WERE A LOT 20 OF IS TO DO THE, AND TS TO CROSS AND BECAUSE OF THE COVID 21 PANDEMIC SITUATION WE'RE NOT EVEN COMPLETELY FINISHED WITH ALL 22 OF THE NOTICE YET. BUT ANYWAY, IF YOU TAKE OUT THE MILLION 23 DOLLARS THAT WAS TRANSFERRED TO PAY OFF THE OPEB LIABILITY, 24 AGAIN IT WAS ABOUT 1.1 MILLION. ALL IN ALL ENDING PRETTY WELL. 25

CASH BALANCE AT THE END OF THE YEAR ROUGHLY 3.1 BILLION. 1 OVERALL THE FUND IS IN GOOD SHAPE WE HAVE GOOD TRACK ON THE 2 3 REVENUES. AND ADMINISTRATIVELY, IT SHOULDN'T BE ANY BIG SHOCKS TO IT NOW. BUT, ANYWAY, WE ENDED THE YEAR IN DECENT SHAPE. AND 4 5 ABOUT 3.1 MILLION IN THE BANK. SO, I WOULD BE HAPPY TO ANSWER ANY QUESTIONS. 6 7 8 KAREN MITCHOFF, CHAIR: THANK YOU BRIAN.
