




- 13 AND JEANNE, WHICH I WILL GET TO IN A MINUTE -- I'M GOING TO
- 14 TRY TO DO THEM SEPARATE AND NOT SCREW THIS UP. SOME MAY EVEN
- 15 HAVE THEM. I DON'T KNOW, DO ANY OF YOU HAVE YOUR RESOLUTIONS
- 16 YET? NO. NOPE. OKAY. WELL YOU DON'T. SO, I'M GOING REFRAIN

- 13 2017 HE GUIDED CONSOLIDATION OF MTC STAFF WITH THAT OF THE
- 14 ASSOCIATION OF BAY AREA GOVERNMENTS WORKING CLOSELY WITH JULIE
- 15 PIERCE TO DESIGN AN AGREEMENT ACCEPTABLE TO BOTH BOARDS AND
- 16 WHEREAS DAVE HAS CAPTURED 2016 MOVE OF MTC AND ABAG AND THE
- 17 BAY AREA AIR QUALITY MANAGEMENT DISTRICT TO THE NEWLY
- 18 REDEVELOPED BAY AREA METRO CENTER AND WHILE ALSO WORKING TO
- 19 SMOOTH THE WAY FOR THE SAN FRANCISCO BAY CONSERVATION
- 20 DEVELOPMENT -- SAN FRANCISCO BAY CONSERVATION AND DEVELOPMENT
- 21 COMMISSIONS LATER MOVE TO THE FACILITY. WHEREAS DAVE'S DECADES
- 22 OF WORK ON BEHALF OF THE PEOPLE OF SAN JOSE, SANTA CLARA, AND
- 23 THE BAY AREA REFLECT A LONG FAMILY TRADITION OF PUBLIC SERVICE
- 24 THAT INCLUDES -- AND I DIDN'T KNOW THIS DAVE -- HIS
- 25 GRANDFATHER, WHO WAS A SANTA CLARA CITY COUNCILMEMBER -- I DID

IT'S 20 21 BEEN AN AMAZING THING TO BE PART OF. SO THANK YOU ALL. AND THANK YOU ALL WHO HAVE SUPPORTED US ON THE COMMISSION. - 6 A CONFERENCE ROOM AND SORT OF HAD IT OUT IT TOOK ME A WHILE
- 7 UNTIL I REALIZATION THAT WHEN WE DISAGREE WE DISAGREE LIKE
- 8 BROTHERS. I HAVE TWO BROTHERS IN MY IMMEDIATE FAMILY, TWO
- 9 SIBLINGS AND TWO SISTER PERCENT AND I THOUGHT, NOW I SEE WHERE
- 10 THIS RELATIONSHIP IS GOING, AND SOME OF YOU WERE INVOLVED WITH
- 11 THE ABAG MEETING LAST NIGHT UNDER THEY REFERRED TO SCOTT AS MY





- 17 BLUEPRINT WERE CRITICAL IN REDUCING AUTO MODE SHARE BY 17
- 18 POINTS A SIZABLE REDUCTION. OF COURSE WORKING FROM HOME IS
- 19 ALSO EXPECTED TO GROW IN THE POST COVID ENVIRONMENT ABSENT ANY
- 20 POLICY INTERVENTION. AND COMBINED WITH THOSE INVESTMENT IN

- 19 BE LARGE IF SIZE. ARROWS REFLECT GREENHOUSE GAS EMISSIONS
- 20 REDUCTION FROM THESE STRATEGIES THROUGH 2035 AND YOU CAN SEE
- 21 THE STRATEGIES ARE SIZABLE JUST TO ACHIEVE A FEW POINTS OF

- 11 IN CONCERT WITH PLANNED BAY AREA 2050. FURTHERMORE, AND

- 17 ACCELERATE NEEDED REFORM OF SB 375 BUT COULD HAVE ADVERSE
- 18 UNFORESEEN IMPACTS. NEXT SLIDE PLEASE THE ORIGINAL STRATEGY AS
- 19 WELL AS THE ALTERNATIVE PRESENTED TODAY DOESN'T LIVE IN A
- 20 VACUUM IT'S WOVEN TOGETHER WITH ANOTHER 34 STRATEGIES IN THE
- 21 BLUEPRINT, ELECTRIFICATION, INTERNET SUBSIDIES INFRASTRUCTURE,
- 22 MEANS-BASED DISCOUNTS FOCUS GROUPS NEAR TRANSIT AND OVER \$400
- 23 BILLION TO OPERATE MAINTAIN RESTORE AND EXPAND OUR REGION'S
- 24 TRANSIT NETWORK TO A SIZABLE INVESTMENT EQUITY HAS BEEN WOVEN
- 25 THROUGHOUT THE 35 STRATEGIES AND IT'S CRITICAL IN THINKING



- 1 ABOUT THE ALTERNATIVE STRATEGY WE'RE SHOWING TODAY. NEXT
- 2 SLIDE. BECAUSE OF THESE HIGH CLIMATE TARGETS REGIONS
- 3 THROUGHOUT CALIFORNIA ARE HAVING TO THINK ABOUT INNOVATIVE
- 4 NON-TRADITIONAL STRATEGIES TO REACH THEM. IN SHORT WE ARE NOT
- 5 ALONE. THE DEBATE OVER STRATEGY EN7 IS AN OPPORTUNITY TO
- 6 EXPLAIN THAT MANY OF THESE NEW STRATEGIES ARE ESSENTIAL TO GET
- 7 TOWARDS THE GREENHOUSE GAS GOALS. AS SHOWN IN THIS SLIDE EVERY
- 8 REGION AND EVERY MAJOR REGION IN THE STATE IS PURSUING SOME
- 9 FORM OF ROADWAY PRICING IN THEIR LONG RANGE PLAN AND MANY ARE

- 25 OR STRATEGIES. LASTLY, THE ADJUSTED STRATEGY NEEDED TO FIT



- 1 WITHIN FISCAL CONSTRAINT BECAUSE ALL FUNDING HAS ALREADY BEEN
- 2 ALLOCATED ON THE TRANSPORTATION SIDE. NEXT SLIDE PLEASE.
- 3 ULTIMATELY THE STAFF RECOMMENDATION WE'RE SHARING TODAY FALLS
- 4 UNDER OPTION A REFINING THE STRATEGY WHILE MEETING THE THREE
- 5 REOUIREMENTS LISTED. OTHER ALTERNATIVES WERE EXPLORED
- 6 INCLUDING NOTED ON THE RIGHT MANY IDEAS WERE FOCUSED ON
- 7 SHIFTING THE BURDEN TO BAY AREA COMMUTERS AND AWAY FROM BAY
- 8 AREA BUSINESS. THE STRATEGY WAS FOCUSED ON ASKING BUSINESS TO
- 9 CONTRIBUTE TOWARDS CLIMATE SOLUTIONS TO MATCH THE PUBLIC
- 10 SECTOR ACTIONS STRATEGIES AND INVESTMENTS ELSEWHERE IN THE
- 11 PLAN THE REVISED STRATEGY CONTINUES TO FOCUS ON EMPLOYEES
- 12 ACHIEVING SYNERGISTIC BENEFITS AND PROVIDING FLEXIBILITY
- 13 THROUGH A CAFETERIA STYLE APPROACH OF MODE SHIFT OPTIONS. THE
- 14 ALTERNATIVE IS ENTITLED EXPAND TRIP REDUCTION PROGRAM
- 15 REDUCTIONS AT MAJOR EMPLOYERS GOES BEYOND TELECOMMUTING TO
- 16 ALLOW EMPLOYERS TO LEVERAGE INCENTIVES TO SHIFT THEIR
- 17 WORKFORCE TO TRANSIT, WALKING, BIKING AND OF COURSE
