- 7 AGENCIES IN MAY AND JUNE PRIOR TO THE SCHEDULED ROLL OUT OF
- 8 THAT PROGRAM IN AUGUST. PRESUMING ALL OF THE AGENCIES AGREE,

- 6 NETWORK PLAN, SO, FIRST OF ALL, FOR, SINCE WE'RE HERE IN
- 7 PLENARY WITHOUT ANY BROWN ACT ISSUES AND TALKING ABOUT THIS ON
- 8 OUR AGENDA, I WOULD WELCOME ANY THOUGHTS FROM PEOPLE IN
- 9 ADDITION TO, VEDA'S HAS ALREADY SHARED HER THOUGHTS ABOUT THAT
- 10 DIRECTION, THAT FOLKS WHO ARE INTERESTED IN FARE INTEGRATION,

- 18 THINK THIS IS A GOOD IDEA, OR, GOLLY GEE, I ONLY SIGNED UP FOR
- 19 FARES AND OTHER ASPECTS OF CUSTOMER EXPERIENCE I REALLY DON'T
- 20 WANT TO DEAL WITH, OR YEAH, I THINK THAT'S A PERFECTLY GOOD
- 21 FIT, AND NOW WOULD BE A GOOD TIME TO SHARE THAT: AND TO VEDA'S

- 17 USER. I DRIVE MY CAR ALL THE TIME. AND I'M TRYING TO FIGURE
- 18 OUT WHAT TRANSIT IS ALL ABOUT AND WHAT ARE SOME OF THE ISSUES.
- 19 I DON'T USE THE CAR ANYMORE -- TASK, RIGHT OVER HERE IT SAYS
- 20 THAT I'M THE SENIOR REPRESENTATIVE. SO SENIORS OUGHT NOT TO BE
- 21 IN THE CARS IN THE FIRST PLACE. AND, SO, I'M TRYING TO FIGURE
- 22 PART OF THIS OUT, AND THE WHOLE CONCEPT OF SEAMLESS MADE A LOT
- 23 OF SENSE TO ME, AND I SAW THAT WITH FARES IS THE PLACE TO

- 14 NEXGEN FREEWAY ADVISORY GROUP ACTION REPORT. ANNE OLIVIA
- 15 WANTED TO BRING US UP TO DATE FROM HER POINT OF VIEW ON THAT.

- 25 IT HAS DIRECT EFFECT ON DECISIONS THAT ARE MADE AT THE MTC





- 1 COMMISSION LEVEL AND MTC AND OTHER DECISION-MAKING BODIES
- 2 AFFILIATED. THAT'S WHY IT'S IMPORTANT THAT WE'RE HERE IN THIS
- 3 FORUM TO THE TRANSPARENCY OF RULES IN THE SAME WAY THAT WE
- 4 WOULD FOR THE COMMISSION ITSELF. SO WITH THAT TOUCH STONE OF
- 5 THE PEOPLE'S BUSINESS HAPPENS IN PUBLIC. THAT'S ONE YOU CAN
- 6 REPEAT TO YOURSELF IF YOU EVER HAVE DOUBTS ABOUT WHERE THE KEY
- 7 PRINCIPLE IS. THERE IS SOME WAYS THAT PLAYS OUT. ONE OF THE
- 8 MOST IMPORTANT ONES IS THAT THE AGENDA THAT'S PUBLISHED GIVES
- 9 NOTICE TO THE PUBLIC OF WHAT IS AND IS NOT GOING TO HAPPEN.
- 10 SO, A MEMBER OF THE PUBLIC WHO MIGHT BE INTERESTED IN THE WORK
- 11 OF THE COUNCIL SHOULD BE ABLE TO LOOK AT YOUR AGENDA AND HAVE
- 12 A VERY GOOD SENSE OF WHAT DISCUSSIONS MIGHT OR MIGHT NOT
- 13 OCCUR. THAT MEANS THAT WHEN YOU ARE IN A MEETING, YOU NEED TO
- 14 BE SURE THAT IF YOU ARE STARTING TO GO OFF OF WHAT HAD BEEN
- 15 AGENDAIZED -- SO, FOR EXAMPLE, IF THERE IS AN ITEM ON, YOU
- 16 KNOW, THE DISABILITY ACCESS FOR THE WAYFINDING AND HOW TO
- 17 IMPROVE THE USABILITY OF THE WAYFINDING TOOLS THAT WE HAVE. IF
- 18 THAT, THEN, STARTS MORPHING INTO A RELATED BUT NOT AGENDAIZED
- 19 TOPIC AROUND FUNDING FOR NEW TECHNOLOGY INITIATIVES, THEN
- 20 THERE IS A POINT AT WHICH MEMBERS OF THE BODY OR THE CHAIR ARE
- 21 GOING TO NEED TO CALL A TIME OUT AND SAY, OKAY, LET'S TAKE
- 22 THAT AS AN ITEM TO PARKING LOT FOR LATER, AND LET'S MAKE SURE
- 23 THAT WE STAY ON TOPIC WITH THE AGENDA. THE REASON FOR THAT IS
- 24 IF LOOK AT IT FROM THE PERSPECTIVE OF A MEMBER OF THE PUBLIC,
- 25 THEY WANT TO KNOW IF THEY SHOULD COME TO THE MEETING OR NOT.





- 1 AND SOME MIGHT CARE ABOUT TECHNOLOGY FUNDING AND MAY NOT KNOW
- 2 TO COME TO TALK ABOUT THE ITEM ON ACCESSIBILITY IF IT'S NOT
- 3 AGENDAIZED IN SUCH THAT WOULD INDICATE THAT YOU'RE GOING TO
- 4 END UP TALKING ABOUT THAT RELATED BUT NOT IDENTICAL TOPIC. AS
- 5 YOU CAN TELL THIS IS NOT NECESSARILY A PRECISE SCIENCE WHERE
- 6 THAT CUT OFF IS BETWEEN SOMETHING THAT'S WITHIN THE KIND OF
- 7 NATURAL AMBIT OF THE AGENDA ITEM, AND RELATED, BUT NOT
- 8 AGENDAIZED TOPICS, WHERE THAT CUT OFF IS SOMETHING THAT IS A
- 9 REALTIME CALL THAT'S MADE BY YOUR CHAIR AND YOURSELVES. AND
- 10 NOT EVERYBODY AGREES ON THAT. WHENEVER THERE IS AMBIGUITY LIKE
- 11 THAT, TWO THINGS HAPPEN. ONE, IT'S AN INVITATION FOR
- 12 CHALLENGE, RIGHT? BECAUSE PEOPLE CAN SUE UNDER THE BROWN ACT
- 13 WHEN WE HAVE VIOLATED IT, BUT, TWO, AND MORE IMPORTANTLY, YOU
- 14 KNOW, THERE IS THE CHANCE THAT A MEMBER OF THE PUBLIC WHO
- 15 MIGHT WANT TO CONTRIBUTE DOESN'T KNOW TO DO THAT. SO MY
- 16 THOUGHT THERE IS TO, WHERE THERE IS AMBIGUITY, TRY TO BE
- 17 CERTAIN MAKING SURE THAT WE'RE ADHERING TO THE AGENDA SO
- 18 MEMBERS OF THE PUBLIC WHO WOULD HAVE BEEN INTERESTED WOULD
- 19 KNOW TO COME. AND IF SOMETHING APPEARS TO BE AN ISSUE THAT
- 20 MERITS FURTHER DISCUSSION THAT'S SOMETHING THAT CAN BE PUT ON
- 21 A LATER AGENDA. AS LONG AS IT'S NOT AN EMERGENCY, YOU CAN TAKE
- 22 UP IN A FUTURE MEETING, AND THAT'S APPROPRIATE THE APPROPRIATE
- 23 PLACE TO PUT IT. AND YOU CAN GIVE THAT DIRECTION,
- 24 COLLECTIVELY, TO STAFF TO SAY, YOU KNOW, THIS IS AN IMPORTANT
- 25 TOPIC FOR US, WE WANT TO BE ABLE TO TAKE IT UP. LET'S MAKE





- 1 SURE THAT WE HAVE A TIME ON AN AGENDA FOR US TO DO THAT IN A
- 2 MORE FULL MANNER. SO, THAT'S ONE OF THE KEY AREAS. AND ONE OF
- 3 THE AREAS THAT PEOPLE -- FIRST OF ALL, REASONABLE MINDS CAN
- 4 DIFFER ABOUT PRECISELY WHERE THAT CUT OFF IS, BUT ALSO ONE OF
- 5 THE AREAS WHERE WELL INTENTIONED PEOPLE CAN GET INTO A LITTLE
- 6 BIT OF TROUBLE BECAUSE YOU GET EXCITED ABOUT A TOPIC AND A LOT
- 7 OF THESE THINGS ARE INTERRELATED AND IN DIGGING DOWN AND
- 8 TALKING ABOUT IT THERE IS THIS TENDENCY TO HAVE SCOPE DRIFT,
- 9 AND YOU NEED TO MAKE SURE TO REEL THAT BACK IN SO IT'S
- 10 TRANSPARENT ABOUT WHAT'S GOING IN A MEETING. THAT, BY THE WAY,
- 11 IS SOMETHING THAT HAPPENS IN EVERY BROWN ACT BODY THEY HAVE

- 23 WAS LOOKING AT MARTHA'S POP-UP THERE. ONE IS CALLED A SERIAL
- 24 MEETING, AND THAT IS THE ONE THAT HAS SORT OF THE GREATEST
- 25 RISK, AGAIN, FOR WELL INTENTIONED PEOPLE. AND THAT IS WHAT





- 1 HAPPENS WHEN THERE IS KIND OF A GAME OF OPERATOR. SO, IF CHAIR
- 2 KINMAN TALKS TO, YOU KNOW, TWO OTHER COUNCIL MEMBERS ABOUT,
- 3 YOU KNOW, HEY, I THINK WE SHOULD APPROACH THIS UPCOMING ISSUE
- 4 IN THE FOLLOWING WAY, WHAT DO YOU THINK? AND THEY TALK AMONGST
- 5 THEMSELVES THAT'S LESS THAN A OUORUM. YOU'RE NOT IN A MEETING.
- 6 IF THOSE TWO PEOPLE TALK TO OTHER COUNCIL MEMBERS, YOU MAY
- 7 HAVE A PROBLEM WHERE YOU START GETTING A TOTAL NUMBER OF
- 8 GREATER THAN A QUORUM THAT HAS TALKED ABOUT AN ISSUE BEFORE
- 9 IT'S IN A PUBLIC MEETING. AND THAT IS SOMETHING THAT THE
- 10 PUBLIC SHOULD BE ENTITLED TO KNOW ABOUT, BECAUSE YOU ARE
- 11 FORMING AN OPINION OUTSIDE OF AN AGENDAIZED PUBLIC MEETING,
- 12 AND EVEN THOUGH IT'S NOT HAPPENING IN REALTIME, IT'S NOT
- 13 HAPPENING SIMULTANEOUSLY, IT IS A COLLECTIVE VIEW THAT IS
- 14 FORMING OUTSIDE OF AN AGENDAIZED MEETING, AND THAT BECOMES A
- 15 PROBLEM UNDER THE BROWN ACT. THIS IS REALLY EASY TO HAVE
- 16 HAPPEN, BECAUSE YOU ARE ALL DEDICATED OUTSIDE YOU WOULDN'T BE
- 17 DOING THIS, AND YOU ARE MEMBERS OF THE COMMUNITY AND YOU'RE
- 18 OUT THERE AND TALKING IT'S EASY TO ACCIDENTALLY FORM A QUORUM
- 19 ON A TOPIC IF YOU AREN'T REALLY CAREFUL ABOUT MAKING SURE YOU
- 20 KNOW WHOM YOU HAVE SPOKEN TO ABOUT SOMETHING, AND WHO THEY
- 21 HAVE SPOKEN TO. THE OTHER WAY THIS HAPPENS IS CALLED A, THAT'S
- 22 A SERIAL MEETING PROBLEM, GAME OPERATOR GOING THROUGH, THE
- 23 OTHER IS HUB AND SPOKE AND THIS HAPPENS FREQUENTLY WHERE YOU
- 24 HAVE AN ADVOCATE. YOU HAVE AN ADVOCATE WHO WANTS TO TALK TO
- 25 EACH OF YOU ABOUT A SUBJECT SO THEY CAN GET YOU UP TO SPEED,





- 1 AND HOPE TO CONVINCE YOU TO TAKE A PARTICULAR POSITION ON
- 2 SOMETHING. IF THEY TALK TO MAR MORE THAN A QUORUM OF YOU, OR
- 3 THEY BECOME A HUB, AND YOU'RE ALL SPOKES, IT ASIDE UP TO A
- 4 MEETING. IF THEY SAY COMMISSIONER WONG TALKED TO COMMISSIONER
- 5 WILSON, YOU HAVE THAT GAME OF OPERATOR BUT IT'S GOING THROUGH
- 6 AN INTERMEDIARY, AND THAT CAN STILL CONSTITUTE A MEETING UNDER
- 7 THE BROWN ACT AND IS ALSO A VIOLATION OF THE BROWN ACT. AGAIN
- 8 THAT DIDN'T HAPPEN IN A PUBLIC, A MEMBER OF THE PUBLIC
- 9 WOULDN'T HAVE ACCESS TO THAT, AND THAT'S THE FUNDAMENTAL
- 10 PROBLEM THERE. SO THE FIRST ONE WAS THE SERIAL, KIND OF JUST A
- 11 CHAIN, THE OTHER ONE WAS THE HUB AND SPOKE. THOSE ARE BOTH
- 12 THINGS TO WATCH OUT FOR WHEN YOU ARE DEALING WITH THE BROWN
- 13 ACT. AGAIN, REALLY EASY TO HAVE HAPPEN ESPECIALLY WHEN A LOT
- 14 OF YOU OVERLAP OUT IN THE WORLD, BECAUSE YOU'RE PASSIONATE
- 15 ABOUT YOUR RESPECTIVE BUSINESS IS, AND YOU'RE LIKELY TO
- 16 INTERACT WITH THE SAME THIRD PARTIES, AND YOU MAY OVERLAP AT
- 17 OTHER FUNCTIONS AND SO ON. YOU CAN ALSO HAVE A MEETING THAT
- 18 TAKES PLACE ON SOCIAL MEDIA. IF SOMEONE POSTS SOMETHING ON A
- 19 FACEBOOK PAGE AND YOU COMMENT, THAT IS NOW, YOU KNOW, YOUR --
- 20 AND IT'S SOMETHING THAT'S WITHIN THE JURISDICTION OR SUBJECT
- 21 MATTER OF THE POLICY ADVISORY COUNCIL, THAT'S NOW A
- 22 COMMUNICATION THAT'S HAPPENING OUTSIDE OF AN AGENDAIZED
- 23 MEETING. IF SOMEONE IS HOSTING A COMMUNITY FORUM THAT'S NOT
- 24 THROUGH MTC AND A QUORUM OF YOU ATTEND, YOU CAN ALL ATTEND.
- 25 THAT'S FINE. BUT IF YOU START DISCUSSING AMONGST YOURSELVES





- 1 SOMETHING THAT MIGHT LATER SHOW UP ON AN AGENDA FOR YOU, THEN
- 2 THAT'S A MEETING THAT YOU'RE HAVING EVEN THOUGH IT'S NOT
- 3 AGENDAIZED AS YOUR MEETING. SO, THERE ARE ALL THESE KIND OF
- 4 TRAPS FOR THE UNWARY, THAT WHEN WE'RE GOING THROUGH OUR LIVES
- 5 AS NORMAL COMMITTED COMMUNITY MEMBERS WE DON'T HAVE TO THINK
- 6 ABOUT THIS STUFF, BUT ONCE YOU'RE A MEMBER OF A BROWN ACT
- 7 BODY, THERE IS THAT ADDITIONAL LAYER OF HAVING TO CHECK TO
- 8 MAKE SURE THAT YOU'RE NOT TRIPPING OVER THESE STRICTURES THAT
- 9 ARE THERE TO PROTECT THE PUBLIC'S INTEREST IN KNOWING HOW
- 10 YOU'RE FORMING YOUR OPINIONS. THE CURE FOR ALL THAT, BECAUSE
- 11 IT SOUNDS A LITTLE DAUNTING, BUT THE CURE FOR ALL OF THAT IS
- 12 DEVELOPING REALLY GOOD BROWN ACT HYGIENE. AND THAT INVOLVES
- 13 THINGS, LIKE, IF YOU'RE GOING TO TALK TO ANOTHER COUNCILMEMBER
- 14 ABOUT AN ISSUE, AND YOU ARE E-MAILING THEM TO SETUP A TIME TO
- 15 TALK, AND YOU SAY I HAVEN'T SPOKEN TO ANYONE ELSE ON THE
- 16 COUNCIL ABOUT THIS HAVE YOU SPOKEN TO ANYONE? AND ARE YOU
- 17 PLANNING? THAT WAY YOU CAN DETERMINE YOU'RE NOT TRIPPING
- 18 SIDEWAYS INTO A SERIAL MEETING. OR I HAVE SPOKEN TO ONE
- 19 PERSON, THEN YOU CAN COUNT AND MAKE SURE YOU'RE NOT BUMPING UP
- 20 AGAINST HAVING THAT PROBLEM. IF YOU'RE GOING TO A COMMUNITY
- 21 FORUM WHERE YOU THINK THERE ARE ISSUES THAT ARE RELEVANT TO
- 22 THE COUNCIL THAT MIGHT COME UP, YOU CAN ASK THE FORM
- 23 ORGANIZERS WHO ELSE IS BEING INVITED, ARE OTHER COUNCIL
- 24 MEMBERS GOING TO BE THERE. YOU CAN THEN FIGURE OUT WHAT LEVEL
- 25 OF PARTICIPATION YOU ARE COMFORTABLE WITH. ALL OF THESE TOPICS





- 1 ARE WITHIN THE JURISDICTION OF THE POLICY ADVISORY COUNCIL. IF
- 2 YOU WANT TO GO TO A SCHOOL CURRICULUM MEETING AND ALL OF YOU
- 3 ARE AT A SCHOOL CURRICULUM MEETING AND THAT'S NOT SOMETHING
- 4 YOU ALL ARE GOING TO TALK ABOUT ON A POLICY ADVISORY COUNCIL
- 5 THAT'S NOT A PROBLEM JUST REALLOCATED TO THINGS THAT MIGHT BE
- 6 WITHIN YOUR PURVIEW. THE CHALLENGE IS THE POLICY ADVISORY
- 7 COUNCIL HAS A BROAD SUBJECT MATTER OF ISSUES THAT YOU ALL
- 8 MIGHT TALK ABOUT OVER TIME AND IT OVERLAPS PRETTY WELL WITH
- 9 THE THINGS THAT YOU ARE LIKELY ADVOCATING FOR AND DOING THINGS
- 10 IN YOUR LIVES OUTSIDE OF THE POLICY ADVISORY COUNCIL. SO YOU
- 11 HAVE TO THINK ABOUT HOW YOUR OUTSIDE CONDUCT MIGHT RELATE TO
- 12 YOUR POLICY ADVISORY COUNCIL POSITION. THAT'S A LOT RIGHT
- 13 THERE, THAT I JUST TALKED ABOUT, AND THERE IS A LOT TO UNPACK.
- 14 I WANTED TO GET YOU KIND OF THE PRINCIPLE OVER THAT. BUT THERE
- 15 IS A LOT IN THE DETAILS. AND WE'RE HAPPY TO HELP YOU. WE,
- 16 OFFICE OF GENERAL COUNSEL, MYSELF, OR MY VERY TALENTED STAFF
- 17 ARE HAPPY TO HELP YOU WORK THROUGH THINGS IF YOU ARE UNCERTAIN
- 18 ABOUT WHERE YOU ARE. THE GOOD NEWS ABOUT THE BROWN ACT IS,
- 19 WHILE PEOPLE CAN SUE FOR VIOLATION OF IT, WE CAN ALSO MONITOR
- 20 OURSELVES AND WE CAN CURE, IF WE FOUND OUT THAT THERE WAS AN
- 21 ACCIDENT, AND SOMEBODY DIDN'T REALIZE THAT THEY HAD GOTTEN
- 22 INTO A SERIAL MEETING SITUATION OR SOMETHING LIKE THAT, WE CAN
- 23 AGENDAIZE THINGS PROPERLY AND WE CAN TAKE CARE OF THAT OR WE
- 24 CAN REDO AN ACTION PROPERLY SO WE HAVE OPPORTUNITY TO FIX OUR
- 25 PROBLEMS. SO I REALLY WANT TO ENCOURAGE YOU TO REACH OUT,





- 1 IDEALLY, BEFORE AN ISSUE ARISES. BUT IF IT'S AN ISSUE AND AN
- 2 ACCIDENT WHERE SOMETHING HAPPENS AND YOU'RE WORRIED ABOUT IT
- 3 YOU CAN CALL US AND WE CAN FIX IT ON THE BACK END. SOME THINGS
- 4 ARE OBVIOUSLY EASIER TO FIX THAN OTHERS BUT THAT'S AN OPTION
- 5 UNDER THE BROWN ACT. WE DON'T NECESSARILY HAVE TO ACCEPT A
- 6 PROBLEM, WE CAN TRY TO FIX IT AND MAKE SURE THAT WE HAVE GIVEN
- 7 THE PUBLIC THAT ACCESS AND OPPORTUNITY THAT THEY NEED TO WEIGH
- 8 IN ON YOUR DECISION-MAKING. THE NEXT BULLET IS A POINT WHERE
- 9 PUBLIC HAS ACCESS TO INFORMATION THAT INFORMS DECISIONS. IF
- 10 YOU HAVE AN ITEM, THAT'S AN ISSUE THAT'S RELEVANT FOR EXAMPLE,
- 11 YOU DON'T WANT TO BE SENDING OUT AN OPINION ARTICLE AROUND TO
- 12 OTHER COUNCIL MEMBERS AND IT ISN'T SHARED WITH THE PUBLIC,
- 13 BECAUSE THE PUBLIC SHOULD KNOW THE BASIS FOR YOUR DECISION
- 14 THAT'S SOMETHING THE PUBLIC SHOULD BE ABLE TO SEE IN THE
- 15 AGENDA PACKET. AND, THAT IS SOMETHING WE CAN FIX. THERE ARE
- 16 REQUIREMENTS THAT ARE NARROW AND DEFINED BY STATUTE. SO WE DO
- 17 NOT GET TO DIVERGE FROM THE SORT OF, EVERYTHING HAPPENS IN
- 18 PUBLIC STANDARD, UNLESS THERE IS A SPECIFIC REASON THAT'S
- 19 RECOGNIZED BY THE STATUTE THAT LET'S US DO THAT. AND THEY ARE
- 20 THE KINDS OF THINGS THAT YOU WOULD EXPECT. RIGHT? SO, THINGS
- 21 THAT -- A PERSONALLY REVIEW FOR THE EXECUTIVE DIRECTOR DOES
- 22 NOT HAVE TO HAPPEN AT A PUBLIC MEETING. DISCUSSIONS ABOUT
- 23 WHETHER MTC SHOULD SUE SOMEBODY DOESN'T HAVE TO HAPPEN IN
- 24 PUBLIC BEFORE THEY HAVE MADE THE DECISION TO SUE. ONCE THEY
- 25 HAVE MADE THAT DECISION THEN IT'S PUBLIC. THERE ARE CERTAIN





- 1 KIND OF VERY NARROW THINGS BUT THEY'RE NOT LIKELY TO APPLY
- 2 REALLY TO THE COUNCIL'S WORK, WITH THE POSSIBLE EXCEPTION THAT
- 3 IF THERE IS SOME THREAT OF LITIGATION RELATED TO YOUR WORK,
- 4 THAT'S SOMETHING THIS WE MIGHT BE ABLE TO TALK ABOUT IN CLOSED
- 5 SESSION. BUT IT WOULD BE AGENDAIZED APPROPRIATELY FOR THAT.
- 6 SO, THAT'S A LOT OF WICK TALKING ON MY PART. ONE MORE THING I
- 7 WANTED TO MENTION, BECAUSE COMMITTEES CAME UP, IF THERE IS A
- 8 STANDING COMMITTEE OF THE POLICY COUNCIL, NON-COMMITTEE
- 9 MEMBERS CAN ATTEND, SORT OF, AS MEMBERS OF THE PUBLIC, AS
- 10 OBSERVERS, BUT WHAT YOU SHOULDN'T DO IS ACTUAL IT INTO A FULL
- 11 COUNCIL MEETING BY ENGAGING SUBSTANTIVELY IN CONVERSATION AT
- 12 THE COMMITTEE LEVEL. BECAUSE, AGAIN, IT WAS AGENDAIZED AS A
- 13 MEET COMMITTEE NOT THE COUNCIL MEETING, SO IF YOU'RE NOT ON
- 14 THE COMMITTEE YOU SHOULDN'T BE ENGAGING IN THE COMMITTEE
- 15 SUBSTANTIVE TOPICS. YOU COULD ASK A CLARIFYING QUESTION OR
- 16 SOMETHING LIKE THAT BUT IN TERMS OF GETTING INTO A SUBSTANTIVE
- 17 POLICY DISCUSSION AT THE COMMISSION OF THAT COMMITTEE WHEN YOU
- 18 ARE NOT ON THAT COMMITTEE DESTROYS THE SORT OF COMMITTEE
- 19 STRUCTURE AND THE PURPOSE OF THAT AGENDA IN INFORMING THAT. SO
- 20 WITH ALL THAT TALKING, I THINK THAT WAS THE END OF MY -- LET'S
- 21 SEE WHAT THE NEXT SLIDE IS. IT'S PROBABLY QUESTIONS. THERE YOU
- 22 GO. YES. DO E-MAIL ME. I AM AVAILABLE. AND I REALLY DO WANT TO
- 23 HELP YOU, BECAUSE SOME OF THESE THINGS CAN BE CONFUSING, EVEN

- 20 MANAGEMENT. NEXT SLIDE. WHAT TYPE OF PROJECTS SHOULD BE IN THE
- 21 MAP WE'LL FOCUS ON LARGER PROJECTS WITH SIGNIFICANT

KENNETH FOLAN: I THINK IT MAKES SENSE, BUT THAT'S A TOUGHER 1 QUESTION, AND MTC IS NOT THE ONLY FUNDING PARTNER. WE DID GO 2 3 THROUGH A COST BENEFIT FOR PLANS TO ENTER AND BE APPROVED AS PART OF PLANNED BAY AREA 2050. THAT'S THE POOL OF PROJECTS 4 5 THAT WE HAVE RIGHT NOW. I THINK, AS SOME OF THE COMMISSIONERS NOTED THIS MORNING, I THINK THEY WERE TALKING ABOUT SOMETHING 6 VERY SIMILAR TO WHAT YOU JUST SAID, ABOUT THE COST BENEFIT NOT 7 8 BEING STATIC, BUT A PROJECT MAY HAVE BEEN UNDER -- BIG PROJECTS LIKE THIS HAVE BEEN AROUND DEVELOPMENT FOR MANY, MANY 9 YEARS, IF NOT FOR DECADES, IN WHAT THE COMMISSIONERS THIS 10 MORNING WERE SAYING IS THAT, AT TIMES YOU MAY NEED TO DO A 11 REFRESH AND THAT THE COST BENEFIT SHOULD BE NOT STATIC, BUT BE 12 REFRESHED AT TIMES. WITHIN THE REGION. AND, SO, SPENDING MONEY ON SOMETHING THAT



IS NOT THE CORE MAY HAVE A HIGHER VALUE TO THAT -- TO THAT 1 PART OF THE MINI REGION, SO TO SPEAK.
