THIS IS AN ACTION ITEM. AND MR. HANSEL, WILL 13 14 YOU PLEASE GIVE YOUR REPORT. 15 16 DEREK HANSEL: YES IF WE CAN BRING UP THE SUMMARY SHEET. IF WE CAN MAKE THAT A LITTLE BIGGER, FOLKS. IS THAT POSSIBLE WHILE 17 THEY'RE WORKING ON TRYING TO MAKE IT LEGIBLE -- MY APOLOGIES. 18 THIS BUDGET WILL LOOK VERY SIMILAR TO WHAT YOU HAVE SEEN IN 19 PREVIOUS YEARS. NOT MUCH CHANGE HERE. REVENUE LOOKS GENERALLY 20 21 LIKE IT HAS. I'M JUST GOING TO PULL MINE UP SO I CAN SEE IT 22 HERE. MY APOLOGIES. THAT'S NOT -- THERE WE GO. THANK YOU. 23 KAREN MITCHOFF, CHAIR: GREAT. THANK YOU. THANK YOU. 24



DEREK HANSEL: THANK YOU. AGAIN, REVENUE LOOKS VERY SIMILAR TO 1 WHAT WE HAVE SEEN IN PRIOR YEARS. MAINLY, THE CFD COST 2 RECOVERY FEES, AND ALSO PROJECT MONITORING FEES. THOSE ARE 3 COMING IN FROM CURRENT BORROWERS. THE MAJOR EXPENSES ON THIS, 4 5 AGAIN, CONSULTANT AND PROFESSIONAL FEES, SOME OF WHICH ARE KIND OF RUN RATE TRUE EXPENSES THAT WE HAVE EVERY SINGLE YEAR. 6 OTHERS OF WHICH WE WOULD ONLY HAVE IF WE ACTUALLY HAVE 7 8 BORROWINGS DURING THE YEAR. SO WE DO BUDGET FOR THE IDEA THAT THERE COULD BE SOME BORROWINGS THAT GET TEED UP DURING THE 9 YEAR, SO FOLKS KNOW THAT THE PROGRAM IS GENERALLY IN A RUNOFF 10 MODE AT THE MOMENT. THE AUDIT FEES, THIS REFLECTS THE ALL 11 INTENDED AUDIT FEES FOR FISCAL '23. YOU WILL NOTE THAT THE 12 ACTUAL AUDIT FEES THROUGH FEBRUARY OF '22 ARE SOMEWHAT LOWER 13 THAT'S BECAUSE THERE WAS A SPLIT OF AUDIT FEES FOR THIS PAST 14 15 FISCAL YEAR'S AUDIT BETWEEN FISCAL '21, AND FISCAL '22. SO 16 THAT'S REFLECTED THERE. OTHER THAN THAT, YOU KNOW, IT PRODUCES
