MY NAME 11 IS MALLORY ATKINSON PRESENTING PROPOSED EXPENDITURE PLAN FOR 12 MTC SHARE OF THE STATE'S REGIONAL EARLY ACTION PLANNING GRANT 13 PROGRAM. SLIDES PLEASE? THANK YOU. TODAY WE'RE SEEKING 14 15 APPROVAL OF RESOLUTION THAT WOULD AUTHORIZE MTC TO SUBMIT 16 ALLOCATION REQUEST FOR THESE FUNDS AND ENTER INTO AGREEMENTS WITH THE STATE TO RECEIVE FUNDS. NEXT SLIDE. I'M GOING TO 17 START WITH A FEW SLIDES OFFERING BACKGROUND ON THIS FUNDING 18 PROGRAM AND I'LL TRY TO HIGHLIGHT KEY POINTS SINCE THIS 19 INFORMATION HAS BEEN SHARED BEFORE. FIRST, THIS IS A STATE 20 21 PROGRAM TO INVEST 600 MILLION ACROSS THE STATE TO ADVANCE AND IMPLEMENT SUSTAINABLE COMMUNITY STRATEGIES, INCLUDING PLANNED 22 BAY AREA 2050. MTC IS EXPECTED TO RECEIVE NEARLY 103 MILLION 23 FOR TRANSPORTATION AND HOUSING PROJECTS TO SUPPORT PLANNED BAY 24 25 AREA 2050 AND OUR STRATEGIES FOR CLIMATE, HOUSING, AND EQUITY.

AND IMPORTANTLY THESE FUNDS MUST BE SPENT NO LATER THAN JUNE 1 30TH, 2026, SO IT'S A VERY QUICK MOVING PROGRAM. NEXT SLIDE 2 3 PLEASE. THIS TABLE ON THIS SLIDE HIGHLIGHTS A FEW OF THE KEY CHANGES TO THE REAP PROGRAM WITH THIS BEING THE SECOND FUNDING 4 5 ROUND FOR IT, WITH REAP ONE, THE ASSOCIATION OF BAY AREA GOVERNMENTS, AT ABAG RECEIVED 24 MILLION TO SUPPORT LOCAL 6 JURISDICTIONS. PREDOMINANTLY DEVELOPING AND UPDATING THEIR 7 8 HOUSING ELEMENTS IN COMPLIANCE WITH THE LATEST REGIONAL HOUSING ALLOCATIONS OR RHNA PROCESS. AND FOR REAP TWO, THE 9 FUNDING AMOUNT HAS GROWN SIGNIFICANTLY IN THIS EDITION FUNDS 10 ARE COMING TO MPOS, PLAN BE ORGANIZATIONS OR MTC IN THE BAY 11 AREA AND IN ADDITION THE ELIGIBILITY OF THE FUNDS BROADENED 12 SIGNIFICANTLY. WHILE PLANNING IS STILL ELIGIBLE FOR THESE 13 FUNDS, THE EMPHASIS FOR REAP TWO IS REALLY TO PROVIDE DIRECT 14 15 INVESTMENTS IN BOTH HOUSING AND CAPITAL TRANSPORTATION 16 PROJECTS TO REDUCE VMT AND ADVANCE OTHER STATE GOALS. NEXT SLIDE, PLEASE. SO OUR PROPOSED EXPENDITURE PLAN FOR THESE 17 18 FUNDS MUST HAVE A CLEAR RELATIONSHIP TO THREE STATE OBJECTIVES. FIRST TO ACCELERATE INFILL IN A WAY THAT INCREASES 19 SUPPLY, CHOICE, AND AFFORDABILITY, ALSO TO AFFIRMATIVELY 20 FURTHER FAIR HOUSING, AND REDUCE PER CAPITA VEHICLE MILES 21 TRAVELED. OBJECTIVES FOR THE FUND PROGRAM WHICH I JUST WENT OVER ON THE 1 PREVIOUS SLIDE. ADDITIONALLY A FEW OTHER CONSIDERATIONS STAFF 2 3 TOOK INTO ACCOUNT INTO DEVELOPING A PROPOSAL FOR OUR REGION. FIRST WITH THE PROGRAM ACCELERATED EXPENDITURE LEAD LINES 4 5 PROJECTS MUST BE READY TO GO AND AVAILABLE TO DELIVER ON SHORT TIMELINES. THIS IS ONE TIME FUNDING OPPORTUNITY RATHER THAN 6 7 ONGOING SOURCE WE WANT TO LIMIT THE ADMINISTRATIVE BURDEN ON 8 OUR AGENCY AND SPONSORS USING FUNDS ESSENTIALLY FOCUSING ON LARGER PROJECTS AND FUNDS SHOULD BE USED IN COORDINATION WITH 9 OTHER COMPLEMENTARY FUND SOURCES AND MORE ON THIS POINT WILL 10 BE IN THE NEXT SLIDE, PLEASE. HOPEFULLY THIS IS A FAMILIAR 11 SLIDE TO THIS COMMITTEE. THIS SLIDE SHOWS A TABLE OF ALL OF 12 THESE COMPLEMENTARY FUND SOURCES THAT ARE AVAILABLE TO SUPPORT 13 PLANNED BAY AREA OBJECTIVE THE REAP BEING ONE OF THOSE 14 15 SOURCES, INCLUDING OTHER FUNDS -- SORRY -- INCLUDE THE ONE BAY 16 AREA GRANT, OBAG THREE BLUE RIBBON FUNDING FEDERAL CARB AN REDUCTION PROGRAM COORDINATING FUNDING COMPREHENSIVELY FUNDING 17 APPROACH COMBINED WITH \$600 MILLION ALLOWS EFFECTIVELY TO 18 MATCH DIFFERENT PROJECTS AND PROGRAMS AND PRIORITIES FOR THE 19 REGION WITH APPROPRIATE FUNDS. THE TABLE ON THIS SLIDE SHOWS 20 21 HOW THE NEARLY 103 MILLION AVAILABLE FOR THIS PROGRAM WILL BE 22 DISTRIBUTED BETWEEN THREE FOCUS YEARS, A REGIONAL GROWTH FRAMEWORK IMPLEMENTATION, TRANSIT TRANSFORMATION ACTION PLAN 23 IMPLEMENTATION, COMMUNITY CHOICE PROGRAM IMPLEMENTATION, AND A 24 SMALL AMOUNT FOR PROGRAM ADMINISTRATION AND STAFFING SUPPORT. 25
