Re: BAHFA Regional Expenditure Plan – Labor Standards

Dear Chair Pedroza, Vice Chair Josefowitz, Chair Romero, Vice Chair Fligor, Committee Members, and Director Hartley:

The 37,000 members of the Nor Cal Carpenters Union have a deeply vested interest in Bay Area housing, both as people who need more abundant housing affordable at all income levels and as the union that organizes and bargains for more unionized construction workers building Bay Area affordable housing than any other single construction trades union.

The proposed BAHFA ballot measure would generate \$10 to \$20B—over half of which will be spent on new construction—allocated to cities and counties throughout the Bay Area. However, due to a state statutory loophole that has been in place since 2001, most low-interest loans of public funds for affordable housing projects do not trigger any State prevailing wage requirement. Considering that only a small number of cities and counties (e.g., San Francisco, San Jose) require that projects that benefit from city-disbursed loans shall pay prevailing wages, the inclusion of strong labor standards should be considered a necessity for the bond measure.

If approved by voters in November, this influx of funds would be the largest ever regional investment in affordable housing and, owing to that significance, should be taken as an opportunity to articulate a clear vision and practical plan for raising labor standards for construction workers who build affordable housing in the Bay Area.

The labor standards set forth in recently enacted state laws (AB 2011, SB 423, and SB 4) provide the best path forward for protecting and improving the lives of residential construction workers, and leveling the playing field for law abiding contractors who often must compete against firms whose business model relies on wage theft and exploitation. The combination of prevailing wages, healthcare expenditures, and apprentice employment opportunities for bond-funded projects ensures that benefits are received by all workers involved in the project, without introducing the practical or political challenges that come from a one-size-fits-all Project Labor Agreement requirement.

While we are encouraged by the prospect of BAHFA applying AB 2011/SB 423 labor standards to the 20% of the bond funds that they will maintain and administer, it would be a mistake to not ensure that these same standards also apply to the 80% of proceeds allocated to the cities and counties.

The current version of the State's BAHFA-authorizing law does not permit BAHFA to write labor standards mandate into the ballot measure and would require us to lobby 13 local governments and the BAHFA board (made up of MTC commissioners) to set labor standards for each. The solution is to alter state law to allow BAHFA to require all local jurisdictions that receive bond funds to adhere to baseline labor standards and to then work through the BAHFA board to write labor standards that will create a level playing field (prevailing wage + health care expenditure standards) and will arm us with the labor compliance enforcement tools (right of private action).

*The Nor Cal Carpenters Union strongly advocates for the inclusion of AB 2011 labor standards, which, in BAHFA staff's own words, offer a chance to "raise the bar" for residential construction workers at a regional scale.* These standards are balanced, feasible, and were widely supported by affordable housing developers when SB 4 made its way through the legislature. We will engage with Staff as well as have two-way communications in the immediate future with Commissioners and with other affordable housing stakeholders to ensure that these standards apply not only to the 20% of funds retained and administered by BAHFA, but to any project receiving bond funds. We look forward to this incredible opportunity to advance enforceable labor standards that protect all workers and lift them up & out of being among the millions of Bay Area residents who qualify for—but generally are not able to find—deed-restricted affordable housing.
