### Memorandum

RE: Contract Amendment - StreetSaver® Training and Guidance Services: Nichols Consulting Engineers,

Chtd. (\$250,000)

Staff seeks the Committee's approval to enter into a contract amendment in an amount not to exceed \$250,000 with Nichols Consulting Engineers, Chtd. (NCE), to provide StreetSaver® training and pavement management system (PMS) guidance services through the end of NCE's contract, which expires on December 31, 2015.

#### Background

MTC's pavement management program, StreetSaver<sup>®</sup>, provides local jurisdictions with an analytical tool that guides local recommendations or "best practices" for pavement preservation in order to help them use their limited local street and road funding in the most cost-effective manner. Currently, all 109 Bay Area jurisdictions use StreetSaver<sup>®</sup>, in addition to over 300 users nationwide. MTC uses StreetSaver<sup>®</sup> to report the annual pavement conditions for local streets and roads and to project the region's pavement needs for the Regional Transportation Plan.

In 2009, following a competitive procurement process, MTC retained NCE to provide StreetSaver® training and PMS guidance services. The Committee approved a two-year contract, with the option to extend the contract for two additional two-year periods. Subsequently, MTC has exercised both options and extended the contract term to December 31, 2015.

This amendment will add \$250,000 to the current contract as amended, bringing the contract total to \$1,895,000. With these additional funds, NCE will provide software training and PMS guidance services including development of PMS and roadway asset management concept documents, software testing, and maintenance of existing projection models, calculation engines, and technical support services. Funding for this amendment is included in the approved FY 2015-16 agency budget. Attachment A includes a summary of NCE and its project team's small business and disadvantaged business enterprise status.

#### Recommendation

Staff recommends that this Committee authorize the Executive Director or his designated representative to negotiate and enter into a contract amendment with NCE in an amount not to exceed \$250,000 to provide StreetSaver® training and PMS guidance services as described herein.
