RE: International Travel Request – Doug Johnson to Bilbao, Spain (\$1,652)

This memorandum requests Committee approval to reimburse Doug Johnson for international travel in an amount not to exceed \$1,652.

## Background:

Doug Johnson, Principal Planner, has been invited to participate and present at the Build Bilbao Urban Innovation Symposium. The symposium, which is attended by representatives from the private, public and philanthropic sectors interested in regional issues including transportation, development, and sustainability, will be held in Bilbao, Spain from September 16 to 19. Doug's presentation will focus on the Plan Bay Area's alignment of regional transportation investments and land use in light of emerging trends in income spread and technological change for both transportation and urban development. By attending, Doug will learn about international and domestic approaches to key issues affecting the region which he can apply to his work at MTC.

Doug has been offered a matching \$1,000 scholarship by the German Marshall Fund of the United States which is sponsoring the event. He has been a member of GMF's TransAtlantic Cities Network for the last five years.
