Dear Chair Mackenzie and MTC Commissioners:

We, the undersigned employees of the Metropolitan Transportation Commission are proud to serve the citizens of the nine counties of the San Francisco Bay Area. Day in and day out we work to improve mobility, promote economic opportunity, and maintain the quality of life of our 7.5 million constituents. We are proud to work for a Commission that is forward thinking and supportive of its staff.

We are writing to you today to express our grave concerns about the Contract for Services for the MTC/ABAG Staff Consolidation, as amended by the ABAG Executive Board on April 20, 2017. The ABAG Executive Board's amendment to the Contract for Services for the MTC/ABAG Staff Consolidation which requires that transitioning ABAG employees become a separate bargaining unit within MTC and remain represented by the Service Employees International Union (SEIU) Local 1021 is very troubling to us.

The purpose of this staff consolidation is to unify staff and create an Integrated Regional Planning Department. The ABAG Executive Board's action by definition is divisive and would create a situation where staff sitting side-by-side, performing similar work would be under different bargaining units, with corresponding differences in pay, benefits, titles, promotional opportunities, and relationship with MTC management. The amended Contract for Services for the MTC/ABAG Staff Consolidation in our view would violate MTC Resolution Nos. 743 and 746 (1979) which establish a process for employer-employee relations and recognizes our Committee for Staff Representation as the exclusively recognized employee organization for all non-Confidential/non-management MTC employees.

For nearly four decades it has been the sole responsibility of MTC's employees to determine who represents us. We continue to support our Committee for Staff Representation as the sole representative organization for all employees as a single united bargaining unit unless or until the employees of MTC elect to designate an alternative representative structure.
