WHEREAS, as the CFO's administrative assistant, a position she has held for the last 18 years, Carolyn stepped into the high-flying, high-finance world of the Bay Area Toll Authority,

booking frequent trips back East by Brian and his sidekick Sue Woo to visit bond rating agencies and bankers, and arranging Napa Valley tony golf tournaments and banquets for visiting financiers from the East Coast; and

WHEREAS, Carolyn was uniquely suited for this assignment, bringing an inner island calm instilled by her native Trinidad, and street smarts and a toughness honed during her teenage and young adult years growing up in Brooklyn; and

WHEREAS, at the same time as attentively serving the needs of her various bosses over the years at MTC, Carolyn wore other important hats — that of a single mom who lovingly and fiercely raised her son Jamal, a loving partner to Damon, and a devoted member of her church; and

WHEREAS, as further evidence that Carolyn has full access to both halves of her brain, the analytical/numbers side and the creative side, she has steeped herself in the art of quilting, producing very professional-looking wall hangings and bed covers for the loved ones in her life; and

WHEREAS, while she only worked for two years in the MTC unit that morphed into Legislation and Public Affairs, Carolyn continued to be a beloved honorary member of the LPA team, joining her original coworkers for birthdays and other happy occasions, lured as much by the call of friendship as by the offer of treats; and

WHEREAS, Carolyn is a well-known and popular figure at MTC whose friendships go beyond the sections where she worked, touching every department and corner of the agency; and

WHEREAS, despite a pronounced sweet tooth that was frequently in evidence, Carolyn appears to have a secret formula for remaining svelte, and she always cut a stylish, willowy figure in the halls of the Oakland MetroCenter and then the Bay Area Metro Center in San Francisco; now, therefore, be it

RESOLVED, that the executives and commissioners of MTC thank Carolyn for her nearly three decades of keeping the agency and Brian out of trouble; that her many friends throughout the agency declare that she will be sorely missed and forever remembered for her warmth, her humor, her indomitable spirit and her keen observations delivered in her Trinidadian lilt; and that collectively, we all wish her well-deserved rest and relaxation, and time and space to explore her talents and interests.
