## MTC Resolution No. 4308, Revised

---

**Subject:** Program of Projects for the 2018 Regional Transportation Improvement Program (RTIP), which includes approximately \$290 million in new programming capacity for the Bay Area

**Background:** MTC is responsible for developing the region's funding priorities for the Regional Transportation Improvement Program (RTIP), and for submitting the proposed projects to the California Transportation Commission (CTC) for adoption into the State Transportation Improvement Program (STIP). Resolution No. 4308 establishes MTC's policies, procedures, criteria, schedule, and funding targets for the 2018 RTIP, and includes the program of projects due to the CTC by December 15, 2017. The 2018 STIP includes \$291 million in new programming capacity for the Bay Area and covers the fiscal years 2018-19 through 2022-23.

Each county Congestion Management Agency (CMA) or countywide transportation planning agency is responsible for soliciting projects for its county share of the RTIP. The CMA must notify eligible project sponsors of the process and deadlines for applying for RTIP funding. The CMAs provided MTC with their final project lists on November 8.

### 2018 RTIP Policies and Procedures

At its October 25 meeting, the MTC Commission approved the 2018 RTIP Policies and Procedures (MTC Resolution No. 4308). In summary, the approval action directed staff to do the following:

- Set aside \$46 million of regionally-controlled RTIP funds as an augmentation to the One Bay Area Grant Program Housing Production Incentive challenge (also known as *80k by 2020*).
- Develop supplemental housing condition criteria for stakeholder input and input via special Commission workshop in 2018.
- Survey jurisdictions' compliance with state housing statutes.
- Assess the Priority Development Area (PDA) planning process to identify action steps and constraints for housing production and affordable housing in PDAs.

These actions do not affect any proposed projects submitted for the 2018 RTIP. The revised RTIP Policies are available on MTC's website.

### Program Highlights

A summary of the important program issues is included as Attachment 1. Attachment 2 includes charts summarizing the proposed program by county, project type, and modal investment category. Attachment 3 summarizes changes to previously-programmed RTIP projects, such as a change in funding amount, phase, or year of programming. Some highlights are:

- Seven of the nine Bay Area counties propose new projects for RTIP funding. Marin and Sonoma Counties do not have new programming

capacity since those counties are still paying back prior STIP commitments.

- The 2016 STIP mandated deletion of \$754 million in existing programming statewide, due to the lower-than-anticipated price-based excise tax receipts. In the Bay Area, this translated to \$115million in existing funds deleted from the RTIP. Thanks to Senate Bill 1, five projects deleted in the 2016 RTIP are now requesting full or partial restoration of their RTIP funding amounts.
- The 2018 STIP Fund Estimate identifies funding for Advanced Project Development Element (APDE) shares. Contra Costa and Santa Clara Counties each programmed the full amount of available APDE shares.
- Through previous RTIPs, MTC has committed funding to various projects and programs that are memorialized in the RTIP Policies and Procedures. These commitments are addressed or retired as part of the new funding from the 2018 RTIP.
- The 2018 RTIP includes two major transit projects focused on maintaining aging transit assets in a state of good repair. In Alameda and Contra Costa Counties, BART has \$16.8 million for its Station Modernization Program, and SFMTA has \$13.6 million for the maintenance and rehabilitation of various light rail lines throughout San Francisco.
- Caltrans proposes programming one new project in the Bay Area from its Interregional Transportation Improvement Program target: \$18 million for the final design phase of the US-101 Managed Lanes project in San Mateo County.

### Schedule

MTC's RTIP program of projects is due to the CTC by December 15, 2017. MTC staff will transmit the draft RTIP list after this Committee's review, with the final RTIP submitted to CTC following Commission approval on December 20. CTC staff is aware of this schedule. CTC is scheduled to adopt the STIP in March 2018.

**Attachment 1: MTC’s 2018 Regional Transportation Improvement Program Summary**

**Funding and Significant New Projects**

The 2018 State Transportation Improvement Program (STIP) Fund Estimate identifies roughly \$291 million in new programming capacity for the Bay Area. Seven of the nine Bay Area counties propose new projects for RTIP funding. Marin and Sonoma Counties do not have new programming capacity since those counties are still paying back prior STIP commitments.

Each CMA provided MTC with its final project listing by November 8. The full listing of projects is included in Attachment B to MTC Resolution No. 4308, Revised. Table 1, below, shows proposed new 2018 RTIP projects requesting over \$5 million in RTIP funds.

Attachment 2 to this memo includes two charts that summarize the proposed 2018 RTIP based on mode for each county, and the overall project type summary which includes MTC’s commitment of \$46 million for the *80k by 2020* Housing Incentive Program.

**2016 STIP Programming Deletions**

The 2016 STIP mandated deletion of \$754 million in existing programming statewide, due to the lower-than-anticipated price-based excise tax receipts. In the Bay Area, this translated to \$115.3 million in existing funds deleted from the RTIP. Thanks to Senate Bill 1, much of the eliminated 2016 STIP capacity is restored and available for programming. Five projects deleted in the 2016 RTIP are now requesting full or partial restoration of their RTIP funding amounts:

- Alameda and Contra Costa Counties, BART Station Modernization Program (scope refined to specific station improvements)
- Contra Costa County, I-680/SR4 Interchange Improvements project

- San Mateo County, US 101 Managed Lanes project
- San Mateo County, SR-92/US-101 Interchange Improvements project
- Solano County, Jepson Parkway (Leisure Town from Commerce to Orange) project

Note that not all of the deleted projects in the 2016 RTIP returned to the 2018 RTIP since project sponsors either found alternative fund sources or identified other priorities.

**Advanced Project Development Element (APDE)**

The 2018 STIP Fund Estimate identifies funding for Advanced Project Development Element (APDE) shares. Up to 25% of the each county’s share of the estimated capacity in the next STIP cycle can be programmed for the environmental and permits and the plans, specifications and estimates phases (PS&E). Contra Costa and Santa Clara Counties each programmed the full amount of available APDE shares:

- Contra Costa County, \$6.1 million for PS&E in FY 21-22 for the SR-4 Operational Improvements project
- Santa Clara County, \$10.6 million for PS&E in FY 18-19 for the US-101 Express Lanes - Phase 5 project.

Both projects programmed using APDE share capacity are identified in Attachment B to MTC Resolution 4308. APDE must be listed separately as they are advances of regular future STIP county shares.

**Remaining Commitments**

Through previous RTIPs, MTC has committed funding to various projects and programs that are memorialized in the RTIP Policies and Procedures. All of these commitments are addressed or retired as part of the new funding from the 2018 RTIP. Table 2 below summarizes the remaining commitments and their current status.

## Notes on Table 2:

- \* Per MTC Resolution No. 4267, these funds are first committed as additional contingency to the Caltrain Electrification project. MTC Resolution No. 4308 directs these funds to the *80k by 2020* Housing Production Incentive program if these funds are no longer needed for Caltrain.
- \*\* The 80k by 2020 Program is included outside of the current RTIP funding years.
- \*\*\* Since Central Subway is already under construction, San Francisco will program its commitment to SF MTA to free up locally-controlled funds as payback.
- + MTC proposes to commit \$2 million in SB 1 Local Partnership Program (LPP) formula funds and \$2 million in match for the pre-construction of this project, as part of MTC Resolution No. 4312 in December 2017.

**Transit Program Investments**

The 2018 RTIP includes two major transit projects focused on maintaining aging transit assets in a state of good repair. In Alameda and Contra Costa Counties, BART has \$16.8 million for its Station Modernization Program to improve the stations at 19th Street Oakland and Concord. In San Francisco, SFMTA has \$13.6 million for the maintenance and rehabilitation of various light rail lines throughout San Francisco. Both projects achieve the region's goal of "fix it first" – maintaining the transportation assets we already have in a state of good repair.

The 2018 RTIP also includes major transit expansion projects, including \$13.1 million for AC Transit's Bus Rapid Transit (BRT) project, and \$29.7 million for the BART Extension to Downtown San José/Santa Clara.

**Interregional Transportation Improvement Program**


The 2018 STIP Fund Estimate identifies \$528 million in new programming capacity for Caltrans's Interregional Transportation Improvement Program (ITIP) – which represents 25% of the total STIP. Caltrans proposes programming one new project in the Bay Area from its ITIP target – \$18 million for the final design phase of the US-101 Managed Lanes project in San Mateo County. Caltrans proposes this amount come from its APDE share, and augments that project's funding plan which includes RTIP funding and planned SB 1 competitive program funding.

**Upcoming Actions**


MTC will submit the 2018 RTIP to the California Transportation Commission in December 2017. CTC will hold two hearings on the STIP in early 2018, and will release staff recommendations in late February 2018. CTC is scheduled to adopt the 2018 State Transportation Improvement Program (STIP), of which MTC's RTIP is a part, on March 21, 2018.

**Attachment 3: Summary of Proposed 2018 RTIP Changes to Existing Projects**

Below is a summary of the proposed changes to currently-programmed RTIP projects by county.

**Alameda County**

- Redirect \$12 million from the East West Connector (I-880 to Mission Blvd.) project programmed in FY 20-21, to the I-80 Gilman Interchange Reconstruction and Access Improvements project in the same fiscal year, as allowed under the 2018 STIP Guidelines; and
- Update the project description of the BART Station Modernization Program to the BART 19th Street Oakland Station Improvement Project.

**Contra Costa County**

- Advance the I-680 South Bound HOV Gap Closure (N. Main-Livorna) project from FY 19-20 to FY 18-19, as allowed under the 2018 STIP Guidelines; and
- Program an additional \$5.8 million to the I-80/Central Avenue - Phase 2 (Local Road Realignment) project in Richmond, \$4 million for right-of-way in FY 20-21 and \$1.8 million for construction in FY 21-22; and
- Update the project description of the BART Station Modernization Program to the BART Concord Station Improvement Project.

**Marin County**

- No programming changes requested.

**Napa County**

- Redirect \$1.2 million from the Eucalyptus Drive Extension project programmed in FY 20-21, to the Devlin Road and Vine Trail Extension project in in FY 18-19, as allowed under the 2018 STIP Guidelines; and
- Combine the right-of-way and construction funding for the Petrified Forest Rd and SR-128, Intersection Improvements project into construction, and delay the project by one year to FY 19-20 to accommodate additional environmental studies; and
- Combine engineering and construction funding for the Hopper Creek Pedestrian Path (Oak Cir - Mission) project into construction in FY 19-20.

**San Francisco County**

- No programming changes requested.

**San Mateo County**

- Redirect \$6.9 million from the State Route 1 Calera Parkway project programmed in FY 18-19, to the US 101/Woodside Road Interchange Improvements project in in FY 18-19, as allowed under the 2018 STIP Guidelines.

**Santa Clara County**

- No programming changes requested.

**Solano County**

- Program an additional \$6 million to the Jepson Parkway (Leisure Town from Commerce to Orange) project, and delay the project from FY 18-19 to FY 20-21.

**Sonoma County**

- No programming changes requested.

**Regionwide**

- Redirect \$46 million in regional discretionary RTIP funds to the *80k by 2020* Housing Production Challenge Grant program (if not needed for Caltrain Electrification contingency), and program funds outside of 2018 RTIP period.

WHEREAS, the Metropolitan Transportation Commission (MTC) is the regional transportation planning agency for the San Francisco Bay Area pursuant to Government Code Section 66500 *et seq.*; and

WHEREAS, MTC has adopted and periodically revises, pursuant to Government Code Sections 66508 and 65080, a Regional Transportation Plan (RTP); and

WHEREAS, MTC shares responsibility with the Association of Bay Area Governments (ABAG) for developing and implementing a Sustainable Communities Strategy (SCS) that integrates transportation, land use, and housing to meet greenhouse gas (GHG) reduction goals (Government Code Section 65080(b) 2(B)).

WHEREAS, MTC adopts, pursuant to Government Code Section 65082, a Regional Transportation Improvement Program (RTIP) when additional State Transportation Improvement Program funding is available, that is submitted, pursuant to Government Code Section 14527, to the California Transportation Commission (CTC) and the California Department of Transportation (Caltrans); and

WHEREAS, MTC has developed, in cooperation with Caltrans, operators of publicly owned mass transportation services, congestion management agencies, countywide transportation planning agencies, and local governments, policies, procedures and project selection criteria to be used in the development of the 2018 RTIP, and a five-year program for the funding made available for highways, roadways and state-funded mass transit guideways and other transit capital improvement projects, to include projects programmed in fiscal years 2018-19 through 2022-23; and

WHEREAS, using the process and criteria set forth in the Attachments to this resolution, attached hereto as though set forth at length, a set of capital priorities for the 2018 Regional Transportation Improvement Program (RTIP) was developed; and

WHEREAS, the 2018 RTIP has been developed consistent with the policies and procedures outlined in this resolution, and with the STIP Guidelines adopted by the CTC on August 16, 2017; and

WHEREAS, the 2018 RTIP will be subject to public review and comment; now, therefore, be it

RESOLVED, that MTC approves the process and criteria to be used in the evaluation of candidate projects for inclusion in the 2018 RTIP, as set forth in Attachment A of this resolution, and be it further

RESOLVED, that MTC adopts the 2018 RTIP Program of Projects, attached hereto as Attachment B and incorporated herein as though set forth at length, and finds it consistent with the RTP; and, be it further


RESOLVED, that MTC approves the STIP Amendment / Extension Rules and Procedures to be used in processing STIP amendment and extension requests, as set forth in Attachment C of this resolution, and be it further

RESOLVED, that the Executive Director may make adjustments to Attachment B in consultation with the respective Congestion Management Agency (CMA) or County Transportation Planning Agency, to respond to direction from the California Transportation Commission and/or the California Department of Transportation; and, be it further

RESOLVED, that MTC's adoption of the programs and projects in the 2018 RTIP is for planning purposes only, with each project still subject to MTC's project review and application approval pursuant to MTC Resolution Nos. 3115 and 3757; and, be it further

RESOLVED, that the Executive Director shall forward a copy of this resolution, and such other information as may be required to the CTC, Caltrans, and to such other agencies as may be appropriate.
